The KING's Most Excellent Majesty in Council.

WHEREAS by an Act passed in this present Seffion of Parliament, intituled, " An Act " for further continuing, for a limited Time, an Act " made in the Twenty-third Year of the Reign of " His prefent Majefty, intituled, An Act for pre-" venting certain Inftruments from being required from Ships belonging to the United States of Ame-" rica; and to give to His Majefty, for a limited " Time, certain Powers for the better carrying on " Trade and Commerce between the Subjects of His " Majesty's Dominions and the Inhabitants of the " faid United States; and for further continuing, "for a limited Time, an Act made in the Twentyfourth Year of the Reign of His prefent Majefly, intituled, An Act to extend the Powers of an Act, i. ... "made in the Twenty-third Year of His prefent "Majefty, for giving His Majefty certain Powers "for the better carrying on Trade and Commerce " between the Subjects of His Majesty's Dominions, " and the Inhabitants of the United States of Ame-" rica, to the Trade and Commerce of this Kingdom " with the British Colonies and Plantations in Ame-" rica, with Respect to certain Articles therein men-" tioned," it is enacted, that the faid Acts, and all the Matters and Things therein contained, shall con-tinue and be in Force until the 5th Day of April, 1787 : His Majesty doth thereupon, by and with the Advice of His Privy Council, hereby order and declare, That any Unmanufactured Goods and Merchandizes, the İmportation of which into this King dom is not prohibited by Law, (except Fish, Oil, dom is not prohibited by Law, (except Filh, Oil, Blubber, Whale-Fins and Spermaceti) and any Pitch, Tar, Turpentine, Indico, Mafts, Yards and Bow-fprits, being the Growth or Production of any of the United States of America, may, until further Order, be imported directly from thence into any of the Ports of this Kingdom, either in British-built Ships, owned'by His Majefty's Subjects, and navigated ac-cording to Law, or, until the 1ft Day of January, 1787, in Ships belonging to the Subjects of the

United States of America, or any of them, and whereof the Matter and Three-fourths of the Marinors are Subjects of the faid United State., or any of them; and from and after the faid 11 Day of January, 1787, in Ships built in the Countries belong-ing to the United States of America, or any of them, and owned by the Subjects of the taid United States, or any of them, and whereof the Master and Three-fourths of the Mariners at least, are Subjects of the faid United States, or any of them, and may be entered and landed in any Port of this Kingdom, upon Payment of the fame Duties as the like Sort of Goods or Merchandize are or may be fubject and liable to if imported in British-built Ships, owned by His Majefty's Subjects, and navigated according to Law, from any British Island or Plantation in America, and no other, notwithstanding such Goods or Merchandize, or the Ships in which the fame may be brought, may not be accompanied with the Certifi-cates or other Documents heretofore required by Law. And it is hereby further ordered, that there shall be the fame Drawbacks, Exemptions and Bounties on Merchandizes and Goods exported from Great Britain into the Territories of the faid United States of America, or any of them, as are or may be allowed by Law upon the Exportation of the like Goods or Merchandize to any of the Iflands, Plantations or Colonies belonging to the Crown of Great Britain in America; and that, until further Order, there fhall be allowed and paid the fame Drawbacks on the Exportation of any Sort of Foreign Hemp, or Foreign Iron, exported from Great Britain into any British Colony or Plantation in America, or into the Territories of the United States of America, or any of them, as are or may be allowed by Law upon the Exportation of the like Sort of Hemp or Iron, and under the fame Rules, Regulations, Restrictions, Penalties and Forfeitures, in all Respects, as fuch Drawbacks are allowed and paid, or are fubject and liable to by Law, upon the Exportation of fuch Hemp and Iron into other Foreign Parts.

And His Majesty is hereby further pleased to order, That any Tobacco, being the Growth or Production of any of the Territories of the faid United States of America, may (until further Order) be imported, in Manner before-mentioned, upon Payment of the fame Duties as Tobacco, imported by British Subjects from any British Colony or Plantation, is or may be subject to, but under and subject nevertheless to all and fingular the Regulations of an Act made and passed in the Twenty-fifth Year of the Reign of His prefent Majefty, intituled, "An Act for the better "fecuring the Duties payable on Tobacco." And His Majefty is further pleafed to order,

That any Rice being the Growth or Production of any of the Territories of the United States of America, which shall be imported directly from thence into any of the Ports of this Kingdom, in Manner above-mentioned, may, upon the Importer pay-ing down in ready Money the Duty commonly called the Old Subfidy (except as hereinafter excepted) be warehoused under His Majesty's Locks, in such Warehouses as shall be approved of for that Purpose by the Commissioners of His Majesty's Customs, or any Four or more of them, upon the Importer's own Bond for Payment of all further Duties due for fuch Rice, within Eighteen Months, according to the net Weight and Quantity of fuch Rice at the Time it shall be fo landed : But it is His Majesty's Pleasure, nevertheless, that upon the Importation of any fuc h Rice into the Ports of London, Briftol, Portfmouth, Cowes, Liverpool, Lancaster, Falmouth, Poole, White-haven, Hull, Greenock and Port Glasgow, or either of them, in the Manner herein before expressed, the Importer shall be at Liberty, (until further Order) to enter into Bond for the Payment, as well of the faid Duty commonly called the Old Subsidy, as of all the further Duties due for fuch Rice, but without any Allowance for prompt Payment of the shall Duty commonly called the Old Subsidy, or any other of the Duties which were formerly payable in ready Money; and that if any Rice, which shall be so imported from the Territories of the faid United States, shall be taken within the Time herein before mentioned out of the Warchouses wherein the fame shall be fecured under His Majess' Locks, in Manner herein before directed, at any of the Ports of this Kingdom, or at either of the Ports above-mentioned respectively, as the Cafe may be, to be ex ported directly from thence, the Bonds which shall be entered into for Payment of the faid Duties shall be difcharged, in like Manner as Bonds entered into for the Duties upon Tobacco are directed to be difcharged by any Act of Parliament in Force.

And for the Purpole of regulating the Trade and Commerce between the People and Territories belonging to the Crown of Great Britain, in the Weft-Indies, in which Defcription the Bahama Islands and the Bermuda or Somers Iflands are included, and the People and Territories belonging to the faid United the People and Territories belonging to the laid United States of America, His Majefty is hereby further pleafed to order, that no Goods or Commodities whatfoever, except Pitch, Tar, Turpentine, Hemp and Flax, Mafts, Yards and Bow/prits, Staves, Heading Boards, Timber, Shingles, and all other Species of Lumber; Horfes, Neat Cattle, Sheep, Hogs, Poultry, and all other Species of Live Stock and Live Provisions Pears Pears Pettoes Wheat and Live Provisions, Peas, Beans, Potatoes, Wheat, Flour, Bread, Bifcuit, Rice, Oats, Barley, and all other Species of Grain, being the Growth or Production of any of the faid United States of America; and also Tobacco in the fair and lawful Way of Barter and Traffic, between the People of the faid United States and the People of His Majefly's Weft India Iflands, as permitted by the before-recited Act paffed in the Twenty-fifth Year of the Reign of His prefent Majesty, may be imported from any of the faid United States of America into any of His Majesty's faid Weft-India Iflands, and that the above Goods may, until further Order, be imported by British Subjects only, and in no other than British-built Ships, owned by His Majesty's Subjects, and navigated according to Law; and that Rum, Sugar, Melaffes, Coffee, Cocoa-Nuts, Ginger and Pimento may, (until further Order) be exported by British Subjects, in British-built Ships, owned by His Majesty's Subjects, and navigated according to Law, from any of the faid Iflands to any Port or Place within the faid United States, upon Payment of the fame Duties on Exportation, and subject to the like Rules, Regulations, Securities and Reftrictions, as the fame Articles by Law are or may be fubject and liable to, if exported to any British Colony or Plantation in Ame-rica; and the Bonds and Securities heretofore required to be taken for fuch Ships carrying fuch Goods shall and may be cancelled and difcharged, upon the like Certificates as are required by the faid recited Act made in the Twenty-third Year of His prefent Majesty's Reign, to discharge any Bonds given in Great Britain for the due landing any other Goods in the faid United States of America.

And His Majesty is hereby further pleased to order, that no Goods or Commodities, being the Growth or Manufacture of the faid United States, shall be imported into the Provinces of Nova Scotia or New Brunfwick, or their refpective Dependencies, except Horfes, Neat Cattie, Sneep, Hogs, Poultry, and all other Species of Live Stock and Live Provifions; Peas, Beans, Potatoes, Wheat, Flour, Bread, Bifcuit, Rice, Oats, Barley, and all other Species of Grain; alfo Lumber of every Sort; and that the above Articles thall be imported by Britifh Subjects only, and in none other than Britifh-built Ships, owned by His Majefty's Subjects, and navigated according to Law, and during fuch limitted Times only as the Governors or Commanders in Chief, for the Time being, of the faid Provinces, and their refpective Dependencies, thall, with the Advice of their refpective Councils, by Proclamation declare the Importation of any of the faid Articles to be neceflary for the Supply of the Inhabitants of the faid Provinces. And His Majefty is hereby further pleafed to order, that no Goods or Commodities of the Growth or Manafacture of the faid United States thall be imported into any of the Ports of the Province of Quebec.

And the Right Honorable the Lords Commissioners of His Majesty's Treasury, and the Lords Commisfioners of the Admiralty, are to give the necessary Directions herein, as to them may respectively appertain. Steph. Cattrelle
