HEREAS it has been humbly represented to the Kings, That on Friday Evening the 10th of this Instant March, a Fire broke out, between the Hours of Eight and Nine o'Clock, at a Farm, in the Parish of Bong Otton in the County of Huntingdon, in the Occupation of Thomas Shuman, by which a Barn, containing about Forty Quarters of Beans, together with Two Hovels adjoining, and containing about Sixty Quarters of Barley and Twenty Quarters of Beans were totally burnt down and consumed, and also Seven Hogswhith overe in the Farm-Kard: And whereas there are strong Reasons to suspect that the same were wilfully and maliciously set on Fire by some Person or Persons unknown; His Majesty, for the better discovering and bringing to Justice the Persons concerned in this atrocious Offence, it hereby pleased to promise His most gracious Pardon to any one of the Offenders (except the Person who actually set Fire to the said Barn and Howels) who shall discover his Accomplice or Accomplices therein, so that he or they may be apprehended and convoicted of the said Offence.
