The KING's Most Excellent Majesty in Council. THEREAS it hath been represented to His Majesty at this Board, that the Place appointed by His Majesty's Order in Council of the 8th of July, 1772, for Performance of Quarantine by Ships or Vessels bound to the Ports of Plymouth, Exeter, and Poole, (except such as are bound to the Ports of Padstow or St. Ive's, being Members of the faid Port of Plymouth, or to Ilfracombe or Barn-flaple, being Members of the Port of Exeter) is become very inconvenient, by reason of the Number of His Majesty's Ships in Ordinary now lying in the Harbour of Hamoaze: His Majesty, with the Advice of His Privy Council, doth hereby order, that all fuch Ships or Vessels which are or shall be bound to the Ports of Plymouth, Exeter, and Poole, or any of the Members or Creeks or other Places within the faid Ports of Plymouth, Exeter, and Poole, (except fuch Parts thereof as have been herein before mentioned) shall, in like Manner as all Ships and Veffels, which are or may be bound to the Port of Falmouth, perform their Quarantine at a Place called St. Ive's Pool, within the Mouth of the Harbour of Falmouth; and that all Goods imported on Board fuch Ships shall be aired at the said Place called St. Ive's Pool, within the Mouth of the Harbour of Falmouth.-And the Right Honorable the Lords
