Whiteball, July 14. Convention for carrying into Effect the Removal of the English Settlers on the Spanish Continent in America, to the Dittrict described in the Sixth Article of the late Definitive Treaty between His Majesty and the King of Spain; for a further Extension of the Limits of that Diffrict; and for additional Privileges to be allowed to the British Subjects there, was figned this Day, by the Marquis of Carmarthen, His Majefty's Principal Secretary of State for Foreign Affairs, on the one Part, and by the Chevalier Don Bernardo del Campo, Minister Plenipotentiary from His Catholick Majesty, on the other.

Whiteball, July 18. The King has been pleafed to grant to the Reverend Thomas Shaw, of Woodhoufe, in the Parish of Wombourn in the County of Stafford, Clerk, and his Iffue, His Royal Licence and Authority to take and use the Surname and Arms of Hellier, pursuant to the last Will of Sir Samuel Hellier, late of Woodhouse aforesaid, Knt. deceased, such Arms being first duly exemplified according to the Laws of Arms, and recorded in the Heralds Office; and alfo to order that this His Majesty's Concession and Declaration be registered in His College of Arms.

Vienna, July 5. The Emperor embarked on the 28th of June at the Port of Zeng, and proceeded by Sea to the Southern-most Point of his Territory in Dalmatia, where his Imperial Majefly landed, and purfued His Journey on Horfeback along the Croatian Frontiers.
