Copenhagen, July 11:

The 7th of this Month an Ordinance was published allowing the Importation of Grain into Aggershus and Christiansand, in national or foreign Vessels, on paying Fifteen Shillings (about Seven Pence Sterling) per Ton. Scotch Meal may also be imported into the District of Christiansand. These Regulations have been adopted, and will subsist till July 1787, on Account of the Appearance of bad Crops this Season in Denmark and Norway.
