An Express has arrived at Carthagena from Algiers, with an Account of the Plague having broken out at Constantia with such Violence as to spread the Alarm over all that Part of the Coast. The Number of Deaths was said to be from Fifty to Eighty in a Day, and the Consuls and other Foreigners at Algiers had shut up their Houses, and renounced all Com-munication with the Rest of the Inhabitants.
