HERE will not be a Levee at St. James's Tomorrow, on Account of His Majesty's Indifpolition.

The last Accounts from Windsor, dated at Ten o'Clock this Morning, were that His Majesty had passed the Night quietly, but that there was no Abatement in his Complaint.

London, November is.

On Saturday last William Gill, Esq; the Lord Mayor Elect for the Year enfuing, was fworn at Guildhall, when the Chair and other Enfigns of Mayoralty were furrendered to him in the accustomed Manner.

Yesterday the new Lord Mayor, accompanied by the late Lord Mayor, many of the Aldermen, and Sheriffs, in their Scarlet Gowns, went in their Ccaches to the Water-fide, the Sword and Mace being carried before them, and the City Officers attending; and from thence proceeded in the City Barge, attended by several of the Companies in their respective Barges, adorned with Streamers and Pendants, to Westminster; and having walked round the Hall, and solemnly saluted all the Courts, they went to the Exchequer Bar, and the Lord Mayor did there take the Oaths appointed; and, having recorded Warrants of Attorney in the proper Courts, returned by Water to Black Fryars, and from thence in Coaches, with the usual Solemnity, to Guildhall, where a magnificent Entertainment was provided; at which were present several of the Foreign Mini-sters and other Persons of Quality and Distinction.

On his Excellency's Return to the Castle the Great Guns at the Salute Battery in His Majesty's Park the Phoenix were fired Three Rounds, and answered by Vollies from the Regiments in Garrison, which were drawn up in College Green; and at Night there were Bonfires, Illuminations, and other Demonstrations of Joy.

Gothenburgh, October 25,

An Express arrived Yesterday from the Court of Copenhagen, with Orders for the Prince of Hesse to retire with all his Troops out of the Swedish Territories.

Vienna, October 29.

An Action took Place, on the 20th or 21st Instant, between a Division of the Emperor's Army, on its March from Sakolo to Opova, and a confiderable Body of Turks: The Latter, after having cut to Pieces a Battalion of Austrian Chasseurs, amounting to 350 Men, were at length compelled to retire. They however carried off in their Retreat all the Pontons, and also the Draught Horses which were attached to that Division. The Emperor's Head Quarters were on the 23d at Jakuba, about nine English Miles from Panscova. Marshal Laudohn is still engaged in the Siege of Gradisca.
