IS Majesty has had a quiet Night, and continues in all Respects as he was Yesterday.

His Majesty passed the Day Yesterday in a quiet Manner, has had Five Hours of undisturbed Sleep; but is unquiet this Morning.

· Vienna, November 29.

Intelligence has been received here, that an Armistice was figned on the 21st or 22d Instant by General Count Kinsky, on the Part of his Imperial Majesty, and by the Pacha of Romalia; by which it is agreed that neither Party shall renew Hostilities, in any Quarter, without giving Ten Days previous Notice to the other.

The Severity of the Season, both in the Bannat and Croatia, will entirely prevent any military Operations of Importance, in either of those Countries, till the Return of Spring.

Marshal Pellegrini arrived here on Saturday, and

Marshal Lascy on Monday last.

The Emperor was expected Yesterday at Buda. Previous to his Imperial Majesty's Departure from Semlin, he held a Chapter of the military Order of Maria-Therefa, in which Eight Officers of different Ranks were elected Knights of that Order.

Madrid, November 29:

His Royal Highness the Infant Don Gabriel, his Catholic Majesty's Third Son, died of the Small Pox, on the 23d Instant, in the Thirty-seventh Year of his Age. This unfortunate Event is a severe Stroke of Affliction to the King and Royal Family, as well as to the Nation in general.
