Letters Patent have been passed under the Great Seal of this Kingdom, constituting and appointing the Right Honorable William Brabazon Ponsonby, and the Right Honorable Charles Lord Lostus, to be His Majesty's Postmaster-General of Ireland.

Dresden, December 20.

A confiderable Number of Military Promotions took Place here last Week. General Benckendorf

is appointed Commander in Chief of the Horse Guards, and Count de Bellegarde succeeds him as Inspector of Cavalry. Six Colonels are advanced to the Rank of Major General, and Two Major Generals are made Lieutenant Generals.

#### Madrid, December 29.

Prince de Masserano, Captain of the Life Guards, was, on his Return from the Funeral of the late King, promoted to the Rank of Marechal de Camp.

His Catholick Majesty has issued Two Decrees, by one of which it is declared, that all Debts contracted by the late King are to be confidered as Debts of the Crown, and discharged as speedily as the Urgencies of Government, the State of the Revenues, and the Quality of the Debts will allow; and by the second, his Majesty extends his Beneficence to the Debts of his Royal Predecessors Ferdinand VI. and Philip V. under certain Modifications and Redrictions.
