WE, taking into Our most ferious Confideration the indispensible Duty which We owe to Almighty God; for the manifold and inestimable Bleffings which We have received at His Hands; and defiring to manifest to Our faithful and loving Subjects, and to the World, the deep and devout Senfe which We entertain of His late Mercies vonchlafed unto Us, by prostrating Ourselves before His Divine Majesty, and offering up, in the most public and folemn Manner, Our Praises and Thanksgivings for that fignal Interpolition of His good Providence, which hath removed from Us the late Illnefs with which We have been afflicted, and which hath eftablished and confirmed in Us the furest Trust and Confidence in His Protection, have thought fit, by the Advice of Our Privy Council, to iffue this Our Royal Proclamation, hereby appointing and commanding that a General Thanksgiving to Al-mighty God, for these His Mercies, be observed throughout England, Wales and the Town of Berwick upon Tweed, on Thursday the Twenty-third Day of this Inftant April; and for the better and more orderly folemnizing the fame, We have given Directions to the Moft Reverend the Archbithops and Right Reverend the Bifhops of England to compose a Form of Prayer fuitable to the Occasion, to be used in all Churches and Chapels, and other Places of Public Worship, and to take Care for the timely Difperfing of the fame throughout their re-fpective Diocefes. And We do frictly charge and command that the faid Public Day of Thankigiving be religiously observed by all Our loving Subjects, as they tender the Favour of Almighty God, and upon Pain of fuffering fuch Punifhment as We can justly inflict upon all fuch who shall contemn or neglect the fame.

WE, taking into Our most ferious Confideration the indispensible Duty which We owe to Al-mighty God, for the manifold and inestimable Blef-sings which We have received at His Hands, and defiring to manifest to Our faithful and loving Sub-

jects and to the World, the deep and devout Senfe which We entertain of His late Mercies vouch/afed which we entertain of ris late interfes voucnairea into Us, by profirating Ourfelves before His Divine Majefty, and offering up, in the moft public and fo-lemn Manner, Our Praifes and Thankfgivings for that fignal Interpolition of His good Providence, which hath removed from Us the late Illnefs with which We have been afflicted, and which hath established and confirmed in Us the surest Trust and Confidence in His Protection, have thought fit, by the Advice of Our Privy Council, to iffue this Our Royal Proclamation, hereby appointing and commanding that a General Thankfgiving to Almighty God, for thefe His Mercies, be obferved throughout that Part of Our Kingdom of Great Britain called Scotland, upon Thursday the Twenty-third Day of this Instant April, and We do strictly charge and command that the faid Public Thanksgiving be reverently and decently obferved by all Our loving Subjects in Scotland, on the faid Twenty-third Day of this Instant April, as they tender the Favour of Almighty God, and would avoid His Wrath and Indignation, and upon Pain of fuch Punifhment as We may juilly inflict on all fuch as contemn or neglect the Performance of fo religious a Duty. Our Will and Pleafure is, therefore and We charge that this Our Proclamation feen, ye forthwith pafs to the Market Crofs of Edinburgh, and all other Places needful, and there in Our Name and Authority make Publication thereof, that none pretend Ignorance. And Our Will and Pleafure is, that Our Solicitor do cause printed Copies hereof to be sent to the Sheriffs of the feveral Shires, Stewards of Stewarties, and Bailiffs of Regalities, and their Clerks, whom We ordain to fee the fame published, and We appoint them to fend Copies thereof to the feveral Parish Churches within their Bounds, that mon the Lord's Churches within their Bounds, that upon the Lord's Day, immediately preceding the Day above men-tioned, the fame may be publifhed and read from the Pulpits immediately after Divine Service.

PROCLAMATION A

For jupprefling Riots and Tumults committed by Colliers and others in the Counties of Northum-berland and Durham, and for apprehending and bringing to Justice the Perfons who have com-minted or shall commit the fame.

GEORGE R. HEREAS it has been reprefented to Us, that a great Number of Street that a great Number of Pitmen, to the Number of Two Hundred and upwards, did in a tumultuous,

multuous, diforderly and riotous Manner, affemble themfelves, upon the Tenth Day of March lale, at Long Benton Colliery, in the County of Northum-berland, and there wilfully and maliciously damaged and deftroyed leveral Engines erected for drawing Coals out of feveral of the Pits of the faid Colliery, and did also wilfully and maliciously fet on Fire one Pit belonging to the faid Colliery, and the fame continued on Fire for two whole Days, to the great Damage of the Proprietors thereof; and alfo that on the faid Tenth Day of March a Number of Pitmen, to the Number of Two Hundred and upwards, affembled themfelves in like Manner at a certain Pit called the Robert Pit, belonging to Shire Moore Colliery, in the County aforefaid, and there wilfully and malicioufly deftroyed and damaged various Implements, Materials and Engines belonging to the fame : And allo, that on the faid tenth Day of March, a number of Pitmen to the Number of One Hundred and upwards, did in like Manner affemble themselves at Walls-End Colliery in the County aforefaid, and wilfully and maliciously did confiderable Damage to the Gins and Machines belonging to the faid Colliery : And alfo that on the faid tenth Day of March, a Number of Pitmen, to the Number of One Hundred and upwards, in like Manner affembled, wilfullyand malicioully broke and damaged the Engine for drawing Coals at the Engine Pit of East Benton Colliery in the County aforefaid : Whereas it has also been represented unto Us, that a Number of Persons to the Number of One Hundred and upwards, affembled themselves together upon the faid tenth Day of March laft, at a Colliery called Walker Colliery, fituate in the faid County, and by Force and Vio-lence prevented the working of a certain Coal Pit belonging to the faid Colliery, and broke and damaged a certain Engine or Engines belonging to the fame, and violently affaulted fome of the Workmen of the faid Colliery, and threw down Heap Lamps into the faid Pit with Fire in them : And whereas it has also been represented to Us, that upon the Eleventh or Twelfth Days of the faid Month of March divers Persons assembled themfelves together in a like riotous, tumultuous and illegal Manner at Gosforth Pit, belonging to the faid Colliery, and threw Lamps and other Ma-terials down the fame : And whereas it has alfo been represented to Us, that on the feveral Days aforefaid, divers Perfons being riotoufly, tumul-tuoufly and illegally affembled, did various other Outrages and Milchiefs to feveral of the Coal Mines in the faid Counties of Northumberland and Durham, in open Defiance of Justice and the Laws, by which the Peace of the faid County, and the Lives and Properties of Our good Subjects are greatly endangered; We, therefore, being deeply fenfible of the many milchievous Confequences that must inevitably enfue to the Peace of Our Kingdom, and the Lives and Properties of Our loving Subjects from fuch wicked and illegal Practices, if they shall go unpunished ; and being firmly refolved to caufe the Laws of this Our Kingdom to be put in Execution for the Punifh-ment of all fuch Offenders, have thought fit, by the Advice of Our Privy Council, to iffue this Our Royal Proclamation, hereby strictly commanding and requiring all Our Justices of the Peace, Sheriffs, Under Sheriffs, and all other Our Civil Officers whatfoever, that they do use their uunoft Endeavours for difcovering and apprehending the Perfons who We are informed are concerned in the faid Outrages and Riots, and who thall be concerned in any fuch riotous and dangerous Practices, to the End they may be brought to Juffice. And We do hereby promife and declare, that if any Perfon or Perfons concerned in the faid Outrages and Felonics, or in any of the faid Crimes, shall, on or before the Third Day of June next,

difcover and apprehends or caufe to be difcovered and apprehended, any other Perfon or Perfons who hath or have or shall have been concerned in any of the faid Offences, that have or shall have been committed on or fince the faid Tenth Day of March last, so as he or they may be convicted thereof, such Discoverer or Discoverers thereof fhall have Our most Gracious Pardon. And as a further Encouragement to such as shall discover the faid Offenders, We do hereby further promife and declare, that any Perfon or Perfons who shall, on before the faid Third Day of June next. difcover and apprehend, or cause to be discovered and apprehended, any of the Perfons concerned in the faid Outrages and Riots, fo as he or they may be convicted thereof, shall have and receive for every Perion fo difcovered, apprehended and convicted, the Sum of FIFTY POUNDS, which faid Sum the Commissioners of Our Treasury, or Our Lord High Treasurer for the Time being, are hereby directed and required to pay accordingly, without any further Warrant in that Behalf. And We do hereby further firicily charge and command all Our Judices of the Peace, Sheriffs, Under Sheriffs, and other Officers alorefaid, that they do use the most effectual Means for suppressing all Riots and Tumults, and to that End effectually put in Execution an Act of Parliament made in the First Year of the Reign of Our late Royal Anceflor, King George the First, of glorious Memory, intituled, " An Act for preventing Tumults and riotous Affemblies, and for the more fpeedy and effectual punishing the Rioters," and all other Laws and Statutes made against Riots, Routs, and unlawful Assemblies; and that the faid Justices, and all other Our Civil Officers to whom it doth appertain, do give the necessary Directions that fufficient Watch and Ward be duly kept at fuch Times and Places as they shall judge neceffary for the preventing and suppressing the like Diforders. And We do hereby further frictly charge and command all Our Officers, Civil and Military, and all other Our loving Subjects, that they be aiding and affifting in the Execution of Our Commands herein, and in the apprehending and taking the faid Per-fons and all other Perfons who have offended. or shall hereafter offend in Manner aforefaid. And We do hereby charge and command, that the faid Offenders be profecuted with the utmost Severity and Rigour of the Law, We being refolved to fupprefs fuch Riots and Tumults by a most strict and exemplary Punishment of all such Offenders. And We do hereby command the refpective Justices of the Peace and other Magistrates aforefaid, that they do from Time to Time transmit an exact Account of what they shall do purfuant to this Our Royal Proclamation, to one of Our Principal Secretaries of State.
