Vienna, September 9.

The Emperor, who removed to Hetzendorff on Thursday last, begins already to benefit from the Change of Air, and his Imperial Majesty is now in a better State of Health than he has been in, at any Time, for the last Five Months.

An Account was published here on Sunday Evening last, by which it appears that, on the 28th ult. the Turks were again defeated by the Corps under General Clairfait, and obliged to take Refuge in the Fortrefs of Orsova.

The March of the Grand Army from Weiskirchen for Syrmia began on the 30th ult. in Three Columns, by different Routes, which are to rendezvous in the Vicinity of Opoza, and to be afterwards joined by the Croatian Army, which has hitherto been encamped at Ruma. The whole Force intended for the Attack of Belgrade is computed at upwards of Seventy Thousand Men.
