Whitehall, September 8. AS several Artificers and Manufacturers, Subjects of Great Britain, bave from Time to Time gone into Foreign Countries to exercise their several Callings, into Pareign Countries to exercise their several Callings, contrary to the Laws of these Kingdoms; the following Abstracts of Asis of Parliamen of their late Majestics, King George the First and Second, and of His present Majesty, for proventing such Practices, are published for the Information of all Persons who may be ignorant of the Penalties they may incur by Disobedience to them.—And it will be observed, that such Penalties likewise extend to those who are any ways concerned or instrumental in the Sending or Enticing Artificers or Manufacturers out of these Kingdoms, or in the Exportation of the Tools and Instruments used by them, as well as to the Artificers or Manufacturers themselves.

Statute 5 George I. Chap. 27.

WF any Person shall contract with, entice, or solicit,
A any Artificer in Wool, Iron, Steel, Brass, or
other Metal, Clock-maker, Watch-maker, or any other Artificer of Great Britain, to go into Foreign Countries, out of the King's Dominions, and shall be convicted thereof upon Indictment or Information, in any of the Courts at Westminster, or at the Affizes or Quarter-Seffions, he shall be fined any Sum not exceeding ONE HUNDRED POUNDS for the first Offence, and shall be imprisoned Three Months, and till the Fine be paid. And if any Perfon having been once convicted, shall offend again, he shall be fined at the Discretion of the Court, and imprisoned Twelve Months, and till the Fine be paid.

If any of the King's Subjects, being such Arti-That Almighty God may long preserve the Life ficers, shall go into any Country out of His Ma-and Happiness of our King, who is the Patron of jesty's Dominions, to exercise or teach the said

Trades to Foreigners; and if any of the King's; Subjects in any such Foreign Country, exercising any of the said Trades, shall not return into this Realm within Six Months after Warning given by the Ambassador, Minister or Consul of Great Britain, in the Country where such Artificers shall be, or by any Person authorised by such Ambassador, &c. or by one of the Secretaries of State, and from henceforth inhabit within this Realm; fuch Persons shall be incapable of taking any Legacy, or of being an Executor or Administrator, or of taking any Lands, &c. within this Kingdom, by Descent, Devise or Purchase; and shall forfeit all Lands, Goods, &c. within this Kingdom, to His Majesty's Use, and shall be deemed Alien, and out of His

Majesty's Protection.

Upon Complaint made upon Oath before any Justice of Peace that any Person is endeavouring to seduce any such Artisicer, or that any such Artificer hath contracted, or is preparing to go out of His Majelly's Dominions, for the Purpofes aforefaid; such Justice may send his Warrant to bring the Person complained of before him, or before fome other Justice; and if it shall appear by the Oath of one Witness, or by Confession, that he was guilty of any of the said Offences, such Justice may bind thim to appear at the next Affizes or Quarter Seffions: And if such Person shall refuse to give Security, the Lustice may commit him to Goal till the next Assizes or Quarter Sessions, and until he shall be delivered by due Course of Law. And if any fuch Artificer shall be convicted upon Indictment of any fuch Promife, Contract, or Preparation to go beyond the Seas for the Purpole aforesaid, he shall give such Security to the King, not to depart out of His Majesty's Dominions, as such Court shall think reasonable, and shall be imprisoned till Security given.

If any of the above Offences shall be committed in Scotland, the same shall be prosecuted in the

Court of Justiciary, or the Circuits there.

Statute 23 George II. Chap. 13. F any Person shall contract with, or endeavour to seduce any Artificer in Wool, Mohair, Cotton or Silk, or in Iron, Steel, Brass, or other Metal, or any Clock-maker, Watch-maker, or any other Artificer in any other of the Manufactures of Great Britain or Ireland, to go out of this Kingdom or Ireland, into any Roreign Country, not within the Dominions of the Crown of Great Britain, and shall be convicted upon Indictment or Information in the King's Bench at Westminster, or by Indistment at the Assizes or General Gaol Delivery for the County, &c. wherein such Ossence shall be committed in England, or by Indictment in the Court of Justiciary, or any of the Circuit Courts in Scotland, or by Indicament or Information in the King's Bench at Dublin, if such Offence be committed in Ireland; the Person so convicted shall, for every Artificer contracted with, or seduced, forseit FIVE HUNDRED POUNDS, and shall suffer Impri-sonment in the Common Goal of the County or Stewartry wherein such Offender shall be convicted. for Twelve Calendar Months, and until Foreiture be paid: And in Case of a subsequent Offence of the fame Kind, the Persons so again offending shall forfeit, for every Person contracted with or or Implements, or any Models or Flans thereof;

feduced, ONE THOUSAND POUNDS, and shall suffer Imprisonment in the Common Gaol of the County or Stewartry wherein fuch Offender shall be convicted, for Two Years, and until such

Forfeiture be paid

If any Person in Great Britain or Ireland shall put on Board any Ship or Boat not bound directly to some Port in Great Britain or Ireland, or to some other of the Dominions of the Crown of Great Britain, any such Tools or Utenfils as are commonly used in. or proper for the Preparing, Working up or Finishing of the Woollen or Silk Manufactures or any Part of such Tools, he shall for every Offence forfeit all such Tools, or Parts thereof, put on Board, and TWO HUNDRED POUNDS, to be recovered by Action of Debt, &c. in any Court of Record at Westminster, or in the Court of Session in Scotland, or at any of the Four Courts in Dublin respectively, wherein no Essoin, &c. shall be allowed.

It shall be lawful for any Officer of the Customs in Great Britain, or for any Officer of the Revenue in Ireland, to seize and secure, in some of His Majesty's Warehouses, all such Tools or Utensils prohibited to be exported, as fuch Officer shall find on Board any Vessel not bound cirectly to some Port in Great Britain or Ireland, or to some other of the Dominions of the Crown of Great Britain; and all Tools fo seized shall, after Condemnation, be publickly fold to the best Bidder; and one Moiety of the Produce shall be to the Use of His Majesty, and the other Moiety to the Officer who shall seize and fecure the same.

If the Captain of any Vessel in Great Britain or Ireland knowingly permit any of the faid Tools, prohibited to be exported, to be put on Board his Vessel, he shall for every such Offence forfeit ONE HUNDRED POUNDS, to be recovered as the Penalties inflicted upon Persons exporting the Tools; and if the Vessel belongs to His Majesty, the Captain shall not only forfeir ONE HUN-DRED POUNDS, but thall also forfeit his Employment, and be incapable of any Employment

under His Majetty.

If any Officer of the Customs in Great Britain, or of the Revenue in Ireland, take, or knowingly fuffer to be taken, any Entry outward, or fign any Cocket or Sufferance for the Shipping or Exporting of any of the said Tools, or knowingly affer the same to be done, he shall forseit ONE HUNDRED FOUNDS, to be ecovered as aforesaid, and also forseit his Office, and be incapable of any Office under His Majesty.

One Moiety of the Forfeitures shall be applied to the Use of His Majesty, and the other Moiety to the Use of the Person who shall sue for the

Statutes 14, 21, 25 and 26 of His present Majesty.

Y these Statutes the like Penalties and For-feitures as above mentioned are extended to Persons packing or putting on board any Vessel, not bound directly for some Port in Great Britain or Ireland, any Machine, Engine, Tool, Press, Paper, Utenfil or Implement whatfoever used in, or proper for the working or finishing of the Cotton, Linen, Steel or Iron Manufactures of this Kingdom, or any Part or Parts of fuch Machines

and all Captains of Ships and other Persons receiving or being in Possession of any such Articles, with an Intent to export the fame to Foreign Parts, and all Custom-house Officers suffering an Entry to be made thereof, are respectively liable to the like Penulties as are above mentioned, in the Case of Tools and Utensils used in the Woollen and Silk Manufactures.

St. Petersburgh, September 4.

Advices were received here Yesterday from the Commander in Chief of the Army in Finland, that the Swedes had repassed the Kymen, and had entirely evacuated the Russian Territory.

Stockholm, September 8.

Accounts were received here this Morning, that the King of Sweden had quitted the Neighbourhood of Hogfors, and fallen back to the Frontiers of his own Dominions The Russians attempted to cut off the Swedish Garrison in their Retreat; in which they would probably have succeeded, had it not been for the spirited Efforts of a Battalion of the West-Gotha-Dal Regiment, who prevented the Landing of the Enemy's Troops that had been embarked in Thirteen Gallies, with a View to effect a Descent at some Distance from that Fortrels.

A Report having been spread that the Russians had formed the Project of sending a Part of their Coasting Fleet, with Troops, to attempt a Landing near this Capital, Orders have been issued for arming and disciplining the City Militia; and every necessary Precaution is taken for the Defence of the neighbouring Coasts.

Berlin, September 15.

The Difference between the Russian and Swedish Accounts received here of the Action between the two Coasting Fleets, on the 24th ult. is so great as to make it extremely difficult to form a just Idea of the Refult, or of the Consequences which may ensue; but upon the Whole it is believed that the Swedish Galleys, which made good their Retreat, are not rendered unfit for Service; and that they are sufficiently numerous to prevent the Russians from having a decided Superiority. This Opinion is confirmed by the Certainty of the King of Sweden's having received a confiderable Reinforcement of Troops and Stores, which make his Force by Land function to that of Russia, and may enable him to support himself during the sew remaining Weeks that this Campaign can last.
