The Subscriptions are so badly imitated, that the Imposition is observable on a very slight In-: spection. But besides other Differences, which are nanecessary to mention, the Forgery is on common Paper, so that by holding it up to the Light, it may at once be detected by its wanting the Water Mark of Paisley
