The KING's Most Excellent Majesty in Council.

THEREAS by an Act passed in the Twentyeighth Year of the Reign of His present Majesty, intituled, "An Act for regulating the Trade " between the Subjects of His Majesty's Colonies " and Plantations in North America and in the " West India Islands, and the Countries belonging " to the United States of America; and between " His Majesty's faid Subjects and the Foreign Islands " in the West Indies, it is, amongst other Things, enacted, That it shall and may be lawful for His Majesty in Council, by Order or Orders to be iffued and published from Time to Time, to authorize, or by Warrant or Warrants, under His Sign Manual, to impower the Governor of Newfoundland for the Time being to authorize, in Case of Necessity, the Importation into Newfoundland of Bread, Flour, Indian Corn, and Live Stock, from any of the Territories belonging to the said United States, for the Supply of the Inhabitants and Fishermen of the Island of Newfoundland, for the then ensuing Season only; provided always, that fuch Bread, Flour, Indian Corn, and Live Stock, fo authorized to be imported into the Island of Newfoundland, shall not be imported except in conformity to fuch Rules, Regulations and Restric-

Warrant or Warrants, respectively, and except by British Subjects and in British-built Ships owned by His Majesty's Subjects, and navigated according to Law: And whereas it is expedient and necessary that Provision be made for fully supplying the Inhabitants and Fishermen of the Island of Newfoundland for the ensuing Season with Bread, Flour, and Indian Corn; His Majesty doth thereupon, by and with the Advice of His Privy Council, hereby order and declare, That, for the Supply of the Inhabitants and Fishermen of the Island of Newfoundland, for the ensuing Season only, Bread, Flour and Indian Corn be imported into the faid Island from any of the Territories belonging to the faid United States, by British Subjects, and in British built Ships owned by His Majesty's Subjects, and navigated according to Law, and which shall, within the Space of Seven Months previous to the Time of fuch Importation, have cleared out from some Port in Great Britain, or some other Port of His Majesty's Dominions in Europe, for which Purpose a Licence shall have been granted by the Commissioners of His Majesty's Customs in England or Scotland, or the Commissioners of His Majesty's Revenue in Ireland, or any other Person or Persons who may be duly authorized in that Kingdom respectively, in the Manner and Form herein after mentioned; which Licences shall continue and be in Force for Seven Calendar Months from the Day of the Date upon

which they are respectively granted, and no longer; provided that no fuch Licence as aforefaid, granted after the Thirtieth Day of June, One Phonfand Seven Hundred and Ninety, shall be of any Force or Effect: And His Majefty is hereby further pleased to order, That the Master, or Person having the Charge or Command of any Ship or Vessel to whom such Licence shall be granted, shall, upon the Arrival of the faid Ship or Vessel at the Port, Harbour or Place in the Island of Newfoundland where he shall discharge such Bread, Flour, or Indian Corn, deliver up the faid Licence to the Collector or other proper Officer of the Customs there, having first indorsed on the Back of such Licence the Marks, Numbers and Contents of each Package of Bread, Flour, or Indian Corn, under the Penalty of the Forfeiture in the faid Act mentioned. And the Collector or other proper Officer of the Customs at Newfoundland is hereby enjoined and required to give a Certificate to the Master, or Person having the Charge or Command of such Ship or Vessel, of his having received the said Licence, so indorfed as before directed, and to transmit the fame to the Commissioners of His Majesty's Customs in England or Scotland, or to the Commissioners of His Majesty's Revenue in Ireland, respectively, by whom fuch Licence was granted.

Now be it known that the faid [Perfon's Name] hath Licence to lade on board the faid Ship [Ship's Name], at and from any Port or Place belonging to the United States of America, Bread, Flour, and Indian Corn, the Produce of the faid United States, and no other Article whatfoever, and to carry the faid Bread, Flour, and Indian Corn to some Port or Place on the Island of Newfoundland; and on the Arrival of the faid Ship at any Port, Harbour, or Place of Discharge in Newfoundland, the Master, or Person having the Charge or Command of the faid Ship, is required and enjoined to deliver up the faid Licence to the Collector or other proper Officer of His Majesty's Customs there, and to indorse on the Back thereof the Marks, Numbers, and Contents of each Package of Bread. Flour, or Indian Corn, and shall thereupon receive a Certificate thereof from the faid Collector or other proper Officer of the Cuftoms.

Dublin-Castle, January 21, 1790.

HIS Day the Parliament having met, his Excellency the Lord Lieutenant went in State to the House of Peers, and being seated on the Throne with the usual Solemnity, the Honourable Henry Fane, Gentleman Usher of the Black Rod, was sent with a Message from his Excellency to the House of Commons, signifying his Pleasure that they should immediately attend his Excellency in the House of Peers; and the Commons being come thither accordingly, his Excellency was pleased to open the Sessions with the following Speech from the Throne:

My Lords, and Gentlemen,

THE King having been graciously pleased to place me in the Government of this Kingdom, I have His Majesty's Commands to meet you in Parliament, and it affords me peculiar Satisfaction that I enter upon the Discharge of this most important Trust at a Period when this Country, in common with the rest of His Majesty's Dominions, is in the secure Enjoyment of the Blessings of Peace, and of the incstimable Advantages arising from our free Constitution.

This happy Situation will undoubtedly encourage you to perfevere in the Maintenance of good Government, and to adhere to that wife System of Policy, which has established the Credit, the Industry, and the Prosperity of your Country upon a firm and steady Foundation.

Gentlemen of the House of Commons,

I have ordered the National Accounts to be laid before you, and I trust you will make such Provisions as shall be necessary for the Exigencies of the State, and the honourable Support of His Majesty's Government.

My Lords, and Gentlemen,

Your Zeal for the Interests of this Country will naturally direct your Attention to whatever can increase the Wealth and extend the Industry of Ireland. Her Agriculture and Linen Manusacture will claim your especial Care, and the Institutions of the Charter and other Protestant Schools will, I am persuaded, receive from you that Consideration which the Interests of Religion, and the good Education of Youth, peculiarly demand. I earnestly recommend to your Attention the improving and continuing such Laws as Experience hath shewn to be of National Benefit; and I have the King's Commands to assure you, that such Measures, as may contribute to that End, will meet with His Majesty's most gracious Concurrence.

Impressed with a deep Sense of the distinguished Honour which His Majesty has conferred upon me by my Appointment to this arduous Situation, I shall endeavour, with the utmost Zeal and Attention, to promote the Happiness and Welfare of Ireland; fully sensible, that I cannot otherwise hope either to render my Services acceptable to my Sovereign, or to ensure your favourable Opinion and Considence.

His Majesty, by His Royal Letters, bearing Date the 16th Day of July, 1789, having appointed Richard Longfield, Esq; to be of His Most Honourable Privy Council of this Kingdom, he this Day in Council took the usual Oaths, and his Place at the Board accordingly.

Whitehall, January 26.

As feveral Artificers and Manufacturers, Surjects of Great Britain, have from Time to Time gone into Foreign Countries to exercise their several Callings, contrary to the Laws of these Kingdoms; the following Abstracts of Acis of Parliament of their lave Majestics, King George the First and Second, and of this present Wiojesty, for prewenting such Practices, are published for the Information of all Persons who may be ignorant of the Penalties they may incur by Dischedience to them.—And it will be observed, that such Penalties likewise extend to those who are any ways concerned or instrumental in the Sending or Enticing Artificers or Manufacturers out of these Kingdoms, or in the Exportation of the Tools and Instruments used by them, as well us to the Artificers or Manufacturers themselves.

Statute 5 George I. Chap. 27.

F any Person shall contract with, entice, or solicit, any Artificer in Wool, Iron, Steel, Brass, or other Metal, Clock-maker, Watch-maker, or any other Artificer of Great Britain, to go into Foreign Countries, out of the King's Dominions, and shall be convicted thereof upon Indictment or Information, in any of the Courts at Westminster, or at the Assizes or Quarter-Sessions, he shall be fined any Sum not exceeding ONE HUNDRED POUNDS for the first Offence, and shall be imprisoned Three Months, and till the Fine be paid. And if any Person having been once convicted, shall offend again, he shall be fined at the Discretion of the Court, and imprisoned Twelve Months, and till the Fine be paid.

If any of the King's Subjects, being such Artificers, shall go into any Country out of His Majesty's Dominions, to exercise or teach the said Trades to Foreigners; and if any of the King's Subjects in any such Foreign Country, exercising any of the said Trades, shall not return into this Realm within Six Months after Warning given by the Ambassador, Minister or Consul of Great Britain, in the Country where such Artisicers shall be, or by any Person authorised by such Ambassador, &c. or by one of the Secretaries of State, and from hencesorth inhabit within this Realm; such Persons shall be incapable of taking any Legacy, or of being an Executor or Administrator, or of taking any Lands, &c. within this Kingdom, by Descent, Devise or Purchase; and shall forseit all Lands, Goods, &c. within this Kingdom, to His Majesty's Use, and shall be deemed Alien, and out of His Majesty's Protection.

Upon Complaint made upon Oath before any Justice of Peace that any Person is endeavouring to seduce any such Artificer, or that any such Artificer hath contracted, or is preparing to go out of His Majesty's Dominions, for the Purposes aforesaid; such Justice may send his Warrant to bring the Person complained of before him, or before some other Justice; and if it shall appear by the Oath of one Witness, or by Confession, that he was guilty of any of the said Offences, such Justice may bind him to appear at the next Affizes or Quarter Sessions: And if such Person shall resuse to give Security, the Justice may commit him to Goal till the next Affizes or Quarter Sessions, and until he shall

be delivered by due Course of Law. And if any such Artificer shall be convicted upon Indictment of any such Promise, Contract, or Preparation to go beyond the Seas for the Purpose aforesaid, he shall give such Security to the King, not to depart out of His Majesty's Dominions, as such Court shall think reasonable, and shall be imprisoned till Security given.

If any of the above Offences shall be committed in Scotland, the same shall be prosecuted in the

Court of Justiciary, or the Circuits there.

Statute 23 George II. Chap. 13.

TF any Person shall contract with, or endcavour to feduce any Artificer in Wool, Mohair, Cotton or Silk, or in Iron, Steel, Brass, or other Metal, or any Clock-maker, Watch-maker, or any other Artificer in any other of the Manufac-tures of Great Britain or Ireland, to go out of this Kingdom or Ireland, into any Foreign Country, not within the Dominions of the Crown of Great Britain, and shall be convicted upon Indictment or Information in the King's Bench at Westminster, or by Indictment at the Assizes or General Gaol Delivery for the County, &c. wherein such Offence shall be committed in England, or by Indictment in the Court of Justiciary, or any of the Circuit Courts in Scotland, or by Indictment or Information in the King's Bench at Dublin, if such Offence be committed in Ireland; the Person so convicted shall, for every Artificer contracted with, or seduced, forseit FIVE HUNDRED POUNDS, and shall suffer Imprifonment in the Common Goal of the County or Stewartry wherein such Offender shall be convicted, for Twelve Calendar Months, and until Foreiture be paid: And in Case of a subsequent Offence of the same Kind, the Persons so again offending shall forfeit, for every Person contracted with or seduced, ONE THOUSAND POUNDS, and shall suffer Imprisonment in the Common Gaol of the County or Stewartry wherein fuch Offender shall be convicted, for Two Years, and until such Forfeiture be paid.

If any Person in Great Britain or Ireland shall put on Board any Ship or Boat not bound directly to some Port in Great Britain or Ireland, or to some other of the Dominions of the Crown of Great Britain, any such Tools or Utensils as are commonly used in. or proper for the Preparing, Working up or Finishing of the Woollen or Silk Manusactures or any Part of such Tools, he shall for every Offence forfeit all such Tools, or Parts thereof, put on Board, and TWO HUNDRED POUNDS, to be recovered by Action of Debt, &c. in any Court of Record at Westminster, or in the Court of Session in Scotland, or at any of the Four Courts in Dublin respectively, wherein no Essoin, &c.

shall be allowed.

It shall be lawful for any Officer of the Customs in Great Britain, or for any Officer of the Revenue in Ireland, to seize and secure, in some of His Majesty's Warehouses, all such Tools or Utensils prohibited to be exported, as such Officer shall sind on Board any Vessel not bound directly to some Port in Great Britain or Ireland, or to some other of the Dominions of the Crown of Great Britain; and all

Tools so seized shall, after Condemnation, be publickly sold to the best Bidder; and one Moiety of the Produce shall be to the Use of His Majesty, and the other Moiety to the Officer who shall seize

and fecure the fame.

If the Captain of any Vessel in Great Britain or Ireland knowingly permit any of the said Tools, prohibted to be exported, to be put on Board his Vessel, he shall for every such Offence forseit ONE HUNDRED POUNDS, to be recovered as the Penalties inslicted upon Persons exporting the Tools; and if the Vessel belongs to His Majesty, the Captain shall not only forseit ONE HUNDRED POUNDS, but shall also forseit his Employment, and be incapable of any Employment under His Majesty.

If any Officer of the Customs in Great Britain or of the Revenue in Ireland, take, or knowingly suffer to be taken, any Entry outward, or sign any Cocket or Sufferance for the Shipping or Exporting of any of the said Tools, or knowingly affer the same to be done, he shall forfeit ONE HUNDRED POUNDS, to be recovered as aforesaid, and also forfeit his Office, and be incapable of any Office

under His Majesty.

One Moiety of the Forfeitures shall be applied to the Use of His Majesty, and the other Moiety to the Use of the Person who shall sue for the same.

Y these Statutes the like Penalties and For-D feitures as above mentioned are extended to Persons packing or putting on board any Vessel, not bound directly for some Port in Great Britain or Ireland, any Machine, Engine, Tool, Press, Paper, Utenfil or Implement whatsoever used in, or proper for the working or finishing of the Cotton, Linen, Steel or Iron Manufactures of this Kingdom, or any Part or Parts of fuch Machines or Implements, or any Models or Plans thereof;and all Captains of Ships and other Persons receiving or being in Possession of any such Articles, with an Intent to export the same to Foreign Parts, and all Custom-house Officers suffering an Entry to be made thereof, are respectively liable to the like Penaltics as are above mentioned, in the Case of Tools and Utensils used in the Woollen and Silk Manufactures.
