HEREAS it has been represented to the King, That there are at this Time several Deserters from the different Corps in His Majesty's Land Service, who might be induced to return to their Duty by an Offer of His Majesty's gracious Pardon, and that such an Instance of His Royal Clemency would have due Instance upon their future Behavior; His Majesty is pleased to grant His free Pardon to all Deserters from His Land Forces who shall surrender themselves before the Tenth Day of July next, either to the Regiments to which they belong, or to some other Corps in His Majesty's Service, or to any Recruiting Party in Great Britain or Ireland.

Such Deferters, if able-bodied Men and fit for Service, shall be attested in the Corps to which they surrender, and not be liable to be claimed by any other Corps to which they may formerly have belonged.

And whereas many of the said Deserters may have inlisted in other Corps, and are now serving therein; His Majesty is graciously pleased to extend to such Deserters the Benefit of this Pardon, and to direct, that they shall continue to serve in the Corps wherein they now are, and not be claimed by that in which they formerly served.

And whereas feveral of the said Deserters have been apprehended, and are now in Gaol or in Regimental Custody; His Majesty is likewise pleased to grant to them His free Pardon, of which they are to have the Benesit upon their Arrival at their respective Regiments, or upon their being inlisted by some other Corps, or Recruiting Party.

Any Soldier who may defert, after these His Majesty's most gracious Intentions are made public, shall not be included in the above Pardon, but be proceeded against with the utmost Severity.

To the End that the said Commissioners for the Affairs of the Hospital may be satisfied that they are the same Persons who have passed their Examinations, the Pensioners are hereby further directed, that such of them as have served in, and been discharged from, any of the Regiments or Independent Companies of Invalids, are not to mention in their Affidavits such Regiment or Company of Inval ds in which they served, but the Regiment, Troop, or Corps of the Army from which they were first discharged, and recommended and received to Chelsea Hospital.
