The KING's Most Excellent Majesty in Council. HEREAS His Majesty, by His Royal Proclamation, bearing Date the 7th Day of May last, was graciously pleased to promise and declare, that all Able-bodied Seamen, Twenty Years, fit for His Majefty's Service, who should, on or before the 30th Day of June then next, enter themselves to serve in His Majefty's Royal Navy, should receive, as His Majefty's Royal Bounty, the Sum of Three Pounds each Man; and that all fuch Ordinary Seamen, as should so enter themselves as aforefaid, should receive the Sum of Two Pounds each Man; and that all fuch Able-bodied Landmen, not above the Age of Thirty five nor under the Age of Twenty Years, as should so enter themselves as aforefaid, should receive the Sum of Twenty Shillings; fuch feveral Sums to be paid to them by the Clerks of the Cheque refiding at the Ports or Places where the Ships, into which such Seamen or Landmen so entering, should be, according to the Certificates therein mentioned: And whereas by another Proclamation bearing Date the faid 7th Day of May, His Majefty was further pleafed to promife and declare, that a Reward of Twenty Shillings for every Able and Ordinary Scaman should be paid to any Person who should discover any Scaman or Seamen who should secrete him or themselves, so that such Seaman or Seamen should be taken for His Majesty's Service by any of the Sea Officers employed for

AT the Court at St. James's, the 4th of August; raising Men on or before the said 30th Day of June then next; fuch Rewards to be paid for any Seaman or Seamen so discovered and taken by the Persons mentioned in the said Proclamation, and remons mentioned in the faid Proclamation, and according to the Certificate thereby required: And whereas His Majesty, by Order in Council, bearing Date the 23d of June last, was further pleased to direct, that the Time limited by the said Proclamation for granting the said Bounties and Rewards should be prolonged and extended from the said 30th Day of June to the 31st of this present Month of August, inclusive: And whereas Provision hath been made in the Kingdom of Ireland for the hath been made in the Kingdom of Ireland for the Extraordinary Expence of Government, which may be necessary in putting and maintaining that Kingdom in a State of Defence, and towards raising Men for His Majesty's Fleet:

His Majesty having this Day taken the said Proclamations and Order in Council into Confideration, is pleased, by and with the Advice of His Privy Council, to declare, that the faid feveral Bounties and Rewards, thereby promifed and declared to be payable during the Times therein respectively mentioned; shall henceforth cease and dete mine, and be no longer paid and payable in this Kingdom, to such Able or Ordinary Seamen, or to such Able-bodied Landmen as shall henceforth enter themselves in the Kingdom of Ireland to serve in His Majesty's Navy, or to fuch Persons who may discover any Seaman or Seamen who shall secrete him or themselves in that Kingdom, from and after the Date hereof, any Thing in the aforefaid Proclamations or Order in Council to the contrary in any wife notwithstanding.

Roper and Rayner, of Leeds, another Bill of Exchange, taken out of the same Mail, for 69l. 5s. 6d. which he endorsed in the Name of "Wm. Brown."
