The KING's Most Excellent Majesty in Council. HEREAS by virtue of an Act, passed in the last Session of Parliament, incituled, " An Act to continue the Laws now in Force for regulating the Trade between the Subjects of His Majesty's Dominions and the Inhabitants of " the Territories belonging to the United States of " America, so far as the same relate to the Trade " and Commerce carried on between this King-"dom and the Inhabitants of the Countries be"longing to the faid United States," His Majefty, by the Advice of His Privy Council, did, by an Order in Council made on the 1st Day of April, 1790, amongst other Things, declare, That any unmanufactured Goods and Merchandizes, the Importation of which into this Kingdom is not pro-hibited by Law, (except Fish-Oil, Blubber, Whale-Fins and Spermaceti) and any Pig-Iron, Bar-Iron, Pitch, Tar, Turpentine, Rosin, Pot-Ash, Pearl-Ash, Indigo, Masts, Yards and Bowsprits, being the Growth or Production of any of the Territories of the United States of America, and no other Goods or Merchandizes, might (until further Order) he imported directly from thence into any of the Ports of this Kingdom, either in British-built Ships, -owned by His Majesty's Subjects and navigated according to Law, or in Ships built in the Countries be onging to the United States of America, or any of them, and owned by the Subjects of the faid United States, or any of them, and whereof the Master and Three-fourths of the Mariners at least

are Subjects of the faid United States, or any of them, and may be entered and landed in any Port of this Kingdom, upon Payment of the same Duties as the like Sorts of Goods or Merchandize are or might be subject and liable to if imported in British-built Ships, owned by His Majesty's Subjects and navigated according to Law, from any British Island or Plantation in America; notwithstanding such Goods or Merchandize, or the Ships in which the same may be brought, might not be accompanied with the Certificates or other Documents heretofore required by Law.

And whereas Doubts have arisen upon the true Intent and Meaning of that Part of His Majesty's Order in Council herein before mentioned which respects the Importation of Fish-Oil, Blubber, Whale-Fins and Spermaceti, and such other Goods and Merchandize, being of the Growth, Produc-tion or Manufacture of the faid United States, as are not therein enumerated or described; His Majesty; by the Advice of His Council, doth hereby order and declare, That Oil made from Fish or Creatures living in the Sea, and Blubber, Whale-Fins and Spermaceti, and also all other Goods and Merchandize, the Importation of which into this Kingdom is not prohibited by Law, being the Growth, Production or Manufacture of any of the Territories of the said United States of America. and not enumerated or described in the fail Order, may be imported from thence into this Kingdom in British or American Ships, owned and navigated as by the faid Order is required, upon Payment of fuch Duties of Customs and Excise as are payable on the like Goods or Merchandize upon their Importation into this Kingdom from Countries not

the Tables, marked A. D. and F. annexed to an Act, passed in the Twenty-seventh Year of His prefent Majesty's Reign, intituled, "An Act for re-"pealing the several Duties of Customs and Ex-" cife, and granting other Duties in Lieu thereof, and for applying the faid Duties, together with the other Duties composing the Publick Rewenue; for permitting the Importation of certain Goods, Wares and Merchandize, the Produce or Manufacture of the European Dominions of the " French King, into this Kingdom; and for applying certain unclaimed Monies remaining in the Exchequer for the Payment of Annuities on Lives to the Reduction of the National Debt;" or by any other Laws in Force, passed subsequent to the said Act, for that Purpole; and in Cases where different Duties are therein imposed upon the like Goods imported from different Countries not under the Dominion of His Majesty, then upon the Payment of the lowest of such Duties; and such Goods and Merchandize shall be entitled to the same Drawbacks as are allowed upon the Exportation of the like Goods and Merchandize from this Kingdom, according to the before-mentioned Tables, or by any other Laws in Force, passed subsequent to the faid Act, for that Purpose; and shall be liable to the fame Rules, Regulations and Restrictions as the like Goods and Merchandize are liable to upon Importation into any Port of this Kingdom, by any Laws in Force for that Purpose.

And the Right Honorable the Lords Commis-fioners of His Majerty's Treasury, and the Lords Commissioners of the Admiralty, are to give the necessary Directions berein, as to them may respec-

trively appertain.
