PRESENT,

The KING's Most Excellent Majesty in Council.

HEREAS the Time limited by His Ma-W jesty's Proclamation of the 7th Day of May last, for granting Bounties for the encouraging of Seamen and Landmen to enter themselves on Board His Majesty's Ships of War, was, so far as respects the Bounties granted to Able and Ordinary Seamen, and Able-bodied Landmen, entering them selves in the Kingdom of Great Britain, and the Rewards to Persons discovering Seamen who might fecre e themselves in this Kingdom, prolonged and extended, by His Majesty's Order in Council of the 27th of August last, until the 31st Day of this instant October: And whereas it is expedient for His Majefly's Service, that the faid Bounties and Rewards should continue to be paid for some Time longer; His Majesty doth therefore, by the Advice of His Privy Council, hereby order, That the Payment of fuch Bounties to Able and Ordinary Seamen and Able-bodied Landmen entering themselves in the Kingdom of Great Britain, to serve in His Majesty's Fleet, and also the Rewards to Persons discovering Seamen who secrete themselves in this Kingdom, be continued to the 31st Day of December next inclu-five:—Whereof all Persons concerned are to take Notice, and govern themselves accordingly.

London, November 9.

Yesterday John Boydell, Esq; Lord Mayor Elect for the Year ensuing, was sworn at Guildhall; when the Chair and other Ensigns of Mayoralty were surrendered to him in the accustomed Manner.

This Day the new Lord Mayor, accompanied by the late Lord Mayor; the Aldermen, Recorder, and Sheriffs, in their Scarlet Gowns, went in their Coaches to the Water-fide, the Sword and Mace being carried before them, and the City Officers attending; and from thence proceeded in the City Barge, attended by the feveral Companies in their respective Barges, adorned with Streamers and Pendants, to Weiminster; and having walked round the Hall, and solemaly faluted all the Courts, they went to the Exchequer Bar, and the new Lord Mayor did there take the Oaths appointed; and having recorded Warrants of Attorney in the proper Courts, returned by Water to Black Friars, and from thence in Coaches, with the usual Solemnity, to Guildhall, where a magnificent Entertainment was provided.

Stockholm, October 22.

Yesterday in the Asternoon the King of Sweden made his Public Entry into the Harbour of Stockholm with a large Division of the Coasting Fleet, confishing of Gallies and Gun-Boats, which had arrived in Safety from Finland, having on Board the Troops that are to be stationed at Stockholm and in the Districts bordering on the Lake Meller,

Whitehall, November 9.

As several Artificers and Manufacturers, Subjects of Great Britain, have from Time to Time gone into Foreign Countries to exercise their several Callings, contrary to the Laws of these Kingdoms; the following Abstracts of Acts of Parliament of their lave Majesties, King George the First and Second, and of His prisent Majesty, for preventing such Practices, are published for the Information of all Persons who may be ignorant of the Penalties they may incur by Disobedience to them—And it will be observed, that such Penalties likewise extend to those who are any ways concerned or instrumental in the Sending or Enticing Artificers or Manufacturers out of these Kingdoms, or in the Exportation of the Tools and Instruments used by them, as well as to the Artificers or Manufacturers themselves.

Statute 5 George I. Chap. 27.

If any Person stall contract with, entice, or solicit, any Artificer in Wool, Iron, Steel, Brass, or other Metal, Clock-maker, Watch-maker, or any other Artificer of Great Britain, to go into Foreign Countries, out of the King's Dominions, and shall be convicted thereof upon Indictment or Information, in any of the Courts at Westminster, or at the Assizes or Quarter-Sessions, he shall be fined any Sum not exceeding ONE HUNDRED POUNDS for the first Offence, and shall be imprisoned Three Months, and till the Fine be paid. And if any Person having been once convicted, shall offend again, he shall be fined at the Discretion of the Court, and imprisoned Twelve Months, and till the Fine be

paid.

If any of the King's Subjects, being such Artificers, shall go into any Country out of His Majesty's Dominions, to exercise or teach the said Trades to Foreigners; and if any of the King's Subjects in any such Foreign Country, exercising any of the said Trades, shall not return into this Realm within Six Months after Warning given by the Ambassador, Minister or Consul of Great Britain, in the Country where such Artificers shall be, or by any Person authorised by such Ambassador, &c. or by one of the Secretaries of State, and from henceforth inhabit within this Realm; such Persons shall be incapable of taking any Legacy, or of being an Executor or Administrator, or of taking any Lands, &c. within this Kingdom, by Descent, Detaile or Purchase; and shall forfeit all Lands, Goods, &c. within this Kingdom, to His Majesty's Protection.

Upon Complaint made upon Oath before any Justice of Peace that any Person is endeavouring to seduce any such Artisicer, or that any such Artisicer hath contracted, or is preparing to go out of His Majesty's Dominions, for the Purposes aforestaid; such Justice may send his Warrant to bring the Person complained of before him, or before some other Justice; and if it shall appear by the Oath of one Witness, or by Confession, that he was guilty of any of the said Offences, such Justice may bind him to appear at the next Affizes or Quarter Sessions: And if such Person shall resuse to give Security, the Justice may commit him to Goal till the wext Affizes or Quarter Sessions, and until he shall

be delivered by due Course of Law. And if any such Artificer shall be convicted upon Indistment of any such Promise, Contract, or Preparation to go beyond the Seas for the Purpose aforesaid, he shall give such Security to the King, not to depart out of His Majesty's Dominions, as such Court shall think reasonable, and shall be imprisoned till Security given.

If any of the above Offences shall be committed in Scotland, the same shall be prosecuted in the Court of Justiciary, or the Circuits there.

Statute 23 George II. Chap. 13.

IF any Person shall contract with, or endeavour to seduce any Artificer in Wool, Mohair, Cotton or Silk, or in Iron, Steel, Brass, or other Metal, or any Clock-maker, Watch-maker, any other Artificer in any other of the Manufactures of Great Britain or Ireland, to go out of this Kingdom or Ireland, into any Foreign Country, not within the Dominions of the Crown of Great Britain, and shall be convicted upon Indictment or Information in the King's Bench at Westminster, or by Indictment at the Affizes or General Gaol Delivery for the County, &c. wherein such Offence shall be committed in England, or by Indicament in the Court of Justiciary, or any of the Circuit Courts in Scotland, or by Indictment or Information in the King's Bench at Dublin, if such Offence be committed in Ireland; the Person so convicted shall, for every Artificer contracted with, or seduced, forfeit FIVE HUNDRED POUNDS, and shall suffer Impri-fonment in the Common Goal of the County or Stewartry wherein such Offender shall be convicted, for Twelve Calendar Months, and until Foreiture be paid: And in Case of a subsequent Offence of the same Kind, the Persons so again offending shall forfeit, for every Person contracted with or seduced, ONE THOUSAND POUNDS, and shall suffer Imprisonment in the Common Gaolof the County or Stewartry wherein such Offender shall be convicted, for Two Years, and until fuch Forfeiture be paid.

If any Person in Great Britain or Ireland shall put on Board any Ship or Boat not bound directly to some Port in Great Britain or Ireland, or to some other of the Dominions of the Crown of Great Britain, any such Tools or Utensils as are commonly used in. or proper for the Preparing, Working up or Finishing of the Woollen or Silk Manufactures or any Part of such Tools, he shall for every Offence forseit all such Tools, or Parts thereof, put on Board, and TWO HUNDRED POUNDS, to be recovered by Action of Debt, &c. in any Court of Record at Westminster, or in the Court of Session in Scotland, or at any of the Four Courts in Dublin respectively, wherein no Ession, &c. shall be ailowed.

It shall be lawful for any Officer of the Customs in Great Britain, or for any Officer of the Revenue in Ireland, to seize and secure, in some of His Majelly's Warehouses, all such Tools or Utensils pronibited to be exported, as such Officer shall find on Board any Vessel not bound directly to some Port in Great Britain or Ireland, or to some other of the Dominions of the Crown of Great Britain; and all

Tools so seized shall, after Condemnation, be publickly fold to the best Bidder; and one Moiety of the Produce shall be to the Use of His Majesty, and the other Moiety to the Officer who shall seize

and fecure the fame.

If the Captain of any Vessel in Great Britain or Ireland knowingly permit any of the faid Tools, prohibted to be exported, to be put on Board his Vessel, he shall for every such Offence forseit ONE HUNDRED POUNDS, to be recovered as the Penalties inflicted upon Persons exporting the Tools; and if the Vessel belongs to His Majesty, the Captain shall not only forfeit ONE HUN-DRED POUNDS, but shall also forfeit his Empoyment, and be incapable of any Employment under His Majesty.

if any Officer of the Customs in Great Britain, or of the Revenue in Ireland, take, or knowingly fuffer to be taken, any Entry outward, or fign any Cocket or Sufferance for the Shipping or Exporting of any of the faid Tools, or knowingly fuffer the fame to be done, he shall forfeit ONE HUNDRED POUNDS, to be recovered as aforesaid, and also forfeit his Office, and be incapable of any Office

under His Majesty.

One Moiety of the Forfeitures shall be applied to the Use of His Majelty, and the other Moiety to the Use of the Person who shall sue for the

Statutes 14, 21, 25 and 26 of His present Majesty.

Y these Statutes the like Penalties and Forfeitures as above mentioned are extended to Persons packing or putting on board any Vessel, not bound directly for some Port in Great Britain or Ireland, any Machine, Engine, Tool, Press, Paper, Utenfil or Implement whatsoever used in, or proper for the working or finishing of the Cotton, Linen, Steel or Iron Manufactures of this Kingdom, or any Part or Parts of fuch Machines or Implements, or any Models or Plans thereof;and all Captains of Ships and other Persons receiving or being in Possession of any such Articles, with an Intent to export the same to Foreign Parts, and all Cultom-house Officers suffering an Entry to be made thereof, are respectively liable to the like Penalties as are above mentioned, in the Cafe of Tools and Utenfils used in the Woollen and Silk Manufactures.
