The KING's Most Excellent Majesty in Council. WHEREAS His Majesty was pleased, by His Order in Council of the 20th of last Month, to direct, That the Bounties granted by His Majesty's Proclamation of the 7th of May last to Able and Ordinary Seamen, and Able-bodied Landmen, and the Rewards granted to Perfons difcovering Seamen who might fecrete themselves, should, so far as respected the Bounties to Seamen and Able-bodied Landmen entering themselves in the Kingdom of Great Biftain, and the Rewards to Persons discovering Seamen who might secrete themselves in this Kingdom, be continued to the 31st Day of December next inclusive;—His Majesty, judging it no longer necessary to continue such Bounties and Rewards, is pleased, by and with the Advice of His Privy Council, to order and declare, That the faid Bounties and Rewards shall from henceforth cease, determine, and be no longer paid or payable, any Thing in the said Order of the 20th of last Month contained to the contrary notwithstanding:-Whereof all Persons concerned are to take Notice, and govern themselves accordingly. Yesterday being the Anniversary of the Birth of the late King William the Third, of glorious Memory, in the Morning the Flag was displayed on Bedford Tower; at Noon there was a splendid Appearance of the Nobility and other Persons of Distinction at the Castle to compliment his Excellency the Lord Lieutenant; after which his Excellency, attended by the Nobility and Gentry, and escorted by a Squadron of Horse, went in Procession round the Statue of King William.
