APROCLAMATION,

For Encouraging Seamen and Landmen to enter themfelves on Board His Majesty's Ships of War. GEORGE R.

THEREAS it is Our Royal Intention to give all due Encouragement to all fuch Seamen and Landmen who shall voluntatily enter themselves in Our Service; We have thought fit, by and with the Advice of Our Privy Council, to publish this Our Royal Proclamation: And We do hereby promise and declare, That all fuch Able Seamen, not above the Age of Fifty, not under the Age of Twenty Years, fit for Our Service, who shall, on or before the Thirty-first Day of May next, voluntarily enter themselves to serve in Our Royal Navy, either with the Captains or Lieutenants of Our Ships, or Officers employed in Tenders, or at Rendezvous on Shore, for Raifing Men for the Service of Our Navy, shall receive; as Our Royal Bounty, the Sum of Three Pounds each Man; and all fuch Ordinary Seamen, of the Ages above mentioned, fit for Our Service, who shall so enter themselves as aforesaid, shall receive the Sum of Two Pounds each Man: And all fuch Able-Bodied Landmen, not above the Age of Thirty-five, nor under the Age of Twenty Years, who shall so enter themselves as

aforesaid, shall receive the Sum of Twenty Shillings each Man, as Our Royal Bounty; fuch respective Sums to be paid them by the respective Clerks of the Cheque, residing at the Ports or Places where the Ships, into which they shall be entered, shall be, immediately after the Third Muster of such Seamen and Landmen. And We do declare, that the Qualifications of the Seamen and Landmen, so entering themselves as aforesaid, shall be certified by the Captain, Master, and Boatswain of the Ship or Vessel where they shall enter. And, for Prevention of any Abuses, by any Persons leaving the Vessels to which they shall belong, and entering themselves on Board any other Our Ships or Vessels, in order to obtain the faid Bounty-Money, We do hereby declare and command, that such Seamen and Landmen, belonging to any of Our Ships or Veffels, as shall absent themselves from any of the said Ships or Vessels to which they shall belong, and shall enter themselves on Board any other of Our faid Ships or Vessels, in order to obtain the said Bounty, shall not only lose the Wages due to them in the Ships or Vessels they shall leave, but also be feverely punished according to their Demerits.

A PROCLAMATION,

For Recalling and Probibiting Seamen from ferwing Foreign Princes and States, and for granting Rewards for discovering such Seamen as shall conceal themselves.

GEORGE R.

THEREAS We are informed, That great Numbers of Mariners and Seafaring Men, Our natural-born Subjects, are in the Service of divers Foreign Princes and States, to the Prejudice of Our Kingdom; We have therefore thought it neces-Tary, by and with the Advice of Our Privy Council, to publish this Our Royal Proclamation; and do hereby strictly charge and command all Masters of Ships, Pilots, Mariners, Seamen, Shipwrights, and other Seafaring Men whatfoever and wherefoever, (being Our natural-born Subjects) who are in the Pay or Service of any Foreign Prince or State, or do ferve in any Foreign Ship or Vessel, that forthwith they, and every of them, do (according to their known and bounden Duty and Allegiance) withdraw themselves, depart from, and quit fuch Foreign Services, and return Home to their Native Countries. And further, We do hereby flrictly prohibit and forbid all Masters of Ships, Pilots, Mariners, Seamen, Shipwrights, and other Seafaring Men whatfoever, (being Our natural-born Subjects) from entering, and do charge and command them, and every of them, from henceforth, to forbear to enter themselves into the Pay or Service of any Foreign Prince or State, or to serve in any Foreign Ship or Vessel whatsoever, without Our special Licence first had and obtained in that Behalf; to all which We expect due Obedience and exact Conformity. And We do hereby publish and declare, that the Offenders to the contrary shall not only incur Our just Displeasure, but be proceeded against for their Contempt according to the utmost Severities of the Law. And We do hereby declare, that if any such Masters of Ships, Pilots, Mariners, Seamen, Shipwrights, or other Seafaring Men, (being Our Subjects) shall be take.. in any Foreign Service by the Turks, Algerines, or any others, they shall not be reclaimed by Us as Subjects of Great Britain. And we do hereby further promise and declare, that a Reward of Twenty Shillings for every Able and Ordinary Seaman shall be paid any Person who shall discover any Seama. or Seamen who may conceal him or themselves, so that fuch Seaman or Seamen shall be taken for our faid Service, on or before the 31st Day of Maynext, by any of Our Sea Officers appointed to raife Men on Shore, or by the Captains and Commanders of any of

Our Ships or Veffels in the Ports, or on the Coasts of this Kingdom, the faid Rewards to be paid for any Seaman or Seamen, fo discovered and taken in and about London, by the Principal Officers and Commissioners of Our Navy; and at the Out-Ports by the Clerks of the Cheque at Deptford, Woolwich, Chatham, Sheerness, Portsmouth, or Plymouth, or the Naval Officers at Harwich or Deal respectively; and (where there are no Clerks of the Cheque or Naval Officers) by the Collector or proper Officer of Our Customs at the Port which may be nearest to the Place where such Seaman or Seamen shall be taken, immediately upon a Certificate being produced to the faid Principal Officers and Commissioners of Our Navy, Clerks of the Cheque, Naval Officers, Collectors or proper Officers of the Customs, respectively, by the Person who may make Discovery of any Seaman or Seamen as aforefaid, certifying his Name, and the Name or Names and Number of Seamen procured in consequence of his Discovery; the faid Certificate to be given by fuch Officer as may take fuch Seaman or Seamen for Our Service; and the Amount of all Payments, so to be made by the Collectors or proper Officers of Our Cuftoms. to be reimbursed to them by the Principal Officers and Commissioners of Our Navy, as heretofore, upon authentic Accounts thereof being transmitted to the faid Principal Officers and Commissioners of Our Navy by fuch Collectors or proper Officers of Our Customs.
