The KING's Most Excellent Majesty in Council.

THEREAS His Majefty was gracioufly pleafed, by His Royal Proclamation, bearing Date the Twenty-fifth Day of March last, to promife and declare, That a Bounty of Three Pounds fhould be paid to every Able Seaman, and of Two Pounds to every Ordinary Seaman, not above the Age of Fifty, nor under the Age of Twenty Years, fit for His Majefty's Service, and a Bounty of Twenty Shillings to all fuch Ablebodied Landmen, not above the Age of Thirtyfive, nor under the Age of Twenty Years, who should, on or before the Thirty-first Day of May then next, voluntarily enter themfelves to ferve in His Majesty's Royal Navy, either with the Captains or Lieutenants of His Majesty's Ships, or Officers employed in Tenders, or at Rendezvous on Shore for railing Men for the Service of His Majefty's Navy. And whereas His Majefty was alfo pleafed, by His Royal Proclamation, bearing Date the Sixth Day of April last, to promise and declare, That a Reward of Twenty Shillings for every Able and Ordinary Seaman should be paid, in the Manner thereby directed, to any Perfon who should discover any Seaman or Seamen who might conceal themfelves, fo that fuch Seaman or Seamen fhould be taken for His Majefty's Service on or before the faid Thirty-first Day of May then next, by any of

His Majesty's Sea Officers appointed to raife Men on Shore, or by the Captains and Commanders of any of His Majesty's Ships or Vessels in the Ports or on the Coafts of this Kingdom. And whereas the Time limited for Payment of the faid Bounties and Rewards is near expiring, and it being judged expedient for His Majesty's Service that the faid Bounties and Rewards should continue to be paid for fome 'Time longer; His Majefty, with the Advice of His Privy Council, doth therefore order, and it is hereby ordered, That the Time limited for Payment of the faid Bounties and Rewards be prolonged and extended from the faid Thirty-first of this inftant May to the Thirtieth Day of June next, inclusive : - Whereof all Perfons concerned are to take Notice, and govern themfelves accordingly. And the Petitioners And the Petitioners further thew, that they are advised, and they truft they can maintain, that the Judgment of the faid Select Committee, reported to the Houfe touching the different Rights of Election contained in the faid Statements, is erroneous; and that the Right of Election which hath been deemed valid in the Judgment of fuch Select Committee is not the Right of Election for the fuid Borough. Therefore, and to prevent the faid Judgment of the faid Select Committee from becoming final and conclusive, the Petitioners pray, that they may be admitted as Parties, according to the Form of the Statute in that Cafe lately made and provided, to oppose that Right of Election in Favour of which the faid Select Committee hath reported as above fet forth, and that they may have fuch further and other Relief in the Premifes as to the House shall seem meet, and the Nature of the Cafe may require. I do hereby give Notice that the Houle has appointed Monday the Twenty-ninth Day of August next, at Three o'Clock in the Afternoon, to take the faid Petition into Con-fideration.
