THE King has been pleased to appoint Mor-ton Eden, Esq; to be His Majesty's Envoy Extraordinary and Minister Plenipotentiary to the Court of Berlin:

The King has been pleased to approve the Ap-pointment of Don Manuel de las Heras to be His Catholick Majesty's Agent and Consul-General in England and Ireland.

St. Petersburg, October 7.

Saturday last being the Birth-Day of His Imperial Highness the Great Duke, the same was observed at Court in the usual Manner; and in the Evening there was a Ball and Illumination.

Monday being the Anniversary of the Coronation of Her Imperial Majesty, was celebrated as usual, and the Court was uncommonly crowded and splendid. It being also the Feast of the Order of St. Volodimir, a Chapter was held, at which Her Imperial Majesty was pleased to confer the Order of the First Class on Count Simon Woronzow, Her Minister at the Court of London.

Berlin, October 21.

Their Royal Highnesses the Duke and Dutchess of York, the Princess of Orange, the Hereditary Prince and Princess of Orange, and the Hereditary Prince

and Princess of Brunswick, set out from hence on the 17th for Brunswick, accompanied by the Prince of Prussia, and Prince Lewis, His Royal Highness's Brother.

Yesterday the King of Prussia promoted M. Strau-zenze to the Rank of Minister of State, and placed him at the Head of the Departments lately held by M. de Werder, comprehending the Excise, Transit and all other Duties, and the Direction of the internal Trade and Manufactures.
