That upon the Statement delivered in by the Counsel for the Sitting Members, the faid Select Committee reported, that they had determined, "That the Right of Election, as fet " forth in the faid Statement, is the Right of Elec-"tion for the faid Borough of Pontefract." That John Walsh, Esquire, and also several other Persons pretending to be Electors of Representatives to serve in Parliament for the said Borough of Pontefract, having presented their respective Petitions to this House to prevent the said Judgment of the said Select Committee from becoming final and conclusive, praying that they might be admitted as Parties, according to the Form of the Statute in that Case made and provided, to oppose that Right of Election, in Favour of which the faid Select Committee had reported as above set forth, and that they respectively might have such further and other Relief in the Premises as to the House should seem meet, and the Nature of their Case might require.
