## Bruffels, May . 25.

This Government has received an Account, that General Sztaray, who had been quartered at Charle-roy, to watch the Movements of M. de la Fayette's Army, having understood that a large Detachment was posted at a Place called Florenne, at no great Distance from Philipville, he resolved to attack it, though his Force was much inferior; M. de Gouvion's Numbers being estimated at Seven Thousand, and those of General Sztaray at but Three. The French, after an obstinate Resistance, in the End gave Way, leaving 150 dead, several wounded, Three Picces of Cannon, and all their Baggage and Ammunition; the Loss of the Austrians was Four killed, and Twenty-two wounded. No more particular Circumstances of this Action are as yet received.
