A PROCLAMATION.
GÉORGE R.

HEREAS divers wicked and seditious Writings have been printed, published, and industriously dispersed, tending to excite Tumult and Disorder, by endeavouring to raife groundless Jealousies and Discontents in the Minds of Our faithful and loving Subjects, respecting the Laws and happy Constitution of Government, Civil and Religious, established in this Kingdom; and endeavouring to vilify and bring into Contempt the wife and wholesome Provisions made at the Time of the Glorious Revolution, and fince strengthened and confirmed by subsequent Laws for the Prefervation and Security of the Rights and Liberties of Our faithful and loving Subjects: And whereas divers Writings have also been printed, published and industriously dispersed, recommending the faid wicked and feditious Publications to the Attention of all Our faithful and loving Subjects: And whereas we have also Reason to believe that ·Correspondencies have been entered into with fundry Persons in Foreign Parts, with a View to forward the criminal and wicked Purpofes above mentioned. And whereas the Wealth, Happiness and Prosperity of this Kingdom do, under Divine Providence, chiefly depend upon a due Submission to the Laws, a just Confidence in the Integrity and Wisdom of Parliament, and a Continuance of that zealous Atrachment to the Government and Constitution of the Kingdom, which has ever prevailed in the Minds of the People thereof: And whereas there is nothing

which We so earnestly desire as to secure the Publick Peace and Prosperity, and to preserve to all Our loving Subjects the full Enjoyment of their Rights and Liberties, both Religious and Civil: We, therefore, being resolved, as far as in Us lies, to repress the wicked and feditious Practices aforefaid, and to deter all Persons from following so pernicious an Example, have thought fit, by the Advice of Our Privy Council, to iffue this Our Royal Proclamation, folemnily warning all Our loving Subjects, as they tender their own Happiness, and that of their Posterity, to guard against all such Attempts, which aim at the Subversion of all regular Government within this Kingdom, and which are inconfiftent with the Peace and Order of Society; and earnestly exhorting them at all Times, and to the utmost of their Power, to avoid and discourage all Proceedings, tending to produce Riots and Tumults; and We do strictly charge and command all Our Magistrates in and throughout Our Kingdom of Great Britain, that they do make diligent Enquiry, in order to discover the Authors and Printers of fuch wicked and feditious Writings as aforefaid, and all others who shall disperse the same: And We do surther charge and command all Our Sheriffs, Justices of the Peace. chief Magistrates in Our Cities, Boroughs and Corporations, and all other Our Officers and Magistrates throughout Our Kingdom of Great Britain, that they do, in their feveral and respective Stations, take the most immediate and effectual Care to supprefs and prevent all Riots, Tumults and other Disorders, which may be attempted to be raised or made by any Person or Persons, which, on whatever Pretext Pretext they may be grounded, are not only contrary I of these Nations, and to destroy that unexampled to Law, but dangerous to the most important Interests of this Kingdom: And We do further require and command all and every Our Magistrates aforefaid, that they do, from Time to Time, transmit to One of Our Principal Secretaries of State, due and full Information of fuch Perfons as shall be found offending as aforefaid, or in any Degree aiding or abetting therein; it being Our Determination, for the Prefervation of the Peace and Happiness of Our faithful and loving Subjects, to carry the Laws vigorously into Execution against such Offenders as aforesaid.

Given at Our Court at the Queen's House, the Twenty-first Day of May, One thousand seven hundred and ninety-two, in the Thirty-fecond Year of Our Reign.

The following Addresses, transmitted to the Right Hon. Henry Dundas, His Majesty's Principal Secretary of State for the Home Department, have been by him presented to the King: Which Addresses His Majesty was pleased to receive very gracioully.

To the KING's Most Excellent Majesty,

The humble Address of the Right Honorable the Lord Provoft, Magistrates and Council of the City of Edinburgh, in Common Council asfembled.

Most Gracious Sovereign,

WE, your Majesty's most dutiful Subjects, the Lord Provoft, Magistrates and Council of this your ancient City of Edinburgh, think themselves called upon, at this Time, to express in the strongest Manner their Zeal and Attachment to the Constitution of their Country, their Loyalty to their Sovereign, and their Gratitude for that warm Manifestation of his fatherly Affection to his People, which is displayed in his late Royal Proclamation:

We should hold ourselves most unworthy to live under that Conflictation which fecures to us the highest Measure of Civil Liberty, and under the Protection of those Laws which guard our Lives, and defend us in the peaceable Enjoyment of our Properties, if we could behold, with supine Indifference, the insidious but alarming Attempts of those Enemies to their Country; who feek to poison the Minds of the People of these Realms, by instilling into their Breaits a Jealouly of that Government, which has no other End but their Happiness; by raising up the Shadows of Grievances which were never felt but in Imagination; and by holding forth to their Eyes the Expediency of Innovations and Amendments of that System, which, once unhinged, the same Spirit of Faction and of Anarchy may, for aught that human

Wisdom can foresee, proceed utterly to Annihilation.
Inconsiderable as may be the Number of those evil-minded Men who disseminate or adopt such Principles, and impotent, as we trust in God, all fuch Attempts shall be, to undermine the Civil Happiness

Political Prosperity which we at this Time enjoy, we beg Leave, Sire, to testify our most fincere and hearty Approbation of those Measures which your Majesty's Wisdom has thought proper to recommend in your Royal Proclamation, with a View to the Suppression of all feditious Writings arraigning the Conflictation and Government of these Realms, as eskablished at the Glorious Revolution, or inculcating Doctrines fubverfive of all Civil Order and Subordination: And with that dutiful Obedience which we owe to the Commands of our Sovereign, when he speaks, as he ever does, the Language of Affection to his Subjects, and of Regard for their Rights and Liberties; and acting under the Authority of those Laws, which, if well understood and properly enforced, are completely effectual for the Maintenance of the Public Peace, it shall be our earnest. Endeavour, in our Capacity of Magistrates, to exercise those Powers with which we are entrusted for the Safety of the Community, and the good Order of all who are within the Limits of our Jurisdiction.

WE, your Majesty's most dutiful and loyal Subjects, beg Leave to express our Gratitude to your Majesty for the Publication of your late Royal Proclamation against seditions and inflammatory Writings, in order to preserve the Peace and Tranquillity of these Kingdoms from the Attempts of wicked and defigning Men.

Highly sensible of the Happiness which we enjoy under the best of Sovereigns, and blessed with a Constitution which is deservedly the Admiration of the Universe, by which the Prince and the Peasant are equally protected from Danger and Oppression, we bend in grateful Homage to Him by whom Kings reign and Princes decree Justice, that we are so, highly favoured among the Nations, while many around us are groaning under Anarchy, Confusion, and Despotism.

May your Majesty long reign over a free and a happy People, and may you be enabled to hand down our Constitution in Church and State unimpaired to latest Posterity.
