HEREAS by an Act, passed in the Twenty-fixth Year of Our Reign, intituled, " An Act for amending and re-" ducing into One Act of Parliament the Laws re-" lating to the Militia in that Part of Great Bri tain " called England," it is enacted, That it shall be lawful for Us, in the Cafes and in Manner therein mentioned, the Occafion being first declared in Council and notified by Proclamation, if no Parliament shall be then fitting, to order and direct the Drawing out and Embodying of Our Militia Forces, or any Part thereof: And whereas We have received Information, that in Breach of the Laws, and notwithflanding Our Royal Proclamation of the Twenty-first Day of May last, the utmost Industry is still employed by evil-difpofed Perfons within this Kingdom, acting in Concert with Perfons in Foreign Parts, with a View to fubvert the Laws and eftablished Conflitution of this Realm, and to deftroy all Order and Government therein; and that a Spirit of Tumult and Diforder, thereby excited, has lately shewn itself in Acts of Riot and Infurrection. And whereas, under the prefent Circumstances, it is more particu-'larly necessary, that, for the immediate Suppression of fuch Attempts, fomé Addition should be made, as the Exigency of the Cafe may require, to the Force which may be in Readinefs to act for the

Support of the Civil Magiftrate; We therefore, being determined to exert the Powers vefted in Ue by Law for the Protection of the Perfons, Liberties and Properties of Our faithful Subjects, and fully relying on their Zeal and Attachment to Our Perfon and Government, and to the happy Conflitution eftablished in these Kingdoms, have thought fit to declare in Our Council Our Royal Intention, for the Caufes and on the Occasion aforefaid, to draw out and embody such Part of Our Militia Forces as may more immediately enable Us to provide for the faid important Objects. And We do hereby, in purfuance of the faid recited Act, notify to all Our loving Subjects Our faid Intention, and the Caufes and Occasion thereof.

That whenever We shall cause the Militia to be drawn out and embodied, on the Occafions and in the Manner therein mentioned, if the Parliament shall then be separated by such Adjournment or Prorogation as will not expire within Fourteen Days, We may and shall iffue Our Proclamation for the Meeting of the Parliament within Fourteen Days; and the Parliament shall accordingly meet and fit upon fuch Day as shall be appointed by fuch Proclamation, and continue to fit and act in like Manner, to all Intents and Purpoles, as if it had flood adjourned or prorogued to the fame Day : And whereas We have thought fit, in purfuance of the faid Act, this Day to declare in Our Council, certain Caufes and Occafions moving Us to order and direct, that fuch Part of Our Militia Forces, as may more immediately enable Us to provide for the important Objects therein mentioned, should be drawn out and embodied : And whereas, in purfuance of the faid recited Act, We have thought fit on this Day to iffue Our Royal Proclamation, notifying the Caufes and Occafions fo declared in Council as aforefaid : And whereas Our Parliament now flands prorogued to Thursday the Third Day of January next; We therefore, by the Advice of Our Privy Council, do hereby publifh and declare Our Royal Will and Pleafure, That Our faid Parliament shall, on Thursday the Thirteenth Day of this inftant December, be held for the Difpatch of divers weighty and important Affairs. And the Lords Spiritual and Temporal, and the Knights, Citizens and Burgeffes, and the Commiffioners for Shires and Burghs of the Houfe of Commons, are hereby required to give Attendance accordingly at Westminster on the faid Thirteenth Day of December.

For encouraging Seamen and Landmen to enter themfelves on Board His Majefty's Ships of War.

THEREAS it is Our Royal Intention to give all due Encouragement to all fuch Seamen and Landmen who fhall voluntarily enter themfelves in Our Service; We have thought fit, by and with the Advice of Our Privy Council, to publish this Our Royal Proclamation: And We do hereby promise and declare, 'That all such Able Seamen, not above the Age of Fifty, nor under the Age of Twenty Years, fit for Our Service, who shall, on or before the Thirty-first Day of this instant December, voluntarily enter themfelves to ferve in Our Royal Navy, either with the Captains or Lieutenants of Our Ships or Veffels, or Officers employed on Shore for raising Men for the Service of Our Navy, shall receive, as Our Royal Bounty, the Sum of Three Pounds each Man; and all fuch Ordinary Seamen, fit for Our Service, who shall fo enter themfelves as aforefaid, shall receive the Sum of Two Pounds each Man; and all fuch Able-bodied Landmen, not above the Age of Thirty-five, nor under the Age of Twenty Years, who shall fo enter themfelves as aforefaid, shall receive the Sum of Twenty Shillings each Man, as Our Royal Bounty; fuch respective Sums to be paid them by the respective Clerks of the Checque refiding at the Ports where the Ships or Veffels, on Board which fuch Seamen and Landmen may be appointed to ferve, shall be, immediately after the Third Mufter of fuch Seamen and Landmen : And We do declare, That the Qualifications of the Seamen and Landmen, fo entering themfelves, shall be certified by the Captain, Master and Boatfwain of the Ship or Veffel on Board which they shall be appointed to ferve. And for Prevention of any Abufes by any Perfons leaving the Veffels to which they shall belong, and entering themfelves on Board any other Our Ships or Veffels, in order to obtain the faid Bounty Money, We do hereby declare and command, That fuch Seamen and Landmen belonging to any of Our Ships or Veffelsz

Veffels, as fhall abfent themfelves from any of the faid Ships or Veffels to which they fhall belong, and fhall enter themfelves on Board any other of Our faid Ships or Veffels, in order to obtain the faid Bounty, fhall not only lofe the Wages due to them in the Ships or Veffels they fhall leave, but also be punished according to their Demerits.
