A PROCLAMATION,

For Encouraging Seamen and Landmen to enter themfelves on Board His Majefly's Ships of War.

GEORGE R.

HEREAS it is Our Royal Intention to give all due Encouragement to all fuch Seamen and Landmen who shall voluntarily enter themfelves in Our Service ; We have thought fit, by and with the Advice of Our Privy Council, to publifh this Our Royal Proclamation : And we do hereby promife and declare, That all fuch Able Seamen, not above the Age of Fifty nor under the Age of Twenty Years, fit for Our Service, who shall, on or before the Twenty-eighth Day of February next, voluntarily enter themfelves to ferve in Our Royal Navy, either with the Captains or Lieutenants of Our Ships or Vefiels, or Officers employed on Shore for raifing Men for the Service of Our Navy, fhall receive, as Our Royal Bounty, the Sum of Five Pounds each Man; and all fuch Ordinary Seamen, fit for Our Service, who shall to enter themselves as aforefaid, shall receive the Sum of Two Pounds Ten Shillings each Man; and all fuch Able-bedied Landmen, not above the Age of Thirty-five nor under the Age of Twenty Years, who shall so enter themselves as aforefaid, shall receive the Sum of Thirty Shillings cach Man, as our Royal Bounty, Sa Lieu of the Bounties promised in Our Royal Pro-

clamation dated the First Day of this instant December; fuch respective Sums to be paid them by the respective Clerks of the Checque refiding at the Ports where the Ships or Veffels on Board which fuch Seamen and Landmen may be appointed to ferve, shall be, immediately after the Third Muster of fuch Seamen and Landmen : And We do declare, That the Qualifications of the Seamen and Landmen fo entering themfelvrs shall be certified by the Captain, Master and Boatswain of the Ship or Vessel on Board which they shall be appointed to ferve : And for Prevention of any Abufes, by any Perfons leaving the Veffels to which they shall belong, and entering themfelves on Board any other Our Ships or Veffels, in order to obtain the faid Bounty Money, We do hereby declare and command, That fuch Seamen and Landmen belonging to any of Our Ships or Vessels, as shall absent themselves from any of the faid Ships or Veffels to which they shall belong, and shall enter themselves on Board any other of Our faid Ships or Vessels, in order to obtain the faid Bounty, shall not only lofe the Wages due to them in the Ships or Vessels they shall leave, but also be punished according to their Demerits.

Given at Our Court at St. James's, the Twentys fixth Day of December, One thousand feven hundred and ninety-two, and in the Thirtys third Year of Our Reign.

The KING's Most Excellent Majesty in Council.

HEREAS by an Act paffed in the Twentyeighth Year of the Reign of His prefent Majefty, intituled, " An A& for regulating the Trade * between the Subjects of His Majefty's Colonies " and Plantations in North America and in the 44 West India Islands, and the Countries belonging 55 to the United States of America, and between 44 His Majefty's faid Subjects and the Foreign Islands " in the West Indies," it is, amongst other Things, enacted, That it shall and may be lawful for His Majeity in Council, by Order or Orders to be iffued and published from Time to Time, to authotize, or by Warrant or Warrants, under His Sign Manual, to impower the Governor of Newfoundland for the Time being to authorize, in cafe of Necefficy, the Importation into Newfoundland of Bread, Flour, Indian Corn, and Live Stock, from any of the Territories belonging to the faid United States, for the Supply of the Inhabitants and Fishermen of the Island of Newfoundland, for the then enfuing Seafon only; provided always, that fuch Bread, Flour, Indian Corn, and Live Stock, fo authorized to be imported into the Island of Newfoundland, shall not be imported except in conformity to fuch Rules, Regulations and Reffrictions as shall be specified in such Order or Orders, Warrant or Warrants, respectively, and except by British Subjects and in British-built Ships owned by His Majefty's Subjects, and navigated according to Law. And whereas it is expedient and neceffary that Provision be made for fully supplying the Inhabitants and Fishermen of the Island of Newfoundfand, for the enfuing Seafon, with Bread, Flour, and Indian Corn; His Majesty doth thereupon, by and with the Advice of His Privy Council, hereby order and declare, That, for the Supply of the Inhabitants and Fishermen of the Island of Newfoundland, for the enfuing Seafon only, Bread, Flour and Indian Corn be imported into the faid Island from any of the Territories belonging to the faid United States, by British Subjects, and in British-built Ships owned by His Majefty's Subjects, and navigated according to Law, and which shall, within the Space of Seven Months previous to the Time of fuch Importation, have cleared out from some Port in Great Britain, or fome other Port of His Majesty's Dominions in Europe, for which Purpole a Licence shall have been granted by the Commissioners of His Majefty's Cuftoms in England or Scotland, or whe Commissioners of His Majesty's Revenue in Ire-

duly authorized in that Kingdom respectively, in the Manner and Form herein after mentioned ; which Licences shall continue and be in Force for Seven Calendar Months from the Day of the Date upon which they are respectively granted, and no longer; provided that no fuch Licence as aforefaid, granted after the Thirtieth Day of June, One Thouland Seven Hundred and Ninety-three, shall be of any Force or Effect : And His Majefty is hereby further pleased to order. That the Master, or Perfort having the Charge or Command of any Ship or Veffel to whom fuch Licence shall be granted, shall, upon the Arrival of the faid Ship or Veffel at the Port, Harbour or Place in the Island of Newfoundland where he shall discharge such Bread, Flour, or Indian Corn, deliver up the faid Licence to the Collector or other proper Officer of the Cuftoms there, having first indorfed on the Back of fuch Licence the Marks, Numbers and Contents of each Package of Bread, Flour, or Indian Corn, under the Penalty of the Forfeiture in the faid A& mentioned. . And the Collector or other proper Officer of the Cuftoms at Newfoundland is hereby enjoined and required to give a Certificate to the Masler, or Performand of fuch Ship or Veffel, of his having received the faid Licence, for indorfed as before directed, and to tranimit the fame to the Commissioners of His Majesty's Customs in England or Scotland, or to the Commissioners of His Majesty's Revenue in Ireland, respectively, by whom fuch Licence was granted.

Now be it known that the faid [Perfon's Name] hath Licence to lade on board the faid Ship [Ship's Name], at and from any Port or Place belonging to the United States of America, Bread, Flour, and Indian Corn, the Produce of the faid United States, and no other Article whatfoever, and to carry the faid Bread, Flour and Indian Corn to fome Port or Place on the Island of Newfoundland; and on the Arrival of the faid Ship at any Port, Harbour, or Place of Discharge in Newfoundland, the Master, or Person having the Charge or Command of the faid Ship, is required and enjoined to deliver up the faid Licence to the Collector or other proper Officer of His Majefty's Cuftoms there; and to indorfe on the Back thereof the Marks, Numbers, and Contents of each Package of Bread, Flour, or Indian Corn, and shall thereupon receive a Certificate thereof from the faid Collector or other proper Officer of the Cultoms.

SECTION XVII. And whereas great Loffes and Inconveniencies have arifen to the Public, by Sub-Accountants not having been put in Charge till a long Time has elapfed after the Monies were iffued to them, be it enacted, That the Paymafter-General of His Majefty's Forces, the Treasurer of the Navy, the Treasurer of the Ordnance, and every other Public Officer who shall hereafter pay into the Hands of any Perfon or Perfons whomfoever, Money for Public Services, by Way of Imprest or on Account, shall, within Thirty Days of the 31st Day of December, One thousand seven hundred and eighty-five, and within Thirty Days of the 31st Day of December in every future Year, tranfmit an Account of all Sums of Money iffued or paid by him or them to any Perfon or Perfons, for the Public Service, within the preceding Year, to the Committioners to be appointed under the Authority of this Act; who shall, and they are -hereby required forthwith to transmit Duplicates of the fame to His Majesty's Remembrancer in the -Court of Exchequer, who shall immediately, :on, Receipt of fuch Accounts, put the feveral Sums fo. -iffued in Charge against the Parties, in like Man--ner as is now practifed with respect to Perfons who -receive Money by Way of Imprest, and on Ac--count, at the Receipt of His Majesty's Ex-.chequer.

SECTION XVIII. Provided always, and be it enacted, That no Accountant shall be allowed in his Account any Sum which he shall issue or pay over to any Sub-Accountants, unless he shall have transmitted to the faid Commissioners regular Accounts thereof, in the Manner and within the Times abovementioned; unless Proof shall be produced, to the Satisfaction of the Lord High' Treasurer, or the Commissioners of the Treasury, that any Failure of transmitting the fame did not happen from the wilful Neglect of the Perfor iffuing or paying over the Money as aforefaid. SECTION XX. And be it further enacted and declared, That every Sub-Accountant to whone

Money shall hereafter be issued for Public Services, in cafe the Money fo iffued shall have been for Services to be performed in Great Britain, shall deliver into the Office of the Commissioners to be appointed by virtue of this Act, the Vouchers for the Expenditure thereof, together with an Account Current, within Three Months of the End of each Year from the Commencement of his Account, unlefs it has been usual for fuch Account to be made up to any fixed Period in the Year; in which Cafe they shall be delivered within Three Months of the usual annual Time of the Determination of each Account respectively; and in cale such Monies shall have been issued for Services to be performed in any Part of Europe out of this Kingdom, them the Vouchers shall be delivered within Four Months of the Expiration of each Year's Ac-counts; if in the Weil Indies, the Continent of America, or in Africa, within Six Months after the Expiration of each Year's Accounts; and if in the East Indies, within Twelve Months after the Expiration of each Year's Accounts; unlefs it shall in each and every Cafe be made appear to the Sa-tisfaction of the Commillioners of the Treasury, that the Failure of transmitting the fame, within the Periods beforementioned, was unavoidable; in which Cafe fuch further Delay may be granted by Warrant under the Hands of the Commissioners of the Treasury, or any Three of them, as they shall judge reafonable; and in fuch Cafes the Vouchers shall be delivered at the Expiration of the Term of Delay to granted, on Pain, upon Failure in any of the abovementioned Cafes, of paying fuch Fine to His Majefty as the Court of Exchequer, on Application made to them, shall think fit to fer and impose; which Fine the faid Court is hereby authorized and impowered to fet and impose act -cordingly.

SECTION XXII. Provided always, and be it enacted, that when any Sub-Accountant or Sub-Accountants shall transmit to the Commissioners, to be appointed under the Authority of this Ad, a fufficient and fatisfactory Discharge from the Principal Officers of the Ordnance, the Commiffioners of His Majefty's Navy, the Commiffioners for Victualling His Majefty's Navy, or the Commillioners for Sick and Hurt, for any Monles he or they shall have received in the faid Departments feverally, the faid Commissioners shall transmit .
