PRESENT,
The KING's Most Excellent Majesty in Council.

HEREAS divers injurious Proceedings have lately been had in France in derogation of the Honour of His Majesty's Crown, and of the just Rights of His Subjects: And whereas several unjust Seizures have been there made of the Ships and Goods of His Majesty's Subjects, contrary to the Law of Nations, and to the Faith of Treaties: And whereas the faid Acts of unprovoked Hostility have been followed by an open Declaration of War against His Majesty, and His Ally the Republick of the United Provinces; His Majesty, therefore, being determined to take such Measures as are necessary for vindicating the Honour of His Crown, and for procuring Reparation and Satisfaction for His injured Subjects, is pleased, by and with the Advice of His Privy Council, to order, and it is hereby ordered, that General Reprizals be granted against the Ships, Goods and Subjects of France, fo that as well His Majesty's Fleet and Ships, as also all other Ships and Vessels that shall be commissionated by Letters of Marque or General Reprizals, or otherwise, by His Majesty's Commissioners for executing the Office of Lord High Admiral of Great Britain, shall and may lawfully seize all Ships, Vessels and Goods belonging to France, or to any Persons being Subjects of France, or inhabiting within any of the Territories of France, and bring the same

within His Majesty's Dominions; and to that End His Majesty's Advocate-General, with the Advocate of the Admiralty, are forthwith to prepare the Draught of a Commission, and present the same to His Majesty at this Board, authorizing the Commissioners for executing the Office of Lord High Admiral, or any Person or Persons by them empowered and appointed, to iffue forth and grant Letters of Marque and Reprizal to any of His Majesty's Subjects, or others whom the said Commisfioners shall deem fitly qualified in that Behalf, for the apprehending, seizing and taking the Ships, Vessels and Goods belonging to France, or to any Perfons being Subjects of France, or inhabiting within any of the Territories of France; and that fuch Powers and Clauses be inserted in the said Commission as have been usual and are according to former Precedents: And His Majesty's faid Advocate-General, with the Advocate of the Admiralty, are also forthwith to prepare the Draught of a Commission, and present the same to His Majesty at this Board, authorizing the faid Commissioners for executing the Office of Lord High Admiral to will and require the High Court of Admiralty of Great Britain, and the Licutenant and Judge of the faid Court, his Surrogate or Surrogates, as also the several Courts of Admiralty within His Majesty's Dominions, to take Cognizance of, and judicially proceed upon, all and all Manner of Captures, Seizures, Prizes and Reprizals of all Ships and Goods that are or shall be taken,

and to hear and determine the fame, and according to being judged expedient for His Majesty's Service that the Course of Admiralty, and the Laws of Nations, to adjudge and condemn all fuch Ships, Vessels and Goods as shall belong to France, or to any Persons being Subjects of France, or inhabiting within any of the Territories of France; and that such Powers and Clauses be inserted in the said Commission as have been usual, and are according to former Precedents: And they are likewise to prepare, and lay before His Majesty at this Board, a Draught of such Instructions as may be proper to be sent to the Courts of Admiralty in His Majesty's Foreign Governments and Plantations, for their Guidance herein; as also another Draught of Instructions for such Ships as shall be commissionated for the Purposes aforementioned. The KING's Most Excellent Majesty in Council. THEREAS His Majesty was graciously pleafed, by His Royal Proclamation, bearing Date-the Twenty-fixth Day of December last, to promife and declare, that the Bounties of Five Pounds for every Able Seaman and Two Pounds Ten Shillings for every Ordinary Seaman, fit for His Majesty's Seavice, should be paid, in the Manner thereby directed, to every fuch Able and Ordinary Seaman, not above the Age of Fifty, nor under the Age of Twenty Years, who foodld, on or before the Twentyeighth Day of February then following, enter themselves to serve in His Majesty's Royal Navy, either with the Captains or Licutenants of His Majesty's Ships or Vestels, or Officers employed on Shore for raifing Men for the Service of the Royal Navy: And whereas His Majesty was also graciously pleased, by His faid Proclamation, to declare, That all Ablebodied Landmen, not above the Age of Thirty-five, nor under the Age of Twenty Years, who should so enter themselves as aforesaid, should receive the Sum of Thirty Shillings each Man as His Majesty's Royal Bounty. And whereas the Time limited for Payment of the said Bounties is near expiring, and it

the faid Bounties should be continued to be paid for some Timelonger, His Majesty, with the Advice of His Privy Council, doth therefore order, and it is hereby ordered, that the Time limited for Payment of the faid Bounties be prolonged and extended from the faid Twenty-eighth Day of this instant February to the Thirtieth Day of April next inclusive:-Whereof all Persons concerned are to take Notice. and govern themselves accordingly.

T is this Day ordered, by His Majesty in Coun-L cil, that all Packet-Boats and Bye-Boats, whether British or French, employed in the Conveyance of Letters and Passengers between this Country and France, or the Countries occupied by the Armies of France, be permitted to pass and repass, as heretofore, with their respective Complements of Men, and that such French Packets or Bye-Boats as may now be within any of the Ports, Harbours or Roads of this Kingdom, into which it has been usual for such French Packets or Bye-Boats to come, be notdetained, notwithstanding any Thing contained in His Majesty's Order in Council, of the 4th of this Instant February, for preventing Ships or Vessels belonging to any of His Majesty's Subjects to enter and clear out for any of the Ports of France, or for the Ports of any Country occupied by the Armies of France, and for Ropping all French Ships and Veffels whatever now within, or which shall hereafter come into, any of the Ports, Harbours or Roads within the Kingdom of Great Britain, together with all Persons and Effects on Board the said Ships and Vessels. And the Right Honourable the Lords Commissioners of His Majesty's Treasury, the Lords Commissioners of the Admiralty, and the Lord Warden of the Cinque Ports, are to give the necessary Directions herein as to them may respectively appertain. But the Commissioners trust, that, by these Regulations, and by the published Natices from the Lord Mayor and and by the published Notices from the Lord Mayor and the Court of Aldermen, as well as from the Chairman and the Magistrates for Westminster and the County of Middlesex; and likewise from the Magistrates of the Police, of a perfect Co-operation with this Office, the only remaining Abuse that has attached on the State Lotteries will be us totally suppressed as the Sale of illegal Chances, which is completely at an End.
