PARDONING DESERTERS.

War-Office, February 26, 1793.

HEREAS it has been represented to the King, that there are at this Time feveral Deferters from the different Regular Corps in His Majesty's Land Service, who might be induced to return to their Duty by an Offer of His Majesty's gracious Pardon; and that fuch an Instance of His Royal Clemency would have a due Influence upon their future Behaviour; His Majesty has been graciously pleased, by His Order in Council, to grant His free Pardon to all Deferters from His Regular Land Forces, who shall surrender themselves, on or before the 30th of April next, to the Corps from which they originally deferted; but if such Corps be not within this Kingdom, they shall then be entitled to the like Pardon, on Condition of furrendering to any other Regular Corps in His Majesty's Land Service, or to any Recruiting Party thereof in Great Britain or Ireland.

Such Deferters, if Able-bodied Men and fit for Service, shall be attested in the Corps to which they surrender, and not be liable to be claimed by any other Corps to which they may formerly have belonged, unless it shall appear that such other Corps, or some Part thereof, was actually in Great Britain at the Time of their surrendering.

And whereas many of the faid Deferters may have enlisted in other Corps, and are now ferving therein, His Majesty is graciously pleased to extend to such Deferters the Benefit of this Pardon, and to direct, that they shall continue to serve in the Corps wherein they now are, without being under the Necessity of declaring themselves Deserters in order to entitle them to the Benefit of this Pardon; and they shall not be liable at any future Time to be claimed by that in which they sormerly served; Deserters from the Royal Regiment of Artillery, or Corps of Royal

Military,

Military Artificers and Labourers excepted; who, if | and the Prefervation of the glorious Conflictution of ferving in other Corps, are only to be entitled to the Benefit of this Pardon upon Condition of declaring themselves Deserters from, and of returning to, the Corps under the Department of the Ordnance to which they originally belonged; and, not so declaring themselves, they shall be liable at any future Time to be claimed by the faid Corps, and punished as Deferters.

And whereas several of the said Deserters have been apprehended and are now in Gaol, or in Regimental Custody, His Majesty is likewise pleased to grant them His free Pardon, of which they are to have the Benefit upon their Arrival at their own Corps, or upon their being enlisted by some other Corps or Recruiting Party, according as their respective Cases may be, and in Conformity to the Conditions herein before set forth.

Any Soldier, who may have deferted fince the First of this instant February, shall not be included in the above Pardon, but be proceeded against with the utmost Severity.

On the 21st Instant a French Ship of the Line, and a Bomb-Ketch, appeared before the Island of St. Peter, which was immediately furrendered to the French, the Commandant having previously retired to this Place with a Detachment of 800 Men, and fuch Provisions as they could bring with them, and

The French

fpiked the Cannon they left behind. have also taken the Island of Antioch.

Yesterday the French Fleet, confisting of 19 Ships of the Line, anchored in this Harbour. The Ad miral fent a Detachment of 20 Men on Shore with the National Flag, and an Officer, who demunded the Surrender of the Place; but the Lieutenant of the Port cautioned them not to advance; and when they arrived near the Pratick House, the Sardes killed the Drummer and 16 others: The rest retreated to the Ship. It is expected that the Town will be bombarded this Mornings

Charleston, January 15.

The Legislation of this State passed a Law on the zift Ultimo, prohibiting the Importation of Negroes thereinto, for the Period of Two Years from the 1st of the present Month, when the last prohibitory Act expired.

Munich, February 17.

Accounts are just received of the Duke of Deuxponts's very narrow Escape from an Army of 3,000 French, who have taken Possession of his Residence of Carlsberg, near Deuxponts. His Serene Highness received Intelligence of their Approach on the Evening of the 9th Instant from one of his Peasants, and had but just Time to escape, with the Dutchess and the Ladies of her Court. The French took Possession within an Hour afterwards, and have plundered that very costly Residence. The Duke and Dutchess arrived safe at Manheim the following Day.
