The KING's Most Excellent Majesty in Council.

THEREAS the Time limited by His Majefty's Order in Council of the 7th of December, 1792, for prohibiting the Exporting out of this Kingdom, or carrying Coaftwife, Gunpowder or Saltpetre, or any Sort of Arms or Ammunition, expired upon the 7th Day of this inflant June: And whereas it is judged expedient for His Majesty's Service, and the Safety of this Kingdom, that the faid Prohibition should be continued for fome Time longer; His Majesty doth therefore, by and with the Advice of His Privy Council, hereby order, require, prohibit and command, that no Perfon or Perfons whatfoever (except the Master General of the Ordnance for His Majesty's Service) do, at any Time during the Space of Six Months, to commence from the faid 7th Day of this inftant June, prefume to transport, into any Parts out of this Kingdom, or carry Coaftwife, any Gunpowder or Salt Petre, or any Sort of Arms or Ammunition, or thip or lade any Gunpowder or Salt Petre, or any Sort of Arms or Ammunition, on Board any Ship or Veffel, in order to transporting the same into any Parts beyond the Seas, or carrying the fame Coaftwife, without Leave or Permission in that Behalf first obtained from His Majesty, or His Privy Council, upon Pain of incurring and fuffering the respective Forfeitures and Penalties inflicted by an Act paffed in the Twentyninth Year of His late Majetty's Reign, intituled, " An Act to impower His Majesty to prohibit the " Exportation of Salt Petre, and to enforce the " Law for impowering His Majesty to prohibit the " Exportation of Gunpowder, or any Sort of Arms " or Ammunition; and also to impower His Ma-" jefty to reftrain the carrying Coaftwife of Salt " Petre, Gunpowder, or any Sort of Arms or Am-" munition :-- And the Lords Commillioners of His Majefty's Treafury, the Commissioners for executing the Office of Lord High Admiral of Great Britain,

the Lord Warden of the Cinque Ports, the Maffer General of the Ordnance, and His Majefty's Secretary at War, are to give the necessary Directions herein, as to them may respectively appertain.
