X7HEREAS His Majefty was gracioully pleafed, by His Royal Proclamation, bearing Date the Twenty-fixth Day of December laft, to promise and declare, that the Bounties of Five Pounds for every Able Seaman, and Two Pounds Ten Shillings fo every Ordinary Seaman, fit for His Majesty's Service, should be paid in the Manner thereby directed to every fuch Able and Ordinary Seaman, not above the Age of Fifty nor under the Age of Twenty Years, who should, on or before the Twenty-eighth Day of February then following, enter themfelves to ferve in His Majesty's Royal Navy, either with the Captains or Lieutenants of His Majelly's Ships or Veffels, or Officers employed on Shore for raifing Men for the Service of the Royal Navy: And whereas His Majefty was also graciously pleased, by His faid Proclamation, to declare, that all Able-bodied Landmen, not above the Age of Thirty five nor under the Age of Twenty Years, who should fo enter themselves as aforefaid, should receive the Sum of Thirty Shillings each Man, as His Maiefty's Royal Bounty; And whereas His Majefty was also graciously pleased, by His Royal Proclamation, bearing Date the Sixteenth Day of the

AT the Court at St. James's, the 21st of June, | faid Month of February last, to promise and declare, that a Reward of Twenty Shillings for every Able and Ordinary Seaman, fit to ferve on board His Majesty's Ships, should be paid to any Perfon who should discover any Seaman or Seamen who might conceal him or themfelves, fo that fuch Seaman or Seamen should be taken for His Majefty's Service, on or before the Thirtieth Day of April then next, by any of His Majefty's Sea Officers appointed to raife Men on Shore, or by the Captains and Commanders of any of His Majesty's Ships or Vessels in the Ports, or on the Coafts of this Kingdom: And whereas the Time limited by the faid Proclamations for Payment of the faid Bounties and Reward, hath been prolonged and extended to the Thirtieth Day of this initant June: And it being judged expedient for His Majefty's Service that the faid Bounties and Reward should be continued to be paid for fome Time longer; His Majesty, with the Advice of His Privy Council, doth therefore order, and it is hereby accordingly ordered, that the Time limited for Payment of the faid Bounties and Reward be prolonged and extended from the faid Thirtieth Day of this inftant June to the Thirtyfirst Day of August next, inclusive: Whereof all Perfons concerned are to take Notice, and govern themfelves accordingly.

The KING's Most Excellent Majesty in Council. THEREAS by an Act, paffed in the laft Seffion of Parliament, intituled, " An Act to \* amend an Act made in the Thirty-first Year of the " Reign of His present Majesty, intituled, An Act 44 for regulating the Importation and Exportation of " Corn, and the Payment of the Duty on Foreign " Corn imported, and of the Bounty on British Corn " exported," it is, amongst other Things, enacted, That it shall and may be lawful for His Majesty, His Heirs and Succeffors, and He and They is and are thereby authorized, with Advice of His or Their Privy Council, at any Time when the General Average Price of any Sort of Corn or of Oatmeal, in England or Scotland respectively, taken as in the faid Act paffed in the laft Seffion of Parliament is directed, shall appear to be at or above the Price at or above which Foreign Corn, Meal or Flour of the fame Sort is allowed by Law to be imported from Ireland or the Province of Quebec, or the other Britifh Colonies and Plantations in North America, at the first Low Duties specified in the Table marked E. in the faid Act paffed in the Thirty-first Year of His prefent Majesty's Reign, to prohibit generally, for a limited Time, the Exportation from England and Scotland respectively, as the Case may be, of any fuch Sort of Corn or other Articles mentioned in the faid Acts; and in like Manner, at any Time when the Average Price of any Sort of Corn or of Oatmeal, in England or Scotland respectively, taken as in the faid Act, paffed in the last Session of Parliament, is directed, shall appear to be at or above the Price at or above which Foreign Corn, Meal or Flour of the fame Sort is allowed by Law to be imported from any other Foreign Country at the first Low Duty specified in the faid Table marked E. to permit generally the Importation into England or Scotland respectively, as the Cafe may be, or the taking out of Warehouse for Home Confumption, of any fuch Sort of Foreign Corn, Meal or Flour, on Payment of the fecond Low Duty only, and no other ; and in the like Manner to recal fuch Prohibition or Permission, if Circumstances shall appear so to require : Provided always, that as often as the Importation of any Sort of Corn, Meal or Flour, on the Low Duties, shall be permitted by His Majesty, His Heirs or Successors, by and with the Advice of His or Their Privy Council, fuch Permiffion shall continue in Force for the Space of Three Months at

His Majesty, nevertheless, by the Advice aforesaid, hath thought fit to order, and it is hereby ordered, that nothing herein contained shall extend, or be conftrued to extend, to prohibit the Exportation from England of any Foreign Wheat, Rye, Peas, Beans, Barley, Beer or Bigg, or Oats, nor of any Meal, Flour, Malt, Bread or Bifcuit made thereof, nor from Scotland of any Foreign Barley, Beer or Bigg, Peas, Beans or Qats, or any Meal, Flour, Malt, Bread or Biscuit made thereof, that shall have been imported, and shall be warehoused in Manner and on the Conditions mentioned in the faid Act paffed in the Thirty-first Year of His prefent Majesty's Reign, nor to prevent the carrying Coaftwife, (except as is hereinafter excepted) or carrying out, or the Exportation of the faid feveral Sorts of Corn or other Articles as aforefaid, from England and Scotland refpectively, for any of the Purpofes mentioned in either of the faid Two Acts, in like Manner, and in the fame Proportions and Quantities, and from and to the fame Ports and Places, as is by the faid Acts allowed, at fuch Times as any of the feveral Sorts of Corn, or other Articles before mentioned, are prohibited to be exported, by reafon of the Price of fuch Sort of Corn or of Oatmeal being at or above the Prices mentioned in Table B. in the faid AS passed in the Thirty-first Year of His present Majefty's Reign, contained, fubject to the like Securities, Conditions, Regulations and Reftrictions, Forfeitures and Penalties, as are in either of the faid Two Acts, or by any other Act now in Force, in any fuch Cafe required and imposed ; nor to prohibit the Exportation of fuch Corn, or other Articles as aforefaid, which shall have been entered Outwards, and fhall have been actually fhipped or laden on board, or fo much thereof expressed in fuch Entry, as shall have been to thipped or laden on board at the Time of the Date of this prefent Order, in the fame Manner as if this Prohibition to export had not been made.

Provided, neverthelefs, that any fuch Corn, or other Articles as aforefaid, shall not be permitted to be carried Coastwife, or to be otherwife carried from any Port, from which the Exportation thereof is not, at the Time of Shipping the fame, allowed by Law, and be landed and unfhipped at any other Port from which the fame may then be legally exported.

And His Majefty, by and with the Advice aforefaid, hath thought fit further to order, and it is hereby

Order, until the Thirty-first Day of August, 1793. it shall be lawful to import into any Port or Place in that Part of Great Britain called England, and to take out of Warehoufe, for Home Confumption, any Foreign Wheat, Wheat Meal or Flour, Rye, Peas, Beans, Barley, Beer or Bigg, Oats or Oatmeal, and alfo to import into any Port or Place in that Part of Great Britain called Scotland, and to take out of Warehoufe, for Home Confumption, any Foreign Barley, Peas, Oats and Oatmeal, on Payment of the fecond Duty only, mentioned in the faid Table. marked E. and no other.

And the Right Honourable the Lords Commiffioners of His Majefty's Treafury are to give the necessary Directions herein accordingly.
