# From Saturday August 24, to Tuelday August 27, 1793.

Whiteball, August 27, THE Difpatch, of which the following is an Extract, was this Morning received at the Office of the Right Honorable Henry Dundas, His Majesty's Principal Secretary of State for the Home Department.

Camp near Dunkirk, August 24, 1793.

SIR, Have the Honor to inform you, that His Royal Highnels marched from Furnes, upon the Evening of the 22d, with the belieging Army, in order to attack the Camp of Ghivelde and approach the Town of Dunkirk. He advanced in Three Columns, the Cavalry along the Strand, a Column of Infantry upon the Road which leads by the Canal directly upon Ghivelde, and a third to the Left. The advanced Posts of the Enemy were driven back, with the Lofs of Two or Three Men wounded; and, Night coming on, the Enemy halted within a fhort Distance of the Village of Ghivelde. The Enemy abandoned their Camp in the Night: They afterwards quitted a Redoubt in which they left Four Iron Guns, and the Army took up its Ground within 2 League of the Town. There was a great deal of Firing in the Evening at the advanced Pofts in the Gardens' and Enclosures, which are in Front of the Camp and upon the Dunes, in which the Regiment of Starray and O'Donnel (Auftrian) have had upwards of 50 Men killed and wounded; the Enemy were driven back, and this Morning every

nearer to the Town, and take up the Ground which it is to occupy during the Siege.

The Enemy have made an Opening in the Dyke of the Canal between Dunkirk and Bergues, by which Means they can inundate a great Part of the Country from the Sea. The Inundation made confiderable Progrefs Yesterday, but it made little in the Night.

I am happy to inform you that Field-Marshal Freytag has taken 'Two of the Enemy's Posts, with Four Pieces of Cannon and 60 Priloners, with very little Loss.

It is not in my Power to give a more detailed Account of the Succeffes of this Army. The Field-Marshal will transmit an Account of his Operations' as soon as his other important Occupations' will permit.

It is faid that the Enemy are fending confiderable Reinforcements from Lifle to the Camp at Caffel.

And whereas it hath been reprefented, on Behalf of the principal Importers and Venders of Bar-Iron in the City of London, that great Lofs and Inconvenience will refult to the Trade, by the Exportation of Bar-Iron continuing to be prohibited to Countries in Amity with His Majefty, without special Orders being obtained for that Purpofe : His Majefty, taking the fame into Confideration, is pleased, with the Advice of His Privy Council, to order, (as it is hereby ordered) That from and after the Date hereof, the Exporration of Bar-Iron and Pig-Iron fhall, notwithflanding the faid Orders, be permitted and allowed from any of the Ports of this Kingdom to any Country, in or out of Europe, in Amity with His Majesty, in British-built Ships, owned by His Majefty's Subjects, and navigated according to Law; provided the Merchant Exporter of any fuch Bar Iron and Pig Iron do first make Oath of the true Destination of the fame to the Places for which fuch Bar-Iron and Pig-Iron shall be entered Outwards, before the Entry of the fame shall be made, and do give full and fufficient Security by Bond, to the Satisfaction of the Commissioners of His Majefty's Cufloms, to carry the faid Bar-Iron and Pig-Iron to the Places for which they are fo entered Outwards, and for the Purpofes specified, and none other ; and to produce, within Twelve

Months from the Date of the Bond, from the British Conful refident at the Port for which such Bar-Iron and Pig-Iron shall be cleared out, or, in cafe there shall be no fuch Conful there refident, or he fhall be absent from the fame, then from Two British Merchants refident there, a Certificate or Certificates that fuch Bar-Iron and Pig Iron has been all duly delivered at the Ports for which the fame was cleared out; and the Bonds or Securiries shall not be cancelled or delivered up but on

the Production of fuch Certificate or Certificates. And the Right Honourable the Lords Commissioners of His Majefty's Treafury are to give the necessary Directions herein accordingly.
