HEREAS His Majesty was pleased, by His Order in Council bearing Date the Thirteenth of March, 1793, to order, that an Embargo fhould be forthwith laid upon all Ships or Veffels laden for to be laden in any of the Ports of Great Britain with Salted Provisions of any Kind whatfoever, and also upon all Ships and Vessels laden or to be laden with Butter and Cheefe, Peafe, Beans, Rice, Hay, Straw, or Forage of any Kind whatfoever, and with Hides or Leather manufactured or unmanufactured; but it was His Majefty's Pleafure, amongst other Things, that the faid Embargo should not extend to any Ships or Veffels, being British Ships and Veffels, and navigated according to Law, which may be employed in carrying any of the Articles abovementioned to any Country in or out of Europe, in Amity with His Majesty : And whereas it hath been reprefented, on Behalf of the Merchants, concerned in the Exportation of Tanned Leather, and alfo of the Merchants concerned in the Exportation .of Salted Pilchards, and other Salted Fifh, that the Trade in the faid feveral Articles will be greatly injured, if fuch Articles are not permitted to be exported in Foreign Ships, under proper Regulations; His Majefty, taking the fame into Confideration, is pleafed, by and with the Advice of His Privy Council, to order, and it is hereby ordered, that, from and after the Date hereof, the Exportation of | Bonds or Securities shall not be cancelled or delivered

other Salted Fish, shall, notwithstanding the faid Order of the Thirtzenth of March last, be permitted and allowed from any of the Ports in this Kingdom to any Country in or out of Europe, in Amity with His Majefty, in Foreign Ships or Veffels, provided the Merchant Exporter of any fuch Tanned Leather and Salted Pilchards, or other Salted Fifh, do first make Oath of the true Destination of the fame to the Places for which fuch Tanned Leather and Salted Pilchards, or other Salted Fish, shall be entered Outwards, before the Entry of the fame shall be made, and do give full and fufficient Security by Bond, to the Satisfaction of the Commissioners of His Majefty's Cuftoms, with Two fufficient Sureties, being known British Merchants, or other Persons of acknowledged Credit refident in this Kingdom, to be approved of by the proper Officers of the Cuftoms, to carry the faid Tanned Leather and Salted Pilchards, or other Salted Fish, to the Place for which the fame are respectively entered Outwards, and to produce, within Twelve Months from the Date of the Bond, from the British Conful refident at the Port for which fuch Tanned Leather and Salted Pilchards, or other Salted Fish, shall be cleared out; or, in cafe there shall be no fuch Conful there refident, or he shall be absent from the same, then from Two British Merchants refident there, a Certificate or Certificates that fuch Tanned Leather and Salted Pilchards, or other Salted Fifh, have been all duly delivered at the Ports for which the fame were cleared out; and fuch

#### Whitehall, October 5.

Extract of a Letter received Y fterday by the Right Henorable Henry Dundas, 11.5 Majety's Principal Secretary of State for the Home Department, from the Right Honorable Lord Mulgrave, dated Youlon, September 16.

Nothing of Importance has occurred fince my Letter of September 8. The Enemy have been conitantly in Sight, and have puthed their Patroles very near our Out-Pofts, from whom we have occafionally taken a few Pritoners; but we have remained on our Part conftantly on the Defensive, to avoid fatiguing the Troops, who continue in good Health. The Redoubts and Forts at the Out-Pofts are in general to confiderably ftrengthened as to leave little to apprehend from any offensive Efforts of the Enery; though no Part of the Reinforcements, which were required from different Quarters, were arrived.

On the 15th the Enemy marched a confiderable Corps of Troops, of which about 400 Infantry and 200 Cavalry parfed in Sight of our Pofts from the East Side of the Town, to reinforce Cartaux's Main Body, which is pofted on the Hills to the Weftward. I am certain of the cordial Co-operation of the Spanish Admiral Gravina, who commands the Troops of his Nation on Shore, and whole active Zeal, accommodating Disposition, and even Temper, give every possible Facility to the Execution of the Public Service, and the Support of the Common Cause.

It is with the higheft Satisfaction I inform you that the British Troops have very particularly diftinguished themfelves by their moderate Conduct and orderly Behaviour. From the Inhabitants I have hitherto only heard Praises of their good Order.

Extract of a Letter from the Earl of Elgin, His Majefty's Envoy Extraordinary at the Court of Bruffels, to the Right Honorable Lord Grenville, His Majefty's Principal Secretary of State for Foreign Affairs, dated Haumont, September 29, 1793.

IT is with the utmost Satisfaction that I have it in my Power to inform your Lordship of the compleat Success with which His Serene Highness Prince Cobourg has this Day passed the Sambre, driven into the entrenched Camp of Maubeuge all the detached Corps of French, and formed the Investment of the Camp and Fortrefs.

The Army was in March at Day-break. General Clairfayt's Column crofied at Brelaimort, and having met with very little Refiftance, was, in a very fhort Time, in the Pofition, which according to the Difpofition it was meant to take, between Aulnois and Bafchamp.

The Column of General Colloredo croffed at Pont and Haumont, and fo effectually were the Enemy furprifed in the Camp of St. Remy Malbati, that their Tents and Baggage were taken. The Rout foon began, but the Purfuit was interrupted by great Inequalities in the Ground, and, accordingly, the Loss of the French in killed and wounded, and in

Prifoners, did not exceed the Number of 200 Men. The Auftrians, however, took Nine Pieces of Cannon. General Colloredo has pitched his Camp between Haumont and the Bois de Beaufort, both of which he occupies.

General de la Tour crossed the Sambre between Jeumont and Marpeut, and with a Degree of Succefs fimilar to that of General Colloredo's Column, as he furprifed the Enemy's Camp at Bequignies. He took fome Prifoners, and Two Pieces of Cannon; and as his March was not much impeded by the Nature of the Country, he killed 300 Men. He has advanced to Cerfontaine, where he has taken up his Position : He occupies the Forest of Bonpere, near Ronsies, and his Left Flank extends by Terrere la Petite, towards the Corps of General Colloredo, with whom he is at this Moment forming a Junction. Colonel Seckendorff, who marched from Charleroy, 'has advanced, without much Resiltance, to Collnet.

Prince Cobourg's Head Quarters are at Haumont.

In a Word, every Object propoled in this Enterprize has been obtained, and with the Lofs of 50 Men killed and wounded: Two or Three Officers are flightly wounded.

#### Whitehall, October 5.

As several Artificers and Manufacturers, Subjects of Great Britain, have, from Time to Time, gone into Foreign Countries to exercise their several Callings, contrary to the Laws of thefe Kingdoms, the follow-ing Aftracts of ABs of Parliament of Their late Majeflies King George the First and Second, and of His present Mujesly, for preventing such Practices, are published, for the Information of all Persons who may be ignorant of the Penalties they may incur. by Disobedience to them : And it will be observed, that fuch Penalties likewife extend to those who are any ways concerned or instrumental in the Sending or Enticing Artificers or Manufacturers out of these Kingdoms, or in the Exportation of the Tools and Instruments used by them, as well as to the Artificers or Manufacturers themfelves.

#### Statute 5 George I. Chap. 27.

TF any Perfon fhall contract with, entice, or folicit, 1 any Artificer in Wool, Iron, Steel, Brafs, or other Metal, Clock-maker, Watch-maker, or any other Artificer of Great Britzin, to go into Foreign Countries out of the King's Dominions, and shall be convicted thereof, upon Indictment or Informa-tion, in any of the Courts at Westminiter, or at the Affizes or Quarter-Seffions, he shall be fined any Sum not exceeding ONE HUNDRED POUNDS for the first Offence, and shall be imprisoned Three Months, and till the Fine be paid. And if any Perfon having been once convicted shall offend again, he shall be fined at the Discretion of the Court, and imprisoned Twelve Months, and till the Fine be paid.

If any of the King's Subjects, being fuch Artificers, shall go into any Country out of His Majesty's Dominions, to exercise or teach the faid Trades to Foreigners; and if any of the King's Subjects in any fuch Foreign Country, exercifing any of the faid Trades, shall not return into this Realm within Six Months after Warning given by the Ambassador, Minister or Consul of Great Britain, in the Country where fuch Artificers shall be, OF

or by any Perlon authorited by fuch Ambaffador; | or Finishing of the Woollen or Silk Manufactures &c. or by one of the Secretaries of State, and from | or any Part of fuch Tools, he shall, for every Ofhenceforth inhabit within this Realm ; fuch Perfons fhall be incapable of taking any Legacy, or of being an Executor or Administrator, or of taking any Lands, &c. within this Kingdom, by Defcent, De-vife or Purchafe, and fhall forfeit all Lands, Goods, &c. within this Kingdom, to His Majelty's Ufe, and fhall be deemed Alien, and out of His Majefty's Protection.

Upon Complaint made, upon Oath, before any Justice of Peace, that any Person is endeavour-ing to seduce any such Artificer, or that any such Artificer hath contracted or is preparing to go out of His Majelly's Dominions, for the Purpoles aforefaid, fuch Juffice may fend his Warrant to bring the Perfon complained of before him, or before fome other Juffice; and if it shall appear by the Oath of one Witnefs, or by Confession, that he was guilty of any of the faid Offences, such Justice may bind him to appear at the next Affizes or Quarter Seffions : And, if fuch Perfon shall refuse to give Security, the Juffice may commit him to Goal till the next Affizes or Quarter Seffions, and until he shall be delivered by due Courfe of Law. And if any fuch Artificer shall be convicted, upon Indictment, of any fuch Promile, Contract, or Preparation to go beyond the Seas, for the Purpole aforefaid, he shall give fuch Security to the King not to depart out of His Majeffy's Dominions, as such Court shall think reasonable, and shall be imprisoned till Security given.

If any of the above Offences shall be committed in Scotland, the fame shall be profecuted in the Court of Justiciary, or the Circuits there.

#### Statute 23 George II. Chap. 13.

IF any Perfon shall contract with, or endeavour to feduce any Artificer in Wool, Mohair, Cot-ton or Silk, or in Iron, Steel, Brafs, or other Metal, or any Clock-maker, Watch-maker, or any other Artificer in any other of the Manufactures of Great Britain or Ireland, to go out of this Kingdom or Ireland, into any Foreign Coun-try not within the Dominions of the Crown of Great Britain, and shall be convicted, upon In-diffment or Information, in the King's Bench at Westminster, or by Indictment at the Assizes or General Gaol Delivery for the County, &c. wherein such Offence shall be committed in England, or by Indictment in the Court of Jufficiary, or any of the Circuit Courts in Scotland, or by Indiciment or Information in the King's Bench at Dublin, if fuch Offence be committed in Ireland; the Perfon to convicted thall, for every Ar-tificer contracted with, or feduced, forfeit FIVE HUNDRED POUNDS, and thall fuffer Imprifonment in the Common Goal of the County or Stewartry wherein such Offender shall be convicted, for Twelve Calendar Months, and until Forfeiture be paid : And in Cafe of a subsequent Offence of, the same Kind, the Persons so again offending shall forfeit, for every Perion contracted with or feduced, ONE THOUSAND POUNDS, and shall fuffer Impriforment in the Common Gaol of the County or Stewartry wherein fuch Offender shall be convicted, for Two Years, and until such

Forfeiture be paid. If any Perfon in Great Britain or Ireland shall put on Board any Ship or Boat, not bound directly to fome Port in Great Britain or Ireland, or to fome other of the Dominions of the Crown of Great Britain, any fuch Tools or Utenfils as are commonly uled in, or proper for the Preparing, Working up

fence, forfeit all fach Tools, or Parts thereof, put on Board, and TWO HUNDRED POUNDS, to be recovered by Action of Debt, &c. in any Court of Record at Weffminfler, or in the Court of Seffion in Scotland, or at any of the Four Courts in Dublin respectively, wherein no Effoin, &c. thall be allowed.

It shall be lawful for any Officer of the Cultoms in Great Britain, or for any Officer of the Revenue in Ireland, to feize and fecure, in fome of His Maefty's Warehoufes, all fuch Tools or Utenfils prohibited to be exported, as fuch Officer shall find on Board any Vessel not bound directly to some Porr in Great Britain or Ireland, or to fome other of the Dominions of the Crown of Great Britain ; and all Tools fo feized thall, after Condemnation, be publickly fold to the best Bidder; and one Moiety of the Produce shall be to the Ule of His Majelty, and the other Moiety to the Officer who shall feize and fecure the fame.

If the Captain of any Veffel in Great Britain of Ireland knowingly permit any of the faid Tools, prohibited to be exported, to be put on Board his Veflel, he thall, for every fuch Offence, forfeitONE HUNDRED POUNDS, to be recovered as the Penalties inflicted upon Performs exporting the Tools; and, if the Veffel belongs to His Majeffy, the Captain thall not only forfeit ONE HUN-DRED POUNDS, but thall also forfeit his Empoyment, and be incapable of any Employment under His Majefty.

If any Officer of the Cuftoms in Great Britain, or of the Revenue in Ireland, take, or knowingly fuffer to be taken, any Entry outward, or fign any Cocket or Sufferance for the Shipping or Exporting of any of the faid Tools, or knowingly fuffer the fame to be done, he shall forfer ONE HUNDRED POUNDS, to be recovered as aforefaid, and alfo forfeit 'his Office, and be incapable of any Office

under His Majesty. One Morety of the Forfeitures shall be applied to the Use of His Majesty, and the other Molety to the Use of the Person who shall sue for the fame.

## Statutes 14, 21, 25 and 26 of His prefent

Majefty. BY these Statutes the like Penalties and Forfeitures as above mentioned are extended to Perfons packing or putting on board any Veffel, not bound directly for fome Port in Great Britain or Ireland, any Machine, Engine, Tool, Prefs, Paper, Utenfil or Implement whatfoever, ufed in or proper for the working or finishing of the Cot-ton, Linen, Steel or Iron Manufactures of this Kingdom, or any Part or Parts of fuch Machines or Implements, or any Models or Plans thereof; and all Captains of Ships and other Perfons receiving or being in Poffeifion of any fuch Articles, with an Intent to export the fame to Foreign Parts, and all Custom-house Officers fuffering an Entry to be made thereof, are respectively liable to the like Penalties as are above mentioned, in the Cafe of Tools and Utenfils used in the Woollen and Silk Manufactures.
