

PRESENT,

The KING's Most Excellent Majesty in Council.

7 HEREAS by an' Act of Parliament passed in the Twenty-fixth Year of His late Majesty's Reign, intituled, " An Act to oblige Ships " more effectually to perform their Quarantine, " and for the better preventing the Plague being " brought from Foreign Parts into Great Britain or Ireland, or the Islands of Guernsey, Jersey, " Alderney, Sark or Man," it is, amongst other Things, enacted, That all Ships and Vessels arriving, and all Perfons, Goods and Merchandizes whatfoever, coming or imported into any Port or Place within Great Britain or Ireland, or any of the Isles beforementioned, from any Place from whence His Majesty, His Heirs or Successors, by and with the Advice of His or Their Privy Council, shall judge it probable that the Infection may be brought, shall be obliged to make their Quarantine in fuch Place and Places, for such Time, and in such Manner, as has been or shall, from Time to Time, be directed by His Majesty, His Heirs or Succesfors, by His or Their Order or Orders, made in His or Their Privy Council, and notified by Proclamation, or published in the London Gazette; and that until fuch Ships, Vessels, Persons, Goods and Merchandizes shall have respectively per-

formed and be discharged from such Quarantine, no fuch Persons, Goods or Merchandizes, or any of them, shall come or be brought on Shore, or go or be put on board any other Ship or Vessel, in any Place within His Majesty's Dominions, unless in such Manner, and in such Cases, and by fuch Licence, as shall be directed or permitted by fuch Order or Orders made by His Majesty, His Heirs or Successors, in Council as aforesaid; and that all fuch Ships and Vessels, and the Persons or Goods coming or imported in, or going or being put on board the same, and all Ships, Vessels, Boats and Persons receiving any Goods or Persons ont of the same, shall be subject to such Orders, Rules and Directions concerning Quarantine, and the Prevention of Infection, as have been or shall be made by His Majesty, His Heirs and Successors, in Council, and notified by Proclamation or published in the London Gazette as aforementioned, under fuch Pains and Penalties as are inflicted by the faid Act.

And whereas Information has been received that a malignant and contagious Fever, of the Nature of the Plague, has manifested itself at Philadelphia, in the State of Pensylvania, and in certain Towns of the State of New Jersey, in the United States of America; His Majesty, with the Advice of His Privy Council, doth thereupon judge it expedient, for the Sasety of the Public Health, to order, and it is hereby ordered, That all Ships,

Veffels, Perfons, Goods and Merchandize now arrived, or that shall hereafter arrive in any Po t of this Kingdom, or the Isles of Guernsey, Jersey, Alderney, Sark or Man, from any of the Ports of the said State of Pensylvania, or of the State of Delaware, or of the State of New Jersey, in the United States of America, do make their Quarantine for Fourteen Days, which is to commence and be computed from the Day each Ship or Vessel shall come to Anchor in the Place appointed for the Performance of Quarantine, and not before.

That the Places herein after named shall be and are hereby appointed to be the Places wherein such Ships or Vessels (not having the Infection on board) shall respectively perform Quarantine; that is to fay: All fuch Ships or Vessels which are or shall be bound to the Port of London, or any Member, Creek, or other Parts thereof, or to the River Thames or Medway, shall perform their Quarantine in Standgate Creek; all fuch Ships or Veffels which are or shall be bound to the Ports of Ipfwich, Yarmouth, Boston, Hull, Newcastle or Berwick upon Tweed, or any of them, or any Member or Creek thereof, or other Place therein, shall perform their Quarantine in Whitebooth Road, between Hull and Grimsby; all such Ships or Vessels which are or shall be bound to the Ports of Carlisle and Chester, or either of them, or any Member or Creek thereof, or other Place therein, or to any Part of the Isle of Man, shall perform their Quarantine in a Place called Highlake, near Liverpool, at the West End thereof; all such Ships or Vessels which are or shall be bound to the Ports of Milford, Cardiff, Gloucester, Bristel, Bridgwater, or any of them, or any Member or Creek of them, or any of them, or to Padslow or St. Ive's, being Members of the Port of Plymouth, or to Ilfracombe or Barnstaple, being Members of the Port of Exeter, or to any other Place within the faid Ports of Milford, Cardiff, Gloucester, Bristol or Bridgwater, or within the faid Members or Creeks, shall perform their Quarantine in Kingroad and Porshate Pill; all such Ships or Vessels which are or shall be bound to the Port of Plymouth, except fuch Parts thereof as have been herein before mentioned, and also except Falmouth, One Member thereof, or to the Port of Exeter, except such Parts thereof as have been herein before mentioned, or to the Port of Pool, or any of the Members or Creeks or other Places within the faid Ports of Plymouth, Exeter and Pool, except as before excepted, shall perform their Quarantine in some Place between Wood-End and Saltash, in the River Tamer; all

fuch Ships or Vessels as are or shall be bound to Falmouth, a Member of the Port of Plymouth, or any Creek thereof, or any other Place therein, shall perform their Quarantine in a Place called St. Ive's Pool, within the Mouth of the Harbour of Falmouth; and all fuch Ships or Vessels as are or shall be bound to the Ports of Southampton, Chichester, Sandwich, or any of them, or any of the Members or Creeks thereof, or of any of them, or any other Place within the same, shall perform their Quarantine at a Place called the Mother-Bank, near Portsmouth; and all such Ships or Vessels as are or shall be bound to the Eastern Coast of Scotland, comprehending the Ports of Leith, Burrowstoness, Aloa, Dunbar, Kirkaldy, Anstruther, Preston-Pans, Dundee, Perth, Montrofe and Aberdeen, or to any Member, Creek or other Parts thereof, shall perform their Quarantine in Inverkeithing Bay; and all fuch Ships or Vessels as are or shall be bound to the Western Ports of Scotland, comprehending the Ports of Port Glasgow, Greenock, Irvine, Campbeltoun, Oban, Rothfay, Fort William, Air, Port Patrick, Stranraer and Wigtown, or to any Member, Creek or other Parts thereof, shall perform their Quarantine at Lamlash in the Island of Arran; and all such Ships or Vessels as are or shall be bound to the Northern Ports of Scotland, comprehending the Ports of Inverness, Zetland, Orkney, Caithnels and Stornaway, or to any Member, Creek or other Parts thereof, shall perform their Quarantine in Cromarty Bay in the Murray Firth; and all fuch Ships or Vessels as are or shall be bound to the South-West Ports of Scotland, comprehending the Ports of Dumfries and Kirkcudbright, or to any Member, Creek or other Parts thereof, shall perform their Quarantine at Carsthorn, at the Mouth of the River Nith; and all such Ships or Vessels which are or shall be bound to the Isle of Jersey, or any Port thereof, shall perform their Quarantine at a certain Place on the Coast of the faid Island, called Belle Croute, or at some Place herein before appointed for Performance of Quarantine on the Coast of England; and all such Ships or Vessels as shall be bound to the Islands of Guernsey, Sark or Alderney, or either of them, or any Part of them, or any of them, shall perform their Quarantine in a Place near the Island of Guernsey, called the Little Road, or at some Place herein before appointed for Performance of Quarantine on the Coast of England.

That no Pilot shall go on board any Ship or Vessel obliged to perform Quarantine, in order to conduct the same into any Port or Place, but shall perform such Service in some other Boat or Vessel,

which Boat or Vessel shall keep as much to the Windward of the Ship or Vessel so to be conducted as possible; and if any Pilot or other Person shall go on board such Ship or Vessel, such Pilot or other Person shall person Quarantine, in like Manner as any Person coming in such Ship or Vessel shall be obliged to person the same.

That all Goods, Wares and Merchandizes liable to Quarantine as aforesaid, shall be opened, unpacked and aired, unless His Majesty shall think fit, by His Order in Council, to direct otherwise, and so emain a Week, other than Hemp and Flax, Paper or Books, Silk, raw, thrown or wrought, Linen, Cotton-Wool, Cotton-Yarn or manufactured, Wool, raw or any wife wrought, Feathers, Grograin or Mohair Yarn, Human Hair, Goats Hair, Carmenia Wool, Carpets, Camblets, Burdets, or other Manufactures of Silk and Cotton, Kid-Skins, and Skins in the Wool or Hair, Spunges, Wine and Oil in Chests, Thread Stockings, all Goods packed with Straw or Cotton, Straw Hats and Brushes, Matting, and Artificial Flowers; which Goods and Merchandizes, fo as aforefaid enumerated, are to be opened, unpacked and aired, unless His Majesty shall think sit, by His Order in Council, to direct otherwise, and so remain for the Space of a Fortnight.

That all Goods imported by fuch Ships and Vessels respectively shall be aired in the following Places, that is to fay: All fuch Goods as shall be imported to the Port of London, or any Member, Creek or other Parts thereof, or to the River Thames, or Medway, shall be aired in Standgate Creek; all fuch Goods as shall be imported to the Ports of Ipswich, Yarmouth, Boston, Hull, Newcastle, or Berwick upon Tweed, or any of them, or any Member or Creek thereof, or other Place therein, shall be aired in Whitebooth Road, between Huil and Grimsby; all such Goods as shall be imported to the Ports of Carlisle and Chester, or either of them, or any Member or Creek thereof, or other Place therein, or to any Part of the Isle of Man, shall be aired in a Place called Highlake, near Liverpool, at the West End thereof; all fuch Goods as shall be imported to the Ports of Milford, Cardiff, Gloucester, Bristol, Bridgwater, or any of them, or any Member or Creek of them, or any of them, or to Padstow, or St. Ive's, being Members of the Port of Plymouth, or to Ilfracombe or Barnstaple, being Members of the Port of Exeter, or to any other Place within the faid Ports of Milford, Cardiff, Gloucester, Bristol or Bridgwater, or within the faid Members or Creeks, shall be aired in King Road and Porshute-Pill; all such Goods as shall be imported to the Port of Plymouth, except such Parts thereof as have been herein before mentioned, and also except Falmouth, one Member thereof, or to the Port of Exeter, except such Parts thereof as have been herein before mentioned, or to the Port of Poole, or any of the Members, or Creeks or other Places, within the faid Ports of Plymouth, Exeter and Poole, except as before excepted, shall be aired at some Place between Wood-End and Saltash, in the River Tamer; all such Goods as shall be imported to Falmouth, a Member of the Port of Plymouth, or any Creek thereof, or any other Place therein, shall be aired in a Place called St. Ive's Pool, within the Mouth of the Harbour of Falmouth; all fuch Goods as shall be imported to the Ports of Southampton, Chichester, Sandwich, or any of them, or any of the Members or Creeks thereof, or any of them, or any other Place within the fame, shall be aired at a Place called the Motherbank, near Portsmouth: And all such Goods as shall be imported to the Eastern Coast of Scotland, comprehending the Ports of Leith, Borrowstoness, Alloa, Dunbar, Kirkaldy, Anstruther, Preston-Pans, Dundee, Perth, Montrose and Aberdeen, or to any Member, Creek or other Parts thereof, shall be aired in Inverkeithing Bay; and all such Goods as shall be imported to the Western Parts of Scotland, comprehending the Ports of Port Glafgow, Greenock, Irvine, Cambeltoun, Oban, Rothfay, Fort William, Air, Port Patrick, Stranraer and Wigtown, or to any Member, Creek or other Parts thereof, shall be aired at Lamlash, in the Island of Arran; and all fuch Goods as shall be imported to the Northern Ports of Scotland, comprehending the Ports of Inverness, Zetland, Orkney, Caithness and Stornaway, or to any Member, Creek or other Parts thereof, shall be aired in Cromarty Bay, in the Murray Firth; and all such Goods as shall be imported to the South-West Ports of Scotland, comprehending the Ports of Dumfries and Kirkcudbright, or to any Member, Creek or other Parts thereof, shall be carried to Carsthorn, at the Mouth of the River Nith; and all such Goods as shall be imported to the Isle of Jersey, or any Part thereof, shall be aired at a certain Place on the Coast of the said Island, called Belle-Croute, or at such Place herein before appointed for Performance of Quarantine on the Coast of England, where the Ships in which such Goods are imported shall respectively perform their Quarantine: And all fuch Goods as shall be imimported ported to the Islands of Guernsey, Sark or Alderney, or either of them, or any Part of them, or any of them, shall be aired in a Place near the Island of Guernsey, called the Little-Road, or at such Place herein before appointed for Performance of Quarantine on the Coast of England, where the Ships in which such Goods are imported shall respectively perform their Quarantine.

That whatfoever Ship or Person shall receive any Men or Goods from on board any Ship or Vessel under Quarantine, shall be compelled to personn the like Quarantine.

That fuch Perfons as, after Quarantine performed, shall be employed in the Hold of any Ship or Vessel for the taking any Goods not liable to retain Infection from the Goods and Merchandizes before enumerated, shall be obliged to perform a new Quarantine.

That the Captains of every of His Majesty's Ships of War, who shall meet any such Ship or Vessel coming to any of the Ports of Great Britain or Ireland, or the Isles of Guernsey, Jersey, Alderney, Sark or Man, shall take due Care to prevent the Landing any Goods, Seamen or Passengers from on board the same, until they shall be put under the Direction of the Officers of His Majesty's Customs.

That the Commissioners and other Officers of His Majesty's Customs do use their utmost Diligence and Care that the Quarantine before directed be duly performed.

That the Commanders of His Majesty's Ships of War, as likewise the Commanders of His Majesty's Forts and Garrisons lying near the Sea Coasts, and all the Justices of the Peace, Mayors, Sherists, Bailists, Chief Magistrates, Constables, Headboroughs, Tythingmen, and all other Officers and Ministers of Justice, be aiding and assisting to the said Officers of His Majesty's Customs, and to all others that shall be concerned in stopping all such Ships as aforesaid, and in bringing them to the Places appointed for the Performance of their Quarantine, and in due Performance thereof.

And the Lords Commissioners of His Majesty's Treasury, the Commissioners for executing the Office of Lord High Admiral of Great Britain, the Lord Warden of the Cinque Ports, the Master General and the Rest of the Principal Officers of the Ordnance, His Majesty's Secretary at War, and the Governors or Commanders in Chief for the Time being of the said respective Isles of Jersey, Guernsey, Alderney, Sark and Man, are to give the necessary Directions herein as to them may respectively appearain.

DY a Dispatch from the Earl of Yarmouth, dated the 28th of October, it appears, that on the 25th of that Month the Right Wing of the Enemy was completely routed, with the Loss of Fourteen Cannon, a great Quantity of Military Stores, Two Howitzers, all the Camp Equipage, and an important Position at Wanzenau, of which General Wurmfer immediately took Possessin: That the Austrians were attacked on every Side on the 27th, but that the Enemy was compelled to retreat; and that the Loss of the latter on the Two Days was computed at 3000 killed, wounded and taken.

Dublin Castle, November 5.

Yesterday being the Anniversary of the Birth of the late King William the Third, of Glorious Memory, in the Morning the Flag was displayed on Bedford Tower; at Noon there was a splendid Appearance of the Nobility and other Persons of Distinction at the Castle, to compliment his Excellency the Lord Lieutenant; and Yesterday his Excellency, attended by the Nobility and Gentry, and escorted by a Squadron of Horse, went in Procession round the Statue of King William. On his Excellency's Return to the Castle the Great Guns at the Salute Battery in His Majesty's Park the Phænix were sired Three Rounds, and answered by Vollies from the Regiments in Garrison, which were drawn up in College Green. And at Night there were Bonsires, Illuminations, and other Demonstrations of Joy.

IN Pursuance of the Directions of an Act passed in the Twenty-fourth Year of the Reign of His prefent Majesty King George the Third, intituled, "An Act to repeal so much of Two Acts, made in the Tenth and Fisteenth Years of the Reign of His present Majesty, as authorizes the Speaker of the House of Commons to issue his Warrant to the Clerk of the Crown for making out Writs for the Election of Members to serve in Parliament, in the Maaner therein mentioned; and for substi-

As several Artificers and Manufacturers, Subjects of Great Pritain, have, from Time to Time, gons into Foreign Countries to exercise their several Callings, contrary to the Laws of these Kingdoms, the following Abstracts of Acts of Parliament of Their late Klajestics King George the First and Second, and of His present Majesty, for preventing such Practices, are published, for the Information of all Persons who may be ignorant of the Penalties they may incur by Disobedience to them: And it will be observed, that such Penalties likewise extend to those who are any ways concerned or instrumental in the Ending or Enticing Artificers or Manufacturers out of these Kingdoms, or in the Exportation of the Tools and Instruments used by them, as well as to the Artificers or Manufacturers themselves.

Statute 5 George I. Chap. 27.

IF any Person shall contract with, entice, or solicit, any Artificer in Wool, Iron, Steel, Brass, or other Metal, Clock-maker, Watch-maker, or any other Artificer of Great Britain, to go into Foreign Countries out of the King's Dominions, and shall be convicted thereof, upon Indictment or Information, in any of the Courts at Westminster, or at the Assizes or Quarter-Sessions, he shall be sined any Sum not exceeding ONE HUNDRED POUNDS for the first Offence, and shall be imprisoned Three Months, and till the Fine-be paid. And if any Person having been once convicted shall offend again, he shall be fined at the Discretion of the Court, and imprisoned Twelve Months, and till the Fine be paid.

If any of the King's Subjects, being such Artificers, shall go into any Country out of His Majesty's Dominions, to exercise or teach the said Trades to Foreigners; and if any of the King's Subjects in any such Foreign Country, exercising any of the said Trades, shall not return into this Realm within Six Months after Warning given by the Ambassador, Minister or Consul of Great Britain, in the Country where such Artificers shall be, or by any Person authorised by such Ambassador, &c. or by one of the Secretaries of State, and from henceforth inhabit within this Realm; such Persons shall be incapable of taking any Legacy, or of being an Executor or Administrator, or of taking any Lands, &c. within this Kingdom, by Descent, Devise or Purchase, and shall forseit all Lands, Goods, &c. within this Kingdom, to His Majesty's Use, and shall be deemed Alien, and out of His Majesty's Protection.

Upon Complaint made, upon Oath, before any Justice of Peace, that any Person is endeavouring to seduce any such Artificer, or that any such Artificer hath contracted or is preparing to go out of this Majesty's Dominions, for the Purposes aforesaid, such Justice may send his Warrant to bring the Person complained of before him, or before some other Justice; and if it shall appear by the Oath of one Witness, or by Consession, that he was guilty of any of the said Offences, such Justice may bind him to appear at the next Affizes or Quarter Sessions: And, if such Person shall refuse to give Security, the Justice may commit him to Goal till the next Affizes or Quarter Sessions: And if such Person shall refuse to give Security, the Justice may commit him to Goal till the next Affizes or Quarter Sessions, and until he shall be delivered by due Course of Law. And if any such Artificer shall be convicted, upon Indictment, of any such Promise, Contract, or Preparation to go beyond the Seas, for the Purpose aforesaid, he shall give such Security to the King not to depart out of this Maiesty's Dominions, as such Court shall think reasonable, and shall be imprisoned till Security given.

If any of the above Offences shall be committed in Scotland, the same shall be profecuted in the Court of Justiciary, or the Circuits there.

Statute 23 George II. Chap. 13.

IF any Person shall contract with, or endeavour to feduce any Artificer in Wool, Mohair, Cotton or Silk, or in Iron, Steel, Brefs, or other Metal, or any Clock-maker, Watch-maker, or any other Artificer in any other of the Manufactures of Great Britain or Ireland, to go out of this Kingdom or Ireland, into any Foreign Country not within the Dominions of the Crown of Great Britain, and shall be convicted, upon Indictment or Information, in the King's Bench at Westminster, or by Indictment at the Assizes or General Gaol Delivery for the County, &c. wherein such Offence shall be committed in England, or by Indictment in the Court of Justiciary, or any of the Circuit Courts in Scotland, or by Indictment or Information in the King's Bench at Dublin, if such Offence be committed in Ireland; the Person so convicted shall, for every Artificer contracted with, or feduced, forfeit FIVE HUNDRED POUNDS, and shall suffer Impri-forment in the Common Goal of the County or Stewartry wherein such Offender shall be convided, for Twelve Calendar Months, and until Forfeiture be paid: And in Case of a subsequent Offence of the same Kind, the Persons so again offending shall forseit, for every Person contracted with of seduced, ONE THOUSAND POUNDS, and shall suffer Imprisonment in the Common Gaol of the County or Stewartry wherein fuch Offender shall be convicted, for Two Years, and until such Forfeiture be paid.

If any Person in Great Britain or Ireland shall put on Board any Ship or Boat, not bound directly to some Port in Great Britain or Ireland, or to some other of the Dominions of the Crown of Great Britain, any such Tools or Utensils as are commonly used in. or proper for the Preparing, Working up or Finishing of the Woollen or Silk Manusactures or any Part of such Tools, he shall, for every Offence, forseit all such Tools, or Parts thereof, put on Board, and TWO HUNDRED POUNDS, to be recovered by Action of Debt, &c. in any Court of Record at Westminster, or in the Court of

Session in Scotland, or at any of the Four Courts in Dublin respectively, wherein no Essoin, &c. shall be allowed.

It shall be lawful for any Officer of the Customs in Great Britain, or for any Officer of the Revenue in Ireland, to seize and secure, in some of His Ma-elly's Warehouses, all such Tools or Utensils prohibited to be exported, as such Officer shall find on Board any Vessel not bound directly to some Port in Great Britain or Ireland, or to some other of the Dominions of the Crown of Great Britain; and all Tools fo seized shall, after Condemnation, be publickly fold to the best Bidder; and one Moiery of the Produce shall be to the Use of His Majesty, and the other Moiety to the Officer who shall seize and secure the same.

If the Captain of any Vessel in Great Britain or Ireland knowingly permit any of the faid Tools, prohibited to be exported, to be put on Board his Vessel, he shall, for every such Offence, forfeit ONE HUNDRED POUNDS, to be recovered as the Penalties inflicted upon Persons exporting the Tools; and, if the Vessel belongs to His Majesty, the Captain shall not only forseit ONE HUN-DRED POUNDS, but shall also forfeit his Empoyment, and be incapable of any Employment

under His Majesty.

If any Officer of the Customs in Great Britain, or of the Revenue in Ireland, take, or knowingly fuffer to be taken, any Entry outward, or fign any Cocket or Sufferance for the Shipping or Exporting of any of the faid Tools, or knowingly fuffer the fame to be done, he shall forfeit ONE HUNDRED POUNDS, to be recovered as aforefaid, and also forfeit his Office, and be incapable of any Office under His Majesty.

One Moiety of the Forfeitures shall be applied to the Use of His Majesty, and the other Moiety to the Use of the Person who shall sue for the
