THEREAS by Articles of Capitulation, proposed by the Inhabitants of La Grande Anse, including the Quarter at Jeremie, in the Island of St. Domingo in the West Indies, and accepted by Major-General Williamson, His Majesty's Lieutenant-Governor of the Island of Jamaica; and also by Articles of Capitulation, proposed by the Garrifon and Inhabitants of Cape Nicola Mole and it's Dependencies, in the faid Island of St. Domingo, and accepted by Commodore Ford, Commander in Chief of His Majesty's Ships and Vessels at Jamaica, Parts of the faid Island of St. Domingo have been surrendered to His Majesty, and are now in His Majesty's Possession, and the Inhabitants thereof are become Subjects of His Majesty: And whereas by an Act passed in the last Session of Parliament, intituled, " An Act " more effectually to prevent, during the prefent "War between Great Britain and France, all "traiterous Correspondence with, or Aid or Assist-" ance being given to His Majesty's Enemies," all Persons residing or being in Great Britain are pro-

And His Majesty is pleased further to order and declare, and it is hereby further ordered and declared, that all His loving Subjects may lawfully trade to and from such Parts of the said Island of St. Domingo as are or shall be in His Majesty's Possession, Subject nevertheless to the same Duries, Rules, Regulations, Conditions, Restrictions, Penalties and Forfeitures, to which the Trade to and from His Majesty's Colonies, Plantations and Islands in the West Indies is or shall be subject by Law: But it is His Majefly's Pleafure, that nothing herein contained shall extend to prevent the Importation in American Bottoms of Provisions, Cattle, Grain and Wood of every Kind from the United States of America into fuch Parts of the faid Island as aforefaid, so long as the same shall be allowed, in pursuance of and under the Terms and Conditions of the faid Articles of Capitulation, or any other Privileges or Exemptions granted by the faid Articles of Capitulation.

And His Majesty is further pleased to order and necture, and it is hereby ordered and declared, That all Commodities, being of the Growth, Produce or Manufacture of such Parts of the said Island of St. Domingo as shall, at the Time of the Entry of such Commodities for Exportation from the said Island, be in the Possession of His Majesty, shall be permitted to be imported into any of the Ports of this Kingdom in British Ships, owned by His Majesty's Subjects, and navigated according to Law, subject to the same Duties, Rules, Regulations, Restrictions, Conditions, Penalties and Forseitures, as Articles of the like Sort are subject to, coming from His Majesty's Colonies, Plantations or Islands in the West Indies.

And the Right Honourable the Lords Commiffioners of His Majetty's Treasury and the Lords Commissioners of the Admiralty are to give the necessary Directions herein, as to them may respectively appertain.

WHEREAS His Majesty was graciously pleased, by His Royal Proclamation bearing Date the Twenty-sixth Day of December 1792, to promise and declare, that the Bounties of Five Pounds for every Able Seaman, and Two Pounds Ten Shillings for every Ordinary Seaman, sit for

His Majesty's Service, should be paid in the

Manner thereby directed to every such Able and Ordinary Seaman, not above the Age of Fifty nor under the Age of Twenty Years, who should, on or before the Twenty-eighth Day of February then following, enter themselves to serve in His Majesty's Royal Navy, either with the Captains or Lieutenants of His Majesty's Ships or Vessels, or Officers employed on Shore for raifing Men for the Service of the Royal Navy: And whereas His Majesty was also graciously pleased, by His said Proclamation, to declare, that all Able-bodied Landmen, not above the Age of Thirty-five nor under the Age of Twenty Years, who should so enter themselves as aforesaid, should receive the Sum of Thirty Shillings each Man, as His Majesty's Royal Bounty: And whereas His Majesty was also graciously pleased, by His Royal Proclamation bearing Date the Sixteenth Day of the faid Month of February last, to promise and declare, that a Reward of Twenty Shillings for every Able and Ordinary Seaman, fit to ferve on board His Majesty's Ships, should be paid to any Person who should discover any Seaman or Seamen who might conceal him or themselves, so that fuch Seaman or Seamen should be taken for His Majesty's Service, on or before the Thirtieth Day of April then next, by any of His Majesty's Sea Officers, appointed to raife. Men on Shore, or by the Captains and Commanders of any of His Majesty's Ships or Vessels in the Ports or on the Coasts of this Kingdom: And whereas the Time limited by the said Proclamations for Payment of the faid Bounties and Reward, hath been prolonged and extended to the Thirty-first Day of this Instant December: And it being judged expedient for His Majesty's Service that the said Bounties and Reward should be continued to be paid for some Time longer; His Majesty, with the Advice of His Privy Council, doth therefore order, and it is hereby accordingly ordered, that the Time limited for Payment of the faid Bounties and Reward be prolonged and extended from the faid Thirty-first Day of this instant December to the Twenty-eighth Day of February 1794, inclusive : Whereof all Persons concerned are to take Notice, and govern themselves accordingly.

HEREAS the Time limited by His Majesty's

Order in Council of the 14th of June last, for prohibiting the Exporting out of this Kingdom,

or carrying Coastwise, Gunpowder or Salt-Petre, or any Sort of Arms or Ammunition, will expire upon the 7th Day of December next: And whereas it is judged expedient for His Majesty's Service, and the Safety of this Kingdom, that the faid Prohibition should continue for some Time longer; His Majesty doth therefore, by and with the Advice of His Privy Council, hereby order, require, prohibit and command, that no Person or Persons whatsoever (except the Master General of the Ordnance for His Majesty's Service) do, at any Time during the Space of Six Months, to commence from the faid 7th Day of December next, presume to transport, into any Parts out of this Kingdom, or carry Coastwife, any Gunpowder or Salt-Petre, or any Sort of Arms or Ammunition, or ship or lade any Gunpowder or Salt-Petre, or any Sort of Arms or Ammunition, on Board any Ship or Vessel, in order to transporting the same into any Parts beyond the Seas, or carrying the same Coastwise, without Leave or Permission in that Behalf sirst obtained from His Majesty, or His Privy Council, upon Pain of incurring and fuffering the respective Forfeitures and Penalties inflicted by an Act passed in the Twenty-ninth Year of His late Majesty's Reign, intituled, " An Act to impower His Majesty to pro-" hibit the Exportation of Salt-Petre, and to enforce " the Law for impowering His Majesty to prohibit " the Exportation of Gunpowder, or any Sort of " Arms or Ammunition; and also to empower His " Majesty to restrain the carrying Coastwise of Salt-" Petre, Gunpowder, or any Sort of Arms or Am-" munition:"-And the Lords Commissioners of His Majesty's Treasury, the Commissioners for executing the Office of Lord High Admiral of Great Britain, the Lord Warden of the Cinque Ports, the Master General of the Ordnance, and His Majesty's Secretary at War, are to give the necessary Directions herein as to them may respectively W.
