## From Cut. Day April 8, to Saturday April 12, 1794.

#### Whiteball, April 12.

A Letter, of which the following is an Extract, was Yesterday received from His Royal Highness the Duke of York by the Right Honorable Henry Dun-das, His Majefly's Principal Secretary of State for the Home Department, dated St. Amand, April 8,

1794. I nave received this Morning a Report from Count Walmoden, that the Enemy, having fucceeded in fur-prizing the Heffian Pofts at Tenbreuil, between Werwick and Ypres, got behind the Hanoverian Pickets, and cut them off. Succour, however, having arrived from Menin, the Enemy was driven back, and forced to re-cross the Lys, and to deitroy the Bridge which they had made. Our Loss was One Man killed, One Officer and Seven Mcn wounded, and Three Office. and One Hundred and Forty-three Men taken Prifoners.

## St. James's, April 12.

The King has been pleafed to grant unto John Stow, Gentleman, His Royal Licence and Authority that he and his Inue may affume and take the Sur-name of Baldrey, in Addition to that of Stow, in Compliance with the Will of John Baldrey, late of Woodbridge, in the County of Suffolk, Gent. de-ccafed; and also to order that this His Majefly's Concellion and Declaration be registered in His College of Arms.

Fie King has also been pleased to grant to Peter Goff, of Broad-Street, St. George's in the East, in the County of Middlefex, Suimaker, His Royal Li-cence and Authority that he and his Issue may affume and take the Suimame of Mallard only, and old hear the Arms of Mallard only of Manad alfo bear the Arres of Mallard, out of Regard and Affection to the Memory of his late Grandfather, Peter Mallard, formerly of the Parish of St. John, Wapping, in the County of Middleicx, but late of Plaistow in the County of Effex, Efq; deceased ; fuch Arms being, first daly enimplified according to the Laws of Arms, and recorded in the Heralds Office : And also to order that this His Majefty's Concession and Declaration be regulared in His College of Arms.
