AT the Court at St. James's, the 16th of July,

PRESENT,

The KING's Most Excellent Majesty in Council: X7HEREAS the Time limited by His Majesty's Order in Council of the Fifteenth of January, Et., prohibiting the transporting into any Parts our of this Kingdom any Pig-Iron, Bar-Iron, Cemp. Pitch, Tar, Rofin, Turpentine, Anchors, Cabies, Cordage, Masts, Yards, Bowsprits, Cars, Oakum, Oker, Sheet-Copper, or other Naval Stores, will expire upon the Twenty-fifth Day of this instant July; and whereas it is judged expedient for His Majesty's Service, and the Saidty of this Kingdom, that the faid Prohibition should be continued for some Time longer: His Majesty doth therefore, with the Advice of His Privy Council, hereby order, require, prohibit and command, that no Person or Persons whosoever do at any Time, for the Space of Six Months, to commence from the feid Twenty-fifth Day of this instant July, presume to trasport into any Parts out of this King lom, any Pig-Iron, Bar-Iron, Hemp, Pitch, Tar, Rofin, Turpentine, Anchors, Cables, Cardage, Masts, Yards, Bowsprits, Oars, Oakum, Oker, Sheet-Copper, or other Naval Stores; or Bip or lade any of the Articles above mentioned on board any Ship or Vessel, in order to transporting the same into any Parts beyond the Seas, without Leave or Permission being first had and obtained from His Majesty or His Privy Council. upon Pain of incurring the Forfeitures inflicted by an Act, passed in the Thirty-third Year of His Majelty's Reign, intituled, "An Act to enable His Majesty to restrain the Exportation of Na-

" val Stores, and more effectually to prevent the Exoportation of Salt-Petre; Arms and Amminition; " when prohibited by Proclamation or Oid r in " Council." But it is, neverthelefs, His Majefty's Pleasure, that nothing herein contained shall extend, or be construed to extend, to any of His Mas jefty's Ships of War, or any other Ships or Vessels or Boats, in the Service of His Majesty, or employed or freighted by His Majesty's Board of Ordnance, or by the Commissioners of His Majesty's Navy; nor to prevent any Ship or Vessel from taking or having on Board fuch Quantities of Naval Stores as may be necessary for the Use of fuch Ship or Vessel during the Course of her ititended Voyage, or by Licence from the Lord High Admiral of Great Britain; of the Commissioners of the Admiralty for the Time being; nor to the Lxportation of the faid feveral Aticles to Ireland; br to His Majesty's Yards or Garrisons, or to His Majesty's Colonies or Plantations in America, or the West Indies, or to Newfoundland, or to His Majesty's Forts and Settlements on the Coast of Africa; or to the Island of St. Helena, or the British Settlements or Factories in the East Indies; provided that, upon the Exportation of any of the faid Articles, for the Purpofes of Trade, to Ireland, or to His Majesty's Yards or Garrisons, or to His Majesty's Colonies and Plantations in America, of the West Indies, or to the Island of Newfoundland, or to His Majesty's Forts and Settlements on the Coak of Africa, or to the Island of St. Helena, or the British Settlements or Factories in the East Indies, the Exporters of such Articles do first make Oath of the true Destination of the same to the Places for which they shall be entered

Downers, before the Entry of the same shall be z .ce, and do give full and fufficient Security by Bond, to the Satisfaction of the Commissioners oc His Majesty's Customs, to carry the said Articles to the Places for which they are fo entered Outwards, and for the Parpofes specified, and sone other; and fuch Board shall not be cancelled or delivered up, until Proof be made, to the Satisfaction of the fail Commissioners, by the Production, within a Time to be fixed by the faid Commifsioners, and specified in the Bond, of a Certificate or Certificates, in such Form and Manner as shall be directed by the faid Commissioners, shewing that the faid Articles have been duly landed at the Places for which they were entered Outwards. And the Right Honourable the Lords Commissioners of His Majesly's Treasury, the Commissioners for executing the Office of Lord High Admiral of Great Britain, and the Lord Warden of the Cinque Ports, are to give the necessary Directions herein, as to them may respectively appertain.

#### Whitehall, August 5.

As several Artificers and Manufacturers, Subjects of Great Britain, have, from Time to Time, gone into Foreign Countries to exercise their several Callings, contrary to the Laws of these Kingdoms, the solowing Abstracts of Acts of Parliament of Their late Majestics King George the First and Second and of His present Majesty, for preventing such Practices, are published, for the Information of all Persons who may be ignorant of the Penalties they may incur by Disobedience to them: And it will be observed, that such Penalties likewise extend to those who are any ways concerned or instrumental in the Sending or Enticing Artificers or Manufacturers out of these Kingdoms, or in the Exportation of the Tools and Instruments used by them, as well as to the Artificers or Manufacturers themselves:

#### Statute 5 George I. Chap. 27.

If any Person shall contract with, entice, or solicit, any Artificer in Wool, Iron, Steel, Brass, or other Metal, Clock-maker, Watch-maker, or any other Atificer of Great Britain, to go into Roreiga Countries out of the King's Deminions, and shell be convicted thereof, upon Indiament or Information in any of the Courts at Westminster, or at the Assizes or Quarter-Schoons, he shall be fined any Sum not exceeding ONP HAINDRED POUNDS for the first Offence, and shall be imprisoned Three Months, and till the Fine be paid. And if any Person having been once convicted shall offend again he shall be fined at the Discretion of the Court, and imprisoned Twelve Wooths, and till the Fine be paid.

If any of the King's Subjects, being such Artificers, shall go into any Country out of His Majesty's Dominions, to exercise or teach the said Trades to Foreigners; and if any of the King's Subjects in any such Foreign Country, exercising any of the said Trades, shall not return into this Realm within Six Months after Warning given by the Ambassador, Minister or Consul of Great Britain, in the Country where such Artisicers shall be, or by any Person authorised by such Ambassador,

Ecc or by one of the Secretaries of State, and from henceforth inhabit within this Realm; such Persons shall be incapable of taking any Legacy, or of being an Executor or Administrator, or of taking any Lands, &c. within this Kingdom, by Descent, Device or Purchase, and shall forfeit all Lands, Goods, &c. within this Kingdom, to His Majesty's Use, and shall be deemed Alien, and out of Hie Majesty's Protection.

Úpon Complaint made, upon Oath, before any Justice of Peace, that any Person is endeavour-ing to seduce any such Artiscer, or that any such Artificer hath contracted or is preparing to go out of His Majesty's Dominions, for the Purposes aforefaid, such Justice may fend his Warrant to bring the Person complained of before him, or before some other Justice; and if it shall appear by the Oath of one Witness, or by Confession, that he was guilty of any of the faid Offences, such Justice may bind him to appear at the next Affizes or Quarter Seffions: And, if such Person shall refuse to give Security, the Justice may commit him to Goal till the n xi Affizes or Quarter Seffions, and until he shall be delivered by due Course of Law. And if any fuch Artificer shall be convicted, upon Indicament, of any fuch Promise, Contract, or Preparation to go beyond the Seas, for the Purpose aforesaid, he shall give such Security to the King not to depart out of His Majesty's Dominions, as such Court shall think reasonable, and shall be imprisoned till Security given.

If any of the above Offences shall be committed in Scotland, the same shall be prosecuted in the Court of Justiciary, or the Circuts there.

#### Statute 23 George II. Chap. 13.

IF any Person shall contract with, or endeavout to seduce any Artificer in Wool, Mohair, Cotton or Silk, or in Iron, Steel, Brass, or other Metal, or any Clock-maker, Watch-maker, or any other Artificer in any other of the Manufactures of Great Britain or Ireland, to go out of this Kingdom or Ireland, into any Foreign Country not within the Dominions of the Crown of Geat Britain, and shall be convicted, upon Indictment or Information, in the King's Bench at Westminster, or by Indicament at the Assizes or General Gaol Delivery for the County, wherein such Offence shall be committed in England, or by Indictment in the Court of Justiciary, or any of the Circuit Courts in Scotland, or by Indictment or Information in the King's Bench at Bublin, if fuch Offence be committed in Ireland; the Person so convicted shall, for every Artificer contracted with, or seduced, forseit FIVE HUNDRED POUNDS, and shall suffer Impriforment in the Common Goal of the County or Stewartry wherein fuch Offender shall be convicted, for Twelve Calendar Months, and until Forfeiture be paid: And in Case of a subsequent Offence of the same Kind, the Persons so again offending shall forfeit, for every Person contracted with of seduced, ONE THOUSAND POUNDS, and shall suffer Imprisonment in the Common Gaol of the County or Stewartry wherein such Offender shall be convicted, for Two Years, and until such Forfeiture be paid.

If any Person in Great Britain or Ireland shall put on Board any Ship or Boat, not bound directly to some Port in Great Britain or Ireland, or to some other of the Dominions of the Crown of Great Britain, any such Tools or Utensils as are commonly used in, or proper for the Preparing, Working up or Finishing of the Woollen or Silk Manusastures

or any Part of Inch Tools, he shall, for every Offence, forfeit all fuch Tools, or Parts thereof, put on Board, and TWO HUNDRED POUNDS, to be recovered by Action of Debt, &c. in any Court of Record at Westminster, or in the Court of Session in Scotland, or at any of the Four Courts in Dublin respectively, wherein no Essoin, &c. shall be allowed.

It shall be lawful for any Officer of the Customs in Great Britain, or for any Officer of the Revenue in Ireland, to seize and secure, in some of His Maeity's Warehouses, all such Tools or Utensils prohibited to be exported, as such Officer shall find on Board any Vessel not bound directly to some Port in Great Britain or Ireland, or to some other of the Dominions of the Crown of Great Britain; and all Tools so seized shall, after Condemnation, be publickly fold to the best Bidder; and one Moiety of the Produce shall be to the Use of His Majesty, and the other Moiety to the Officer who shall seize and secure the same.

If the Captain of any Vessel in Great Britain or Ireland knowingly permit any of the faid Tools, prohibited to be exported, to be put on Board his Vessel, he shall, for every such Offence, forfeitONE HUNDRED POUNDS, to be recovered as the Penalties inflicted upon Persons exporting the Tools; and, if the Vessel belongs to His Majesty, the Captain shall not only forfeit ONE HUNDRED POUNDS, but shall also forter his Employment. p oyment, and be incapable of any Employment

under His Majesty.

If any Officer of the Customs in Great Britain, or of the Revenue in Ireland, take, or knowingly fuffer to be taken, any Entry outward, or fign any Cocket or Sufferance for the Shipping or Exporting of any of the faid Teols, or knowingly suffer the same to be done, he shall forfeit ONE HUNDRED POUNDS, to be recovered as aforefaid, and also forfeit his Office, and be incapable of any Office under His Majesty.

One Moiety of the Forfeitures shall be applied to the Use of His Majesty, and the other Mozety to the Use of the Person who shall sue for the Same.

Statutes 14, 21, 25 and 26 of His present
Majesty.

BY these Statutes the like Penalties and For-

Teitures as above mentioned are extended to Persons packing or putting on board any Vessel, not bound directly for some Port in Great Britain or Ireland, any Machine, Engine, Tool, Press, Paper, Utenfil or Implement whatfoever, used in or proper for the working or finishing of the Cotton, Linen, Steel or Iron Manufactures of this Kingdom, or any Part or Parts of fuch Machines or Implements, or any Models or Plans thereof; and all Captains of Ships and other Persons receiving or being in Possession of any such Articles, with an Intent to export the same to Foreign Parts, and all Cuttom-house Officers suffering an Entry to be made thereof, are respectively liable to the like Penalties as are above mentioned, in the Case of Tools and Utenfils used in the Woollen and Silk Manufactures.
