BILLS of EXCHANGE and NOTES.

Stamp-Office, Somerset-Place,
September 11, 1794.

WHEREAS by an Act of the last Session of Parliament, Cap. 32, the Legislature has thought it expedient to give Relief to such Persons as may be the bona fide Holders of Bills of Exchange, Promissory or other Notes, Drafts, or Orders, written by the Drawers, with Intent to defraud or impose, upon Paper not stamped, or if stamped, not of the proper Denomination or Value, whereby the Holders of these Securities are prevented from recovering their just Demands, by reason that the same, not being stamped in pursuance of the Act of the Thirty-first Year of His present Majesty, Cap. 25, cannot be given in Evidence in any of His Majesty's Courts: Notice is hereby given to the Holders of the Bills, Notes, Drafts, or Orders abovementioned, on the 1st Day of January, 1794, that, upon producing the same to His Majesty's Commissioners of the Stamp Duties at any Time, during Office Hours, before the 1st Day of January, 1795, and then fully answering, UPON OATH OR SOLEMN AFFIRMATION, all lawful Questions relating to such Securities, to the Satisfaction of the Commissioners, they will direct their

Officers, upon Payment of the proper Duty, and the Sum of Ten Pounds over and above the said Duty, for each, to stamp the same.

Navy-Office, October 9, 1794.

THE Right Honorable the Lords Commissioners of the Treasury having appointed Money for the Payment of Half-Pay to Sea-Officers from the 1st of January to the 30th of June last, according to His Majesty's Establishment on that Behalf: These are to give Notice, that the several Payments will begin to be made at the Pay-Office, by the Treasurer of the Navy, at Eleven o'Clock in the Morning, on the following Days

viz. On Tuesday the 12th and Wednesday the 15th of this Month, to Admirals, Captains, and their Attornies.

On Thursday the 16th and Friday the 17th to Lieutenants and their Attornies:

And on Saturday the 18th to Masters and Surgeons.

After which the List will be recalled the First and Third Wednesdays in every Month, that all Persons may then and there attend to receive what may become payable to them; and not only to bring with them the Assurance required, touching their not having enjoyed the Benefit of any Public Employ, either at Sea or on Shore, during the Time they are to be paid their Half-Pay; but also to produce Certificates that they have subscribed to the Test, and taken the Oaths of Allegiance required by Act of Parliament to His present Majesty: And in case any of the said Officers should not be able to attend themselves, but employ Attornies for that Purpose, that the said Attornies do produce the like Certificates and Affidavits from the Persons they are employed by.

Where Officers are Abroad on Leave, their Agents are to produce attested Copies of such Leaves, before the Half-Pay can be paid.
