The KING's Most Excellent Majesty in Council.

THEREAS His Majelty was gracioully pleafed, by His Royal Proclamation bearing Date the Twenty-fixth Day of December, 1792, to promife and declare, that the Bounties of Five Pounds for every Able Seaman, and Two Pounds Ten Shillings for every Ordinary Seaman, fit for His Majefly's Service, fhould be paid in the Manner thereby directed to every fuch Able and Ordinary Seaman, not above the Age of Fifty nor under the Age of Twenty Years, who fhould, on or before the Twenty-eighth Day of February then following, enter themfelves to ferve in His Majefty's Royal Navy, either with the Captains or Lieutenants of His Majefly's Ships or Vesfels, or Officers employed on Shore for railing Men for the Service of the Royal Navy: And whereas His Majefty was also graciously pleased, by His faid Proclamation, to declare, that all Able-bodied Landmen, not above the Age of Thirty-five nor under the Age of Twenty Years, who should fo enter themselves as aforefaid, should receive the Sum of Thirty Shillings each Man, as His Majesty's Royal Bounty: And whereas His Majesty was also macioufly pleafed, by His Royal Proclamation bearing Date the Sixteenth Day of the faid Month of February, 1793, to promife and declare, that a Reward of Twenty Shillings for overy Able and Ordinary Seaman, fit to ferve on board His Majesty's Ships, should be paid to

Seamon who might conceal him or themfelves, for that fuch Seaman or Scamen should be taken for His Majefty's Service, on or before the Thirtieth Day of April then next, by any of His Majefty's Sea Officers appointed to raife Men on Shore, or by the Captains and Commanders of any of His Majefty's Ships or Veffels in the Ports or on the Coafts of this Kingdom : And whereas the Time limited by the faid Proclamations for Payment of the faid Bounties and Reward, hath been prolonged and extended to the Thirty-first Day of this inflant October; and it being judged expedient for His Majefty's Service that the faid Bounties and Reward thould be continued to be paid for fome Time longer; His Majefty, with the Advice of His Privy Council, doth therefore order, and it is hereby accordingly ordered, that the Time limited for Payment of the faid Bounties and Reward be prolonged and extended, from the faid Thirty-first Day of this instant October, to the Thirty-first Day of December next, inclusive : Whereof all Perfons concerned are to take Notice, and govern themfelves accordingly.

Copy of a Letter from Sir Edward Pellew, Captain of His Majeff's Ship the Arethylu, to Mr. Stephens, dated off the Start, the 24th Inflant.

SIR.

I Beg you will be pleafed to inform their Lordships, that I failed, with the Ships under my Command, as per Margin +, agreeable to their Orders, on Sunday Morning the 19th, from Cawland Bay; and the Wind having given me the Opportunity, on the following Evening I fhaped a Courfe for Uthant, with the Hope of falling in with any Ships which might leave the Port of Bieft on the Commencement of the Eatlerly Wind ; the Success of this Intention affords me the Pleafure of begging you to acquaint my LordsCommiffioners, that, at Day-Break in the Morning of the 21ft, Ufhant bearing East about Eight or Ten Leagues, we had the good Fortune to fall in with the French National Frigate La Revolutionnaire, to which the Whole of the Squadron gave Chace. The Advantage of being to Windward permitted our cutting her off from the Land; and the fuperior failing of the Artois afforded to Captain Nagle the happy Opportunity of diffinguithing himfelf by a wellconducted Action of Forty Minutes, when La Re-volutionnaire firitck her Colours to His Majeky's Ship Artois, which fhe was induced to do by the near Approach of the reft of the Squadron ; and perceiving the Diamond in the Act of taking a Polition under her Stein to take her, the Ship's Company reufed to defend her any longer. She had fearcely furrendered when the Breakers of the Saints were difcovered ahead, although very hazy Weather.

The dithefted and crippled State of the Ehemy allows me the Opportunity of faying, that her Retiltance could have been of no Avail, had the Artois been alone; and if an Officer of nearly the fame Standing may be permitted, without Prefumption, to offer, his Sentiments on the Conduct of another, I thould not confine myfelf in my Expressions of Approbation on the Behaviour of Captain Nagle; and I have much Pleasure in adding, that he fpeaks in the higheft Terms of the Gallantry and good Conduct of his Officers and Ship's Company, lamenting, as we all do, the Lofs of a very gallant and worthy Officer, in Lieutenant Craigy of the Marines, who, with Two Men killed, and Five wounded, are the Sufferers on this Occafion.

La Revolutionnaire is a remarkable fine new Frigate, most completely fitted, and of large Dimensions; being 159 Feet long and 41 Feet 7 Inches wide, built at Havre de Grace, and never before at Sea. She failed Eight Days fince on her Way to Brefl, and was commanded by Cicizen Thevenard, moanting 44 Gans \*, 28 on her Main Deck and 16 on her Quarter Deck and Forecastle, and manned with 370 Min, 8 of whom were killed and 5 wognded; among the latter is her Captain, flightly.
