Westminster, December 30, 1794.

HIS Day His Majesty came to the House of Peers, and being in His Royal Robes seated on the Throne with the usual Solemnity, Sir Francis Molyneux, Gentleman Usher of the Black Rod, was sent with a Message from His Majesty to the House of Commons, commanding their Attendance in the House of Peers. The Commons being come thither accordingly, His Majesty was pleased to make the following most gracious Speech:

My Lords, and Gentlemen,

A FTER the uniform Experience which I have had of your zealous Regard for the Interests of My People, it is a great Satisfaction to Me to recur to your Advice and Affistance at a Period which calls for the full Exertion of your Energy and Wisdom.

Notwithstanding the Disappointments and Reverses which We have experienced in the Course of the last Campaign, I retain a firm Conviction of the Necessity of perfetting in a vigorous Prosecution of the just and necessary War in which We are engaged.

You will, I am confident, agree with Me, that it is only from Firmness and Perseverance that We can hope for the Restoration of Peace on safe and honourable Grounds, and for the Preservation and permanent Security of Our dearest Interests.

In confidering the Situation of Our Enemies, you will not fail to observe, that the Efforts which have led to their Successes, and the unexampled Means by which alone those Efforts could have been supported, have produced among themselves the pernicious Ef-

fects which were to be expected; and that every Thing which has passed in the Interior of the Country has shewn the progressive and rapid Decay of their Resources, and the Instability of every Part of that violent and unnatural System, which is equally ruinous to France and incompatible with the Tranquillity of other Nations.

The States General of the United Provinces have nevertheless been led, by a Sense of present Difficulties, to enter into Negotiations for Peace with the Party now prevailing in that unhappy Country. No established Government or independent State can, under the present Circumstances, derive real Security from such Negotiations: On Our Part, they could not be attempted without facrificing both Our Honour and Safety to an Enemy whose chief Animosity is avowedly directed against these Kingdoms.

I have therefore continued to use the most effectual Means for the further Augmentation of My Forces; and I shall omit no Opportunity of concerting the Operations of the next Campaign with such of the Powers of Europe as are impressed with the same Sense of the Necessity of Vigour and Exertion. I place the fullest Reliance on the Valour of My Forces, and on the Affection and Public Spirit of My People, in whose Behalf I am contending, and whose Sasety and Happiness are the Objects of My constant Solicitude.

The local Importance of Corfica, and the spirited Efforts of it's Inhabitants to deliver themselves from the Yoke of France, determined me not to with-

hold the Protection which they fought for; and I have fince accepted the Crown and Sovereignty, of that Country, according to an Influence, a Copy of which I have directed to be laid before you.

I have great Pleafure in informing you, that I have concluded a Treaty of Amity, Commerce, and Navigation, with the United States of America, in which it has been My Object to remove, as far as possible, all Grounds of Jealousy and Misunderstanding, and to improve an Intercourse beneficial to both Countries.—As soon as the Ratisfications shall have been exchanged, I will direct a Copy of this Treaty to be laid before you, in order that you may consider of the Propriety of making such Provisions as may appear necessary for carrying it into Essect.

I have the greatest Satisfaction in announcing to you the happy Event of the Conclusion of a Treaty for the Marriage of My Son the Prince of Wales with the Princess Caroline, Daughter of the Duke of Brunswick: The constant Proofs of your Affection for My Person and Family persuade Me that you will participate in the Sentiments I feel on an Occasion fo interesting to my Domestic Happiness, and that you will enable Me to make Provision for such an Establishment as you may think suitable to the Rank and Dignity of the Heir Apparent to the Crown of these Kingdoms.

#### Gentlemen of the House of Commons,

The Confiderations which prove the Necessity of a vigorous Profecution of the War will, I doubt not, induce you to make a timely and ample Provision for the several Branches of the Public Service, the Estimates for which I have directed to be laid before you. While I regret the Necessity of large additional Burthens on My Subjects, it is a just Confolation and Satisfaction to Me to observe the State of Our Credit, Commerce, and Resources, which is the natural Result of the continued Exertions of Industry under the Protestion of a free and well-regulated Government.

My Lords, and Gentlemen,

A just Sense of the Bieslings now so long enjoyed by this Country will, I am persuaded, encourage you to make every Effort, which can enable you to transmit those Bieslings unimpaired to your Petlerity.

I entertain a confident Hope that, under the Protection of Providence, and with Confiancy and Perfeverance on Our Part, the Principles of focial Order, Morality, and Religion, will ultimately be fuccessful; and that My faithful People will find their present Exertions and Sacrifices rewarded by the secure and permanent Enjoyment of Tranquillity at

Home, and by the Deliverance of Europe from the greatest Danger with which it has been threatened since the Establishment of civilized Society.

THEREAS His Majesty was graciously pleased, by His Royal Proclamation bearing Date the Twenty-fixth Day of December, 1792, to promise and declare, that the Bounties of Five Pounds for every Able Seaman, and Two Pounds Ten Shillings for every Ordinary Scaman, fit for hiis Majesty's Scrvice, should be paid in the Manner thereby directed to every such Able and Ordinary Seaman, not above the Age of Fifty nor under the Age of Twenty Years, who should, on or before the Twenty-eighth Day of February then following, enter themselves to serve in His Majesty's Royal Navy, either with the Captains or Lieutenants of His Majesty's Ships or Vessels, or Officers employed on Shore for raising Men for the Service of the Royal Navy: And whereas His Majesty was also graciously pleased, by His said Proclamation, to declare, that all Able-bodied Landmen, not above the Age of Thirty-five nor. under the Age of Twenty Years, who should so enter themselves as aforesaid, should receive the Sum of Thirty Shillings each Man, as His Majesty's Royal Bounty: And whereas His Majesty was also graciously pleased, by His Royal Proclamation bearing Date the Sixteenth Day of the faid Month of February, 1793, to promise and declare, that a Reward of Twenty Shillings for every Able and Ordinary Seaman, fit to ferve on board His Majesty's Ships, should be paid to any Person who should discover any Seaman or Seamen who might conceal him or themselves, so

that such Seaman or Seamen should be taken for lawful Questions relating to such Securities, to the Sa His Majelly's Service, on or before the Thirtieth Day of April then next, by any of His Majesty's Sea Officers appointed to raife Men on Shore, or by the Captains and Commanders of any of His Majesty's Ships or Vessels in the Ports or on the Coasts of this Kingdom: And whereas the Time limited by the faid Proclamations for Payment of the said Bounties and Reward, hath been prolonged and extended to the Thirty-first Day of this inflant December; and it being judged expedient for His Majesty's Service that the said Bounties and Reward mould be continued to be paid for fome Time longer; His Majesty, with the Advice of His Privy Council, doth therefore order, and it is hereby accordingly ordered, that the Time limited for Payment of the faid Bounties and Reward be prolonged and extended, from the faid Thirty-first Day of this instant December, to the Twenty-eighth Day of February, 1795, inclusive: Whereof all Persons concerned are to take Notice, and govern themselves accordingly.
