PRESENT.

The KING's Most Excellent Majesty in Council.

HEREAS it has been represented to His Majesty at this Board, that the malignant and contagious Fever, of the Nature of the Plague, which fome Time fince manifested itself at Baltimore in the State of Maryland, has ceased: His Majesty, taking the same into Consideration, and being defirous to remove all Restraints upon Trade, so far as may be consistent with the Safety of His Subjects, is pleafed, by and with the Advice of His Privy Counvil, to order, and it is hereby ordered, that the Quarantine, laid by His Majesty's Order in Council, bearing Date the 12th Day of November, 1794, upon all Ships, Vessels, Persons, Goods and Merchandize, now arrived, or that shall hereafter arrive from Baltimore, or any other Port or Place in the faid State of Maryland, in the United States of America, be taken off; and that all fuch Ships and Vessels be permitted to discharge their respective Ladings, without unpacking, opening and airing, and without performing any Quarantine, as freely as they might have done, in case such Order of the 12th Day of November, 1794, had not been made, any Thing in the faid Order contained to the contrary notwithstanding; provided that the Masters or other Perions, having Charge of fuch Ships or Vessels respectively, do first make Oath, before the Custom-House Officer or Chief Magistrate as the Places respectively

at which such respective Ships or Vessels have are rived, or shall arrive, that their Crews are free from all Insection.—And the Right Honorable the Lords Commissioners of His Majesty's Treasury, the Commissioners for executing the Office of Lord High Admiral of Great Britain, the Lord Warden of the Cinque Ports, the Master General of the Ordnance, His Majesty's Secretary at War, and the Governors or Commanders in Chief, for the Time being, of the Isles of Jersey, Guernsey, Alderney, Sark and Man, are to give the necessary Directions herein as to them may respectively appertain.

WHEREAS His Majesty was graciously pleased, by His Royal Proclamation bearing Date the Twenty-sixth Day of December, 1792, to promise and declare, that the Bounties of Five Pounds for every Able Seaman, and Two Pounds Ten Shillings for every Ordinary Seaman, sit for His Majesty's Service, should be paid in the Manner thereby directed to every such Able and Ordinary Seaman, not above the Age of Fifty nor under the Age of Twenty Years, who should, on or before the Twenty-eighth Day of February then following, enter themselves to serve in His Majesty's Royal Navy, either with the Captains or Lieutenants of His Majesty's Ships or Vessels, or
