: P RESENT, The KING's Most Excellent Majesty in Council. HEREAS by an Order in Council, dated the Thirteenth Day of February last, it was ordered by His Majefty, by and with the Advice of His Privy Council, in pursuance of an Act passed in the last Session of Parliament, and mentioned in the faid Order, that from and after the Date of the fuid Order, until the Thirtieth Day of September next, no Perfon or Perfons whatfoever fhould export, or lay on Board any Ship or Veffel with Intent to export, from any Port or Place of this Kingdom, any Wheat, Rye, Barley, Beer or Bigg, Peafe, Beans, Oats, Indian Corn or Maize, or any Meal or Flour, or Bread, Bifcuit or Malt made thereof, fubject to the Provisoes and Exceptions in the faid Order contained ; and further, that it fhould be lawful, for the fame limited Time, to import into any Port or Place of this Kingdom any Foreign Corn or Articles as aforefaid, in any British Ship or Veflel, or in any other Ship or Veflel belonging to Perfons of any Kingdom or State in Amity with His Majefty, and navigated in any Manner whatever, without Payment of any Duty whatfoever; and alfo to take out of Warehoufe, for Home Confumption, any fuch Foreign Corn or other Articles as aforefaid, without Payment of any Duty whatficever: And whereas it is judged expedient that the faid Prohibition to export,

and the faid Permission to import, should be continued for a longer Time ; His Majefty therefore, by and with the Advice of His Privy Council, purfuant to the Powers given by the faid Act, passed in the last Session of Parliament, hath thought fit to order, and it is hereby ordered, that the faid riohibition to export, or to lay on Board any S. ip or Veffel with Intent to export, any Corn or Articles as aforefaid, fubject to the Frovisoes and Exceptions in the faid Order contained, and that the faid Permiffion to import Foreign Corn and other Articles as aforefaid, and to take the fame out of Warehouse for Home Confumption, without Payment of any Duty whatfoever, fhall continue and remain in Force until the Expiration of Six Weeks from the Commencement of the next Selfion of Parliament. And the Right Honourable the Lords Commissioners of His Majefty's Treasury are to give the necessary Directions herein accordingly.

HE following are Extracts of Letters from Admiral Sir John Laforey, Bart. Commander in Chief of His Majeity's Ships and Veffels at Barbadoes and the Leeward Iflands, to Mr. Nepean, bearing the Dates against each expressed.

Fort Royal, Martinique, June 23, 1795. L leutenant-General Sir John Vaughan having tignified to me on the 18th Inflant the Neceffity of withdrawing the Garrifon of St. Lucia with all poffible. Hafte, I difpatched directly fuch Ships as I could collect upon the Spot to cover and protect their Embarkation; but the Occasion prefling exceedingize.

ly, Captain John Barrett, commanding His Majesty's given to his Officers and Sloop's Company for their Ship Experiment, who was stationed at the Mouth of spirited Conduct. Ship Experiment, who was stationed at the Mouth of the Careenage to co-operate with the Garrifon, at the Defire of General Stewart, embarked the Whole in his own Ship and a Transport, to the Amount of 1200, between the Hours of Twelve at Night and Eive in the Morning, and got them fafe out of Gun-Shot, except fome Sick and fome Women, who were tee distantly fituated to benefit by his En-deavours for them. The latter were, however, fent over to us the next Day.

St. Pierre's, Martinique, June 26, 1795.

SINCE my Letter of the 23d Instant, His Majesty's Brig the Drake has arrived, whofe Commander parted from the West India Convoy in Lat. 42. 52. North, and Long. 11. 47. Weft, in a very hard Gale of Wind, which he thinks must have greatly difperfed the Whole.

Since the Drake left Barbadoes, I have received a Letter from Governor Ricketts, informing me of the Arrival at that Island of a Part thereof, and of the Capture of fome, a Lift of which I inclose. I am hastening forward Two Frigates, One of which I will fend with all possible Dispatch to Windward of Defeada, and the other off Bartholomew's, where the Enemy fend most of their Prizes, to recover as many of the Captures as may be.

St. Pierre's, Martinique, June 30, 1795.

THE Packet which came here Yesterday, brought me a Letter from Captain Charles John Moore Mansfield, Commander of His Majetty's Ship Andromache, who is arrived at Barbadoes, acquainting me that about 40 Sail of the Convoy have reached that Island. He confirms the Account of the Captures made by the Enemy, of which a Lift is inclosed, in my Letter of the 26th Instant.

The Matilda Frigate, which I had stationed off Baffeterre, Guadaloupe, returned to me Yesterday. Her Commander informed me that he had, on the 28th, fallen in with Nine Sail of Ships going into that Port, Three of which were large Frigates, and chaced him off. Thefe must be the fame that have been cruizing to Windward of Barbadoes, with the Prizes they have made.

Extract of a Letter from Vice-Admiral Caldwell, late Commander in Chief of His Majefty's Ships and Veffels at Bartaloes and the Leeward Islands, to Mr. Nepean, dated at Spithead the 29th of July, 1795.

CAptain Otway, of His Majefty's Sloop Thorn, informed me, that, on the 25th of May, he captured a French Ship of War called the Courier National, of 18 Nine and Six Pounders, and 110 Men. That on his coming up with her he imme-diately laid her on Board, and, after an Atlion of Thirty-five Minutes, (during which Two Attempts were made to board the Thorn) the Enemy fruck: The Thorn had only 5 Men wounded, and the French Ship 7 killed and 20 wounded. From Captain Otway's Report too much Praise cannot be

Rear-Admiral Thompson returned to Martinique on the 13th of June, after feeing the Convoy in Safety to 24 Deg. 8 Min. North, and on his Way back captured the Perdrix, a French Ship of War of 24 Guns.

I is with peculiar Satisfaction I transmit to you, for their Lordships Information, the inclosed Letter, which I received this Evening by the Fox Cut-ter, from Captain Towry, of His Majesty's Ship the Dido, giving an Account of a moft gallant and fpi-rited Action, which took place on the 24th Inftant, between that Frigate, in Company with the Lowe-ftoffe, Captain Middleton, on their Way to reconnoitre off the Hieres Islands, and the Two French Frigates named in the Margin*, the I ermination of which Conteft by the Capture of La Minerve, when the great Superiority of the Enemy's Force is considered, reflects the highest Honour on the Captains, Officers and Crews of the Dido and Lowettoffe. SIR, This Day dispatch the Fox Cutter to communi-Ĵ cate to you, that, in the Execution of your Inftructions of the 22d Inftant, with His Majefty's Ship Loweltoffe under my Orders, being, at Daylight of the 24th, in Latitude 41 Deg. 8 Min. and Longitude 5 Deg. 30 Min. E. we difcovered and chaced Two French Frigates; after some manœuvring they flood towards us, and, at a Quarter before Nine, A. M. the Dido, leading down, commenced a close Action with the headmost of the Enemy's Ships, which falling twice on Board, was at an early Period much difabled from the Lofs of her Bowsprit, Foremalt, and Main-top-Malt; our Mizen-maît being thot away, Fore and Main-top-fails perfectly uleles, we no longer kept-to, at which Time the Lowestoffe opened a well-directed Fire; the Enemy's fecond Frigate then passing, and exchanging the opposite Broadsides, His Majesty's Ships were kept on the fame Tack till file went about, when fearing the might fland to the Affiftance of the difinatted Ship, the Lowestoffe was fent in Chafe; the French Frigate escaped by superior Sailing, leaving her Friend to be raked, in a very judicious Manner, on the Return of the Lowestoffe, , to whole Fire the furrendered about Noon. The Dido having cleared the Wreck of the Mizen-maft, and bent new Topfails, joined in fecuring the Prize, La Minerve, a new Ship, of 42 Guns, Eighteen-Poun-ders, on the Main Deck, and 330 Men, a remarkably fait failer. Her Companion we learnt to be L'Artemife, of 36 Guns.

Having given a Detail of the Action, it becomes as much my Duty as it is my Inclination to acknowledge the very able Support of His Majefty's Ship Loweftoffe, and to teftify, that by Captain Middle-

ton's good Conduct the Bufineis of the Day was, in a great Measure, brought to a fortunate Isue. I must at the fame Time, pay the just Tribuce of my warmest Gratitude to the Officers and Ship's Company I have the Honor to command ; and it is with deep Regret I add, that Lieutenant Buckol, (First of the Dido) a most active Officer, is among the wounded, I fear feverely, though he never quitted the Deck ; Mr. Douglas, the Boatfwain, a deferving Man, is killed. Captain Middleton's Report of the Conduct of the Officers and People of the Loweitoffe is also highly flattering.

I have the Honor to enclose a Lift of the Killed and Wounded. Having received Information from the Prifoners that the French Fleet were actually at Sea, the State of the Ships obliged me to run for this Port, where I propole fitting Jury-Mafts in the Prize, and proceeding to Ajaccio. Circumstances are, I hope, sufficiently strong to plead my Excuse for not fully executing your former Orders. I remain with Respect, Yeu
