

A^T the Court at St. James's, the 29th of July, 1795,

P R E S E N T, The KING's Moft Excellent Majefty in Council.

WHEREAS by an Order in Council, dated the Thirteenth Day of February last, it was ordered by His Majesty, by and with the Advice of His Privy Council, in purfuance of an Act paffed in the last Session of Parliament, and mentioned in the faid Order, that from and after the Date of the faid Order, until the Thirtieth Day of September next, no Perfon or Perfons whatfoever fhould export, or lay on Board any Ship or Vefiel with Intent to export, from any Port or Place of this Kingdom, any Wheat, Rye, Barley, Beer or Bigg, Peafe, Beans, Oats, Indian Corn or Maize, or any Meal or Flour, or Bread, Biscuit or Malt made thereof, fubject to the Provisoes and Exceptions in the faid Order contained ; and further, that it should be lawful, for the fame limited Time, to import anto any Port or Place of this Kingdom any Foreign Corn or Articles as aforefaid, in any British Ship or Veffel, or in any other Ship or Veffel belonging to Perfons of any Kiegdom or State in Amity with His Majesty, and navigated in any Manner whatever, without Payment of any Duty whatfoever; and also to take out of Warehouse, for Home Confumption, any fuch Foreign Corn or other Articles as aforefaid, without Payment of any Duty whatfoever : And whereas it is judged expedient that the faid Prohibition to export,

and the faid Permiffion to import, should be con tinued for a longer Time; His Majesty therefore, by and with the Advice of His Privy Council, purfuant to the Powers given by the faid Act, passed in the last Session of Parliament, hath thought fit to order, and it is hereby ordered, that the faid Prohibition to export, or to lay on Board any Ship or Veffel with Intent to export, any Corn or Articles as aforefaid, fubject to the Provisoes and Exceptions in the faid Order contained, and that the faid Permission to import Foreign Corn and other Articles as aforefaid, and to take the fame out of Warehoufe for Home Confumption, without Payment of any Duty whatfoever, shall continue and remain in Force until the Expiration of Six Weeks from the Commencement of the next Seffion of Parliament. And the Right Honourable the Lords Commissioners of His Majefty's Treafury are to give the neceffary Directions herein accordingly.

A^T the Court at St. James's, the 22d of July, 1795,

PRESENT,

The KING's Most Excellent Majesty in Council.

W HEREAS the Time limited by His Majefty's Order in Council of the Fourteenth of January laft, prohibiting the transporting into any Parts out of this Kingdom any Pig-Iron, Bar-Iron, Hemp, Pitch, Tar, Rosin, Turpentine, Aachors, Cables, Cordage, Maft', Yards, Bowsprits, Oats, Oars, Oakum, Oker, Sheet-Copper, or other Naval Stores, will expire upon the Twenty-fifth Day of this inftant July : And whereas it is judged expedient for His Majesty's Service, and the Safety of this Kingdom, that the faid Prohibition should be continued for fome Time longer; His Majesty doth therefore, with the Advice of Hi Privy Council, hereby order, require, prohibit and command, that no Perfon or Perfons whofoever do at any Time, for the Space of Six Months, to commence from the faid Twenty fifth Day of this inftant July, presume to transport into any Parts out of this Kingdom, any Pig Iron, Bar-Iron, Hemp, Pitch, Tar, Rofin, Turpentine, Anchors, Cables, Cordage, Masts, Yards, Bowsprits, Oars, Oakum, Oker; Sheet-Copper, or other Naval Stores, or thip or lade any of the Articles above mentioned on board any Ship or Veffel, in order to transporting the fame into any Parts beyond the Seas, without Leave or Permiffion being first had and obtained from His Majefty or His Privy Council, upon Pain of incurring the Forfeitures inflicted by an Act, paffed in the Thirty third Year of His Majefty's Reign, intituled, "An Act to ena-" ble His Majefty to reftrain the Exportation of Na-** val Stores, and more effectually to prevent the Ex-" portation of Salt-Petre, Arms and Ammunition, ** when prohibited by Proclamation or Order in " Council." But it is, neverthelefs, His Majefly's Pleasure, that nothing herein contained shall extend, or be confirued to extend, to any of His Majefty's Ships of War, or any other Ships or Veffets or Boats, in the Service of His Majefty, or employed or freighted by His Majefly's Board of Ordnance, or by the Commissioners of His Majefly's Navy; nor to prevent any Ship or Veffel from taking or having on Board fuch Quantities of Naval Stores as may be necessary for the Use of fuch Ship or Veffel during the Course of her intended Voyage; or by Licence from the Lord High Admiral of Great Britain, or the Commissioners of the Admiralty for the Time being; nor to the Exportation of the faid feveral Articles to Ireland, or to His Majelty's Yards or Garrisons, or to His Majefly's Colonies or Plantations in America or the Weft Indies, or to Newfoundland, or to His Majefty's Forts and Settlements on the Coaft of Africa; or to the Island of St. Helena, or the British Settlements or Factories in the East Indies; provided that, upon the Exportation of any of the faid Articles, for the Purpofes of Trade, to Ireland, or to His Majefty's Yards or Garrifons, or to His Majesty's Colonies and Plantations in America or the Weft Indies, or to the Island of New-

toundland, or to His Majefly's Forts and Settlements on the Coaft of Africa, or to the Island of St. Helena, or the British Settlements or Factories in the East Indies, the Exporters of fuch Articles do first make Oath of the true Destination of the fame to the Places for which they fhall be entered Outwards, before the Entry of the fame shall be made, and do give full and fufficient Security by Bond, to the Satisfaction of the Commissioners of His Majefly's Cufloms, to carry the faid Articles to the Places for which they are fo entered Outwards; and for the Purpofes specified, and none other; and fuch Bond shall not be cancelled or delivered up, until Proof be made, to the Satisfaction of the faid Commissioners, by the Production, within a Time to be fixed by the faid Commiffioners, and fpecified in the Bond, of a Certificate or Certificates, in fuch Form and Manner as shall be directed by the faid Commissioners, shewing that the faid Articles have been duly landed at the Places for which they were entered Outwards. And the Right Honourable the Lords Commiffioners of His Majefty's Treasury, the Commissioners for executing the Office of Lord High Admiral of Great Britain, and the Lord Warden of the Cinque Ports, are to give the necessary Directions herein, as to them may respectively appertain.

Extract of a Letter from Admiral Hotham, Commander in Chief of His Majefty's Ships in the Mediterranean, to Mr. Nepean, dated Britannia,. at Sea, July 14, 1795.

SIR,

WOU will be pleafed to inform their Lordfhips, that I difpatched on the 4th Inftant, from St. Fiorenzo, the Ships named in the Margin •, under the Orders of Captain. Nelfon, whom I directed tocall of Genoa for the Inconftant and Sonthampton Frigates that were laying there, and to take them with him, if, from the Intelligence he might there obtain, he fhould find it necefiary.

On the Morning of the 7th I was much furprized to learn that the above Squadron was feen in the Offing, returning into Port, purfued by the Enemy's Elect, which, by General De Vins's Letter, (the lateft Account I had received) I had Reafon to fuppofe were certainly at Toulon.

Immediately on the Enemy's Appearance, I made every Preparation to put to Sea after them; and. notwithstanding the unpleasant Predicament we were: in, most of the Ships being in the Midst of watering and refitting, I was yet enabled, by the Zeal and extraordinary Exertions of the Officers and Men, to get the whole of the Fleet under Weigh that Night, as foon as the Land Wind permitted us to move ; from which Time we neither faw or heard any thing: of the Enemy till the 12th, when being to the Eastward, and within Sight of the Hieres Islands, Two Veffels were fpoken with by Captain Hotham of the Cyclops and Captain Boys of La Fleche, who acquainted them they had feen the French Fleet, not. many Hoars before, to the Southward of those Islands : Upon which Information I made the Signal before Night to prepare for Battle, as an Indication: to our Fleet that the Enemy was near.

Yesterday, at Day-Break, we discovered them to Leeward of us, on the Larboard Tack, confisting of Twenty three Sail, Seventeen of which proved to be of the Line: The Wind at this Time blew veryhard from the W. N. W. attended with a heavy Swell, and Six of our Ships had to bend Main-Topfails, in the room of those that were split by the Gale, in the Course of the Night.

I caufed the Fleet, however, to be formed, with all poffible Expedition, on the Larboard Line of Bearing, carrying all Sail poffible to preferve that Order, and to keep the Wind of the Enemy, in the Hopes-

of

of cutting them off from the Land; from which we were only Five Leagues distant.

At Eight o'Clock, finding they had no other View but that of endeavouring to get from us, I made the Signal for a general Chace, and for the Ships to take. fuitable Stations for their mutual Support, and to engage the Enemy as arriving up with them in Suceeffion; but the baffling Winds and vexatious Calms, which render every Naval Operation in this Country doubtful, foon afterwards took Place, and allowed a few only of our Van Ships to get up with the Enemy's Rear about Noon, which they attacked fo warmly, that, in the Courfe of an Hour after, we had the Satisfaction to find one of their Sternmost Ships, viz. L'Alcide, of Seventy-four Guns, had struck; the Reft of their Fleet, favoured by a Shift of Wind to the Eaftward, (that placed them now to Windward of us) had got io far into Frejus Bay, whill the major Part of our's was becalmed in the Offing, that it became impossible for any thing further to be effected; and those of our Ships which were engaged had approached fo near to the Shore that I judged. it proper to call them off by Signal.

If the Refult of the Day was not fo compleatly fatisfactory as the Commencement promiled, it is my Duty to flate, that no Exertions could be more unanimous than those of the Fleet under my Command; and it would be Injustice to the general Merit of all to feleft individual Inftances of Commendation, had not Superiority of Sailing placed fome of the Ships in an advanced Situation, of which they availed themfelves in the most diffinguished and honourable Manner; and amongst the Number was the Victory, having Rear-Admiral Man on Board, who had shifted his Flag to that Ship upon this Occasion.

I am forry to fay that the Alcide, about Half an. Hour after the had furuck, by fome Accident caught Fire in her Fore-Top, before the was taken Possession of, and the Flames fpread with fuch Rapidity that the whole Ship was foon in a Blaze; feveral Beats from the Fleet were difpatched as quickly as possible to refcue as many of her People as they could fave from the Deftruction that awaited them, and Three Hundred of them were in confequence preferved, when the Ship blew up with the most awful and tremendous Explosion, and between Three and Four Hundred People are supposed to have perished.

Inclosed herewith is a Litt of the Killed and Wounded on Board the different Ships that were engaged, by which their Lordships will perceive our Lois has not been great; and I have the Pleafure to add, that the Damages fultained by those Ships have been fuch as can eafily be remedied.

Had we fortunately fallen in with the Enemy any Diftance from the Land, I flatter myfelf we should have given a decifive Blow to their Naval Force in these Seas; and although the Advantage of Yesterday may not appear to be of any great Moment, I yet hope it will have ferved as a Check upon their prefent Operations, be they what they may.
