AT the Court at Weymouth, the 15th of September,

PRESENT,

The KING's Most Excellent Majesty in Council. 7HEREAS the Countries belonging to the United Provinces have, for some Time past, been, and still continue, in the Possession of the Armies of France, and under the immediate Influence and Direction of the Persons who exercise the Powers of Government in France: And whereas divers injurious Proceedings have lately been had in the faid United Provinces, in Derogation of the Honour of His Majesty's Crown, and the just Rights of His Subjects; and Ships of War, fitted out from the Ports of the faid United Provinces, have received Orders to take and destroy all British Vessels, and some British Vessels have been actually so taken:-His Majesty, therefore, being determined to take such Measures as are necessary for vindicating the Honour of His Crown, and for procuring Reparation and Satisfaction, is pleafed, by and with the Advice of His Privy Council, to order, and it is hereby ordered, that General Reprizals be granted against the Ships, Goods and Subjects of the United Provices, fo that as well His Majesty's Fleet and Ships, as also all other Ships and Vessels that shall be commissionated by Letters of Marque or General Reprizals, or otherwise, by His Majesty's Commissioners for executing the Office of Lord High Admiral of Great Britain, shall and may lawfully seize all Ships,

Veffels and Goods belonging to the United Provinces, or their Subjects, or others inhabiting within any of the Territories of the aforefaid United Provinces, and bring the same to Judgment in any of the Courts of Admiralty within His Majesty's Dominions: And to that End His Majesty's Advocate General, with the Advocate of the Admiralty, are forthwith to prepare the Draught of a Commission, and present the same to His Majesty at this Board, authorizing the Commissioners for executing the Office of Lord High Admiral, or any Person or Perfons by them empowered and appointed, to iffue forth and grant Letters of Marque and Reprizal to any of His Majesty's Subjects, or others, whom the said Commissioners shall deem fitly qualified in that Behalf, for the apprehending, feizing and taking the Ships, Vessels and Goods belonging to the United Provinces, and their Vassals and Subjects, or any inhabiting within the Countries, Territories or Dominions of the aforelaid United Provinces; and that fuch Powers and Clauses be inserted in the faid Commillion as have been usual, and are according to former Precedents. And His Majesty's said Advocate General, with the Advocate of the Admiralty, are also forthwith to prepare the Draught of a Commission, and present the same to His Majesty at this Board, authorizing the faid Commissioners for executing the Office of Lord High Admiral to will and require the High Court of Admiralty of Great Briand the Lieutenant and Judge of the faid Court, his

Surrogate or Surrogates, as also the several Courts off, and that the Exportation of Rice be permitted of Admiralty within His Majesty's Dominions, to take Cognizance of, and judicially proceed upon all and all Manner of Captures, Seizures, Prizes and Reprizals of all Ships and Goods that are or shall be taken, and to hear and determine the same; and, according to the Course of Admiralty, and the Laws of Nations, to adjudge and condemn all fuch Ships, Veffels and Goods as shall belong to the United Provinces, or their Vassals and Subjects, or to any others inhabiting within any of the Countries, Territories and Dominions of the aforesaid United Provinces; and that fuch Powers and Claufes be inferted in the staid Commission as have been usual, and are according to former Precedents: And they are likewife to prepare, and lay before His Majesty at this Board, a Draught of such Instructions as may be proper to be fent to the Courts of Admiralty in His Majesty's Foreign Governments and Plantations, for their Guidance herein; as also another Draught of Instructions for such Ships as shall be commissionated for 14 : Purposes aforementioned.

HEREAS His Majesty was pleased, by His Order in Council of the 15th of July Haft sto order, That no Berson or Persons whatever hould, until further Order, directly or indirectly, export, transport, carry or convey, or cause or procure to be exported, transported, carried or conveyed, any Rice out of or from any Port or Piace in Great Britain; or load or lay on Board, or cause or procure to be loaded or laid on Board of any Ship, Vestel or Boat, any Rice, in order to be exported, transported, carried or conveyed out of any Port or Place in Great Britain, (except as in the faid Order is excepted): And whereas it has been reprefented by the Morchants, Importers of Rice from South Carolina, That the various Dealers in the Article of Rice, for Home Confumption, being amply supplied, the faid Importers can no longer find Sale for confiderable Quantities which remain on Hand, and that they are apprenentive, if the faid Prohibition costinues, that a very small Portion of the new Crop of Rice will be brought to this Kingdomy, His Majelly, taking the fame into Confideration, is pleased, by and with the Advice of his Privy Council, to order, and it is hereby ordered, That the faid Prohibition, laid by His Majesty's faid Order ! in Council of the 15th Day of July last, be taken I Captain George Redhead, from 111th Foot.

# Whitehall, September 29.

As feveral Artificers and Manufacturers, Subjects of Great Britain, have, from Time to Time, gone into Foreign Countries to exercise their several Callings, contrary to the Laws of these Kingdoms, the following Abstracts of Acts of Parliament of Their late Majeslies King George the First and Second and of His present Majesty, for preventing such Practices. are published, for the Information of all Persons who may be ignorant of the Penalties they may incur by Disobedience to them: And it will be observed, that fuch Penalties likewife extend to those who are any ways concerned or instrumental in the Sending or Enticing Artificers or Manufacturers out of theje Kingdoms, or in the Exportation of the Tools and - Instruments used by them, as well as to the Artisicers or Manufacturers themselves.

# Statute 5 George 1. Chap. 27.

F any Person shall contract with, entice, or solicit, any Artificer in Wool, Iron, Steel, Brass, or other Metal, Clock-maker. Watch-maker, or any other Atificer of Great Britain, to go into Foreign Countries out of the King's Dominions, and shall be convicted thereof, upon Indictment or Information in any of the Courts at Westminster, or at the Assizes or Quarter-Sessions, he shall be fined any Sum not exceeding ONE HUNDRED POUNDS for the first Offence, and shall be imprisoned Three Months, and till the Fine be paid. And if any Person having been once convicted shall offend again he shall be fixed at the Discretion of the Court, and imprisoned Twelve Months, and till the Fine be paid.

If any of the King's Subjects, being such Artificers, shall go into any Country out of His Majesty's Dominions, to exercise or teach the said Trades to Foreigners; and if any of the King's Subjects in any such Foreign Country, exercising any, of the said Trades, shall not return into this Realm within Six Months after Warning given by the Ambassador, Minister or Consul of Great Britain, in the Country where such Artificers shall be, or by any Person authorited by such Ambassador, &c or by one of the Secretaries of State, and from henceforth inhabit within this Realm; such Persons shall be incapable of taking any Legacy, or of being an Executor or Administrator, or of taking any Lands, &c. within this Kingdom, by Descent, De

vise or Purchase, and shall forseit all Lands, Goods, &c. within this Kingdom, to His Majesty's Use, and shall be deemed Alien, and out of His Majesty's Protection.

Upon Complaint made, upon Oath, before any Justice of Peace, that any Person is endeavouring to feduce any fuch Artificer, or that any fuch Artificer hath contracted or is preparing to go out of this Majelty's Dominions, for the Purpofes aforefaid, such Justice may send his Warrant to bring the Person complained of before him, or before some other Justice; and if it shall appear by the Oath of one Witness, or by Confession, that he was guilty of any of the said Offences, such Justice may bind him to appear at the next Affizes or Quarter Seffions: And, if such Person shall refuse to give Security, the Julice may commit him to Goal till the next Assizes or Quarter Sessions, and entil he shall be delivered by due Course of Law. And if any be delivered by due Course of Law. And if any such Artificer shall be convicted, upon Indictment, of any such Promise, Contract, or Preparation to go beyond the Seas, for the Purpose aferesaid, he shall give such Security to the King not to depart out of His Majesty's Dominions, as such Court shall think reasonable, and shall be imprisoned till Security given.

If any of the above Offences shall be committed in Scotland, the same shall be prosecuted in the Court of Justiciary, or the Circuits there.

# Statute 23 George II. Chap. 13.

IF any Person shall contract with, or endeavour to seduce any Artificer in Wool, Mohair, Cotton or Silk, or in Iron, Steel, Brass, or other Metal, or any Clock-maker, Watch-maker, or any other Artificer in any other of the Manufactures of Great Britain or Ireland, to go out of this Kingdom or Ireland, into any Foreign Country not within the Dominions of the Crown of ricat Britain, and shall be convicted, upon Indictment or Information, in the King's Bench at Westminster, or by Indictment at the Assizes or General Gaol Delivery for the County, &c. wherein such Offence shall be committed in England, or by Indictment in the Court of Justiciary, or any of the Circuit Courts in Scotland, or by Indictment or Information in the King's Bench at Dublin, if such Offence be committed in Ireland; the Person so convicted shall, for every Artificer contracted with, or seduced, forseit FIVE HUNDRED FOUNDS, and shall suffer Imprifonment in the Common Goal of the County or, Stewartry wherein such Offender shall be convicted, tor Twelve Calendar Months, and until Forfeiture be paid: And in Case of a subsequent Offence of the same Kind, the Persons so again offending shall forfeit, for every Person contracted with or seduced, ONE THOUSAND POUNDS, and shall suffer Imprisonment in the Common Gaol of the County or Stewartry wherein such Offender thall be convicted, for Two Years, and until such Forfeiture be paid.

It shall be lawful for any Officer of the Customs in Great Britain, or for any Officer of the Revenue in Ireland, to seize and secure, in some of His Ma-jelly's Warehouses, all such Tools or Utenfils prohibited to be exported, as fuch Officer shall find on Board any Vessel not bound directly to some Port in Great Britain or Ireland, or to some other of the Dominions of the Crown of Great Britain; and all Tools so seized shall, after Condemnation, be publickly told to the best Bidder; and one Moiety of the Produce shall be to the Use of His Majesty, and the other Moiety to the Officer who shall seize and secure the same.

If the Captain of any Vessel in Great Britain or Ireland knowingly permit any of the faid Tools, prohibited to be exported, to be put on Board his Vessel, he shall, for every such Offence, forfeitONE HUNDRED POUNDS, to be recovered as the Penalties inslicted upon Persons exporting the Tools; and, if the Vessel belongs to His Majesty, the Captain shall not only sorfeit ONE HUN-DRED POUNDS, but shall also forfeit his Employment, and be incapable of any Employment under His Majetty.

If any Officer of the Customs in Great Britain, or of the Revenue in Ireland, take, or knowingly foffer to be taken, any Entry outward, or fign any Cocket or Sufferance for the Shipping or Exporting of any or the faid Tools, or knowingly suffer the fame to be done, he shall forfeit ONE HUNDRED POUNDS, to be recovered as aforefaid, and also forfeit his Office, and be incapable of any Office

under His Majesty.

One Moiety of the Forfeitures shall be applied to the Use of His Majesty, and the other Moiety to the Use of the Person who shall sue for the

Statules 14, 21, 25 and 26 of His present

BY these Statutes the like Penalties and Forfeitures as above mentioned are extended to Persons packing or putting on board any Vessel, not bound directly for some Port in Great Britain or Ireland, any Machine, Engine, Tool, Press, Paper, Utenfil or Implement whatfoever, used in or proper for the working or finishing of the Cotton, Linen, Steel or Iron Manufactures of this Kingdom, or any Part or Parts of fuch Machines or Implements, or any Models or Plans thereof; and all Captains of Ships and other Persons receiving or being in Possession of any such Articles, with an Intent to export the same to Foreign Parts, and all Custom-house Officers suffering an Entry to be made thereof, are respectively liable to the like Penaities as are above mentioned, in the Cafe of Tools and Utenfils used in the Woollen and Silk Manufactures.
