HEREAS the Time limited by His Majesty's Order in Council of the 3d of June last, for prohibiting the Exportation out of this Kingdom, or carrying Coastwife, Gunpowder or Salt-Petre, or any Sort of Arms or Ammunition, will expire upon the 7th Day of this inslant December: And whereas it is judged expedient for His Majesty's Service, and the Safety of this Kingdom, that the faid Prohibition should be continued for some Time longer; His Majesty doth therefore, with the Advice of His Privy Council, hereby order, require, prohibit and command, that no Person or Persons whatsoever (except the Master-General of the Ordnance for His Majesty's Service) do, at any Time during the Space of Six Months, to commence from the faid 7th Day of this instant December, prefume to transport, into any Parts out of this Kingdom, or carry Coastwife, any Gunpowder or Salt-Petre, or any Sort of Arms or Ammunition, or ship or lade any Gunpowder or Salt-Petre, or any Sort of Arms or Ammunition, on board any Ship or Vessel, in order to transporting the same into any Parts beyond the Seas, or carrying the same Coastwise, without Leave or Permission in that Behalf first obtained from His Majesty, or His Privy Council, upon Pain of incurring and fuffering the respective Forfeitures and Penalties inflicted by an Act passed in

the Twenty ninth Year of His late Majesty's Reign, intituled, " An Act to impower His Majesty to pro-" hibit the Exportation of Salt-Petre, and to enforce " the Law for impowering His Majesty to prohibit " the Exportation of Gunpowder, or any Sort of " Arms or Ammunition; and also to empower His " Majesty to restrain the carrying Coastwise of Salt-" Petre, Gunpowder, or any Sort of Arms or Am-" munition:" - And the Right Honourable the Lords Commissioners of His Majesty's Treasury, the Commissioners for executing the Office of Lord High Admiral of Great Britain, the Lord Warden of the Cinque Ports, the Master-General of the Ordnance, and His Majesty's Secretary at War, are to give the necessary Directions herein as to them may respectively appertain. The KING's Most Excellent Majesty in Council. THEREAS the Time limited by His Majesty's Order in Council of the 10th Day of June, 1795, prohibiting the transporting into any Parts out of this Kingdom any of the Wood called Lignum Vice, will expire on the 10th Day of this instant December: And whereas it is judged expedient for His Majesty's Service that the said Prohibition should be continued for some Time longer; His Majesty doth therefore, with the Advice of His Privy Council, hereby order, require, prohibit and command, that no Person or Persons whosoever do, at

any Time, for the Space of Six Months from the faid 10th Day of this instant December, export, or attempt to export, transport, carry or convey, or lade or lay on Board of any Ship, Vessel or Boat, in order to be exported, transported, carried or conveyed out of this Kingdom, any of the Wood called Lignom Vitæ, without Leave or Permission being sirst had and obtained from His Majesty or His Privy Council, upon Pain of incurring the Forfeitures inflicted by an Act passed in the Thirty-fourth Year of His Majesty's Reign, intituled, "An Act for indemnifying all Persons who have been concerned in advising or carrying into Execution an Order of the Lords 6 Commissioners of His Majesty's Treasury respecting the Exportation of Pot-Ashes or Pearl Ashes; " for preventing Suits in consequence of the same; for authorizing His Majesty to prohibit the Ex-" portation or carrying Coastwise of Pot-Ashes or \* Pearl-Ashes, and for making further Provisions " relative thereto." But it is nevertheless His Majesty's Pleasure, that nothing herein contained shall extend, or be construed to extend, to prevent any Ship or Veffel from taking or having on Board any of the faid Wood called Lignum Vitæ, which may be necessary for the Use of the said Ship or Vessel during the Course of her intended Voyage; nor to prevent the Exportation of the faid Wood called Lignum Vitæ to Ireland, or to His Majesty's Islands of Guernsey, Jersey, Alderney, Sark or Man, or to His Majesty's Colonies or Plantations in America or the West Indies, or to Newfoundland, or to His Majesty's Forts and Settlements on the Coast of Africa, or to the Island of St. Helena, or to the British Settlements or Factories in the East Indies; provided that, upon the Exportation of the faid Wood called Lignum Vitæ to Ireland, or to His Majesty's Islands of Guernsey, Jersey, Alderney, Sark or Man, or to His Majesty's Colonies and Plantations in America or the West Indies, or to the Island of Newfoundland, or to His Majesty's Forts and Settlements on the Coast of Africa, or to the Island of St. Helena, or the British Settlements or Factories in the East Indies, the Exporters of the faid Wood called Lignum Vitæ do first make Oath of the true Destination of the same to the Places for which it shall be entered Outwards, before the Entry of the same shall be made, and do give full and sufficient Security, by Bond, to the Satisfaction of the Commissioners of His Majesty's Customs, to carry the faid Wood called Lignum Vitæ to the Places for which it is fo entered Outwards, and none other; and fuch Bond shall not be cancelled or delivered up until Proof be made, to the Satisfaction of the said Commissioners, by the Production, within a Time to be fixed by the faid Commissioners, and

fpecified in the Bond, of a Certificate or Certificates, in such Form and Manner as shall be directed by the said Commissioners, shewing that the said Wood called Lignum Vitæ has been duly landed at the Places for which it was entered Outwards.—And the Right Honorable the Lords Commissioners of His Majesty's Treasury, the Commissioners for executing the Office of Lord High Admiral of Great Britain, and the Lord Warden of the Cinque Ports, are to give the necessary Directions herein, as to them may respectively appertain.

Majesty was also graciously pleased, by his said Proclamation, to declare, that all Able-bodied Landmen, not above the Age of Thirty-five nor under the Age of Twenty Years, who should so enter themselves as aforesaid, should receive the Sum of Thirty Shillings each Man, as His Majesty's Royal Bounty: And whereas His Majesty was also graciously pleased, by His Royal Prociamation bearing Date the Sixteenth Day of the said Month of February, 1793, to promise and declare, that a Reward of Twenty Shillings for every Able and Ordinary Seaman, fit on to ferve board His Majesty's Ships, should be paid to any Person who should discover any Seeman or Seamen who might conceal him or themselves, so that fuch Seaman or Seamen should be taken for His Majesty's Service, on or before the Thirtieth Day of April then next, by any of His Majesty's Sea Officers appointed to raife Men on Shore, or by the Captains or Commanders of any of His Majesty's Ships or Vessels in the Ports or on the Coasts of this Kingdom: And whereas the Time limited by the faid Proclamations for Payment of

As feveral Artificers and Manufacturers, Subjects of Great Britain, bave, from Time to Time, gone into Foreign Countries to exercise their several Callings, contrary to the Laws of these Kingdoms, the following Abstracts of Acts of Parliament of Their late Majestics King George the First and Second and of His present Majesty, for preventing such Practices, are published, for the Information of all Persons who may be ignorant of the Penalties they may incur by Disobedience to them : And it will be observed, that such Penalties likewise extent to those who are any ways concerned or influmental in the Sending or Enticing Artificers or Manufadurers out of thefe Kingdoms, or in the Exportation of the Tools and Instruments used by them, as well as to the Artistcers or Manufacturers themselves.

#### Statute 5 George I. Chap. 27.

IF any Person shall contract with, entice, or solicit, any Artificer in Wool, Iron, Steel, Brass, or other Metal, Clock-maker, Watch-maker, or any other Atificer of Great Britain, to go into Foreign Countries out of the King's Dominions, and shall be convicted thereof, upon Indictment or Information in any of the Courts at Westminster, or at the Assizes or Quarter-Sessions, he shall be fined any Sum not exceeding ONE HUNDRED POUNDS for the first Offence, and shall he imprisoned Three Months, and till the Fine be paid. And if any Person having been once convicted shall offend again he shall be fined at the Discretion of the Court, and imprisoned Twelve Months, and till the Fine be paid.

If any of the King's Subjects, being such Artificers, shall go into any Country out of His Majesty's Dominions, to exercise or teach the said Trades to Poreigners; and if any of the King's Subjects in any such Foreign Country, exercising any of the said Trades, shall not return into this Realm within six Months after Warning given by the Ambassed, minister or Consul of Great Britain, in the Country where such Artificers shall be, or by any Person authorised by such Ambassador, &c. or by one of the Secretaries of State, and from henceforth inhabit within this Realm; such Persons shall be incapable of taking any Legacy, or of being at Executor or Administrator, or of taking any Land, &c. within this Kingdom, by Descent, Devise or Purchase, and shall forseit all Lands, Goods, &c within this Kingdom, to His Majesty's Use, and shall be deemed Alien, and out of His Majesty's Protection.

Upon Complaint made, upon Oath, before any Justice of Peace, that any Person is endeavouring to seduce any such Artificer, or that any such Artificer hath contracted or is preparing to go out of His Majesty's Dominions, for the Purposes aforesaid, such Justice may send his Warrant to bring the Person complained of before him, or before some other Justice; and if it shall appear by the Oath of one Witness, or by Confession, that he was guilty of any of the said Offences, such Justice may bind him to appear at the next Assizes or Quarter Sessions: Aud, if such Person shall resulte to give Secu-

rity, the Justice may commit him to Goal fill the next Assizes or Quarter Sessions, and until he shall be delivered by due Course of Law. And if any such Artificer shall be convicted, upon Indictment, of any such Promise, Contract, or Preparation to go beyond the Seas, for the Purpose aforesaid, he shall give such Security to the King not to depart out of His Majesty's Dominions, as such Court shall think reasonable, and shall be imprisoned till Security given.

If any of the above Offences shall be committed in Scotland, the same shall be prosecuted in the Court of Justiciary, or the Circuits there.

#### Statute 23 George II. Chap. 13.

IF any Perfon shall contract with, or endeavour to seduce any Artificer in Wool, Mohair, Cotton or Silk, or in Iron, Steel, Brass, or other Metal, or any Clock-maker, Watch-maker, or any other Artificer in any other of the Manufactures of Great Britain or Ireland, to go out of this Kingdom or Ireland, into any Foreign Country not within the Dominions of the Crown of Freat Britain, and shall be convicted, upon Indictment or Information, in the King's Bench at Westminster, or by Indictment at the Assizes of General Gaol Delivery for the County, &c. wherein such Offence shall be committed in England, or by Indictment in the Court of Justiciary, or any of the Circuit Courts in Scotland, or by Indicament or Information in the King's Bench at Dublin, if such Offence be committed in Ireland; the Person so convicted shall, for every Artificer contracted with, or seduced, forseit FIVE HUNDRED POUNDS, and shall suffer Imprifonment in the Common Goal of the County or Stewartry wherein such Offender shall be convicted, for Twelve Calendar Months, and until Forfeiture be paid: And in Case of a subsequent Offence of the fame Kind, the Persons so again offending shall forfeit, for every Person contracted with or seduced, ONE THOUSAND POUNDS, and shall suffer Imprisonment in the Common Gaol of the County or Stewartry wherein such Offender shall be convicted, for Two Years, and until such Forfeiture be paid.

If any Person in Great Britain or Ireland shall put on Board any Ship or Boat, not bound directly to some Port in Great Britain or Ireland, or to some other of the Dominions of the Crown of Great Britain, any such Tools or Utensils as are commonly used in, or proper for the Preparing, Working up or Finishing of the Woollen or Silk Manusastures or any Part of such Tools, he shall, for every Offence, forseit all such Tools, or Parts thereof, put on Board, and TWO HUNDRED POUNDS, to be recovered by Assion of Debt, &c. in any Court of Record at Westminster, or in the Court of Session in Scotland, or at any of the Four Courts in Dublin respectively, wherein no Essin, &c. shall be allowed.

It shall be lawful for any Officer of the Customs in Great Britain, or for any Officer of the Revenue in Ireland, to seize and secure, in some of His Majesty's Warehouses, all such Tools or Utensils prohibited to be exported, as such Officer shall find on Board any Vessel not bound directly to some Port in Great Britain or Ireland, or to some other of the Dominions of the Crown of Great Britain; and ail Tools so seized shall, after Condemnation, be pub-

Hickly folds to the best Bidder; and one Moiety of the Produce shall be to the Use of His Majesty, and the other Moicty to the Officer who shall seize

and fecure the fame.

If the Captain of any Vessel in Great Britzin or Ireland knowingly permit any of the faid Tools, prohibited to be experted, to be put on Board his Vestel, he shall, for every such Offence, forseitONE HUNDRED FOUNDS, to be recovered as the Penalties infifted upon Perfous exporting the Tools; and, if the Vessel belongs to His Majesty, the Captain shall not only forkit ONE HUN-DRED POUNDS, but thall also forfeit his Employment, and be incapable of any Employment under His Majefly.
