afer the Thirtieth Day of September, One Thousand Seven Hundred and Ninety-fix, shall be of any Force or Effect : And His Majesty is hereby further pleased to order, That the Master, or Person having the Charge or Command of any Ship or Vessel to whom such Licence shall be granted, shall, upon the Arrival of the faid Ship or Veffel at the Port, Harbour or Place in the Island of Newfound. land where he shall discharge such Bread, Flour, Indian Corn or Live Stock, deliver up the faid Licence to the Collector or other proper Officer of the Customs there, having first indorfed on the Back of fuch Licence the Marks, Numbers and Contents of each Package of Bread, Flour, or Indian Corn, and the Number of Live Stock, under the Penalty of the Forfeiture in the faid Act mentioned. And the Collector or other proper Officer of the Customs at Newfoundland is hereby enjoined and required to give a Certificate to the Mafter, or - Person having the Charge or Command of such Ship or Veffel, of his having received the faid Licence, fo indorfed as before directed, and to transmit the fame to the Comm slioners of His Majesty's Customs in England or Scotland, or to the Commissioners of His Majesty's Revenue in Ireland, frespectively, by whom such Licence was granted.
