A'T the Court at St. James's, the 13th of January, 1796, British Subjects and in British-built Ships owned by His Majefty's Subjects, and navigated according to

## PRESENT,

The KING's Most Excellent Majesty in Council.

WHEREAS by an Act paffed in the Twentyeighth Year of the Reign of His prefent Majefty, intituled, " An A& for regulating the Trade " between the Subjects of His Majefty's Colonies " and Plantations in North America and in the " Weft India Iflands, and the Countries belonging " to the United States of America, and between " His Majefly's faid Subjects and the Foreign Iflands " in the Welt Indies," it is, amongft other Things, enacted, That it shall and may be lawful for His Majesty in Council, by Order or Orders to be iffued and published from Time to Time, to authorize, or by Warrant or Warrants, under His Sign Manual, to impower the Governor of Newfoundland for the Time being to authorize, in cafe of Necessity, the Importation into Newfoundland of Bread, Flour, Indian Corn, and Live Stock, from any of the Territories belonging to the faid United States, for the Supply of the Inhabitants and Fishermen of the Island of Newfoundland, for the then enfuing Seafon only; provided always, that fuch Bread, Flour, Indian Corn, and Live Stock, fo authorized to be imported into the Ifland of Newfoundland, fhail not be imported except in conformity to fuch Rules, Regulations and Reftrictions as shall be specified in such Order or Orders, Warrant or Warrants, respectively, and except by

His Majefty's Subjects, and navigated according to Law. And whereas it is expedient and neceffary that Provision be made for fully supplying the Inhabitants and Fishermen of the Island of Newfoundland, for the enfuing Seafon, with Bread, Flour, Indian Corn and Live Stock 1 His Majefty doth thereupon, by and with the Advice of His Privy Coun-" cil, hereby order and declare, That, for the Supply of the Inhabitants and Fishermen of the Island of Newfoundland, for the enfuing Seafon only, Bread, Flour, Indian Corn and Live Stock be imported into the faid Island from any of the Territories belonging to the faid United States, by British Subjects, and in British-built Ships owned by His Majefty's Subjects, and navigated according to Law, and which shall, within the Space of Seven Months previous to the Time of fuch Importation, have cleared out from fome Port in Great Britain, or some other Port of His Majesty's Dominions in Europe, for which Purpole a Licence thall have been granted by the Commissioners of His Majefty's Cuftoms in England or Scotland, of the Commiffioners of His Majefty's Revenue in Ireland, or any other Perfon or Perfons who may be duly authorized in that Kingdom respectively, in the Manner and Form herein after mentioned ; which Licences shall continue and be in Force for Seven Calendar Months from the Day of the Date upon which they are respectively granted, and no longer ; provided that no fuch Licence as aforefaid, granted aft. #

after the Thirtieth Day of September, One Thou fand Seven Hundred and Ninety-fix, shall be of any Force or Effect : And His Majefty is hereby further pleafed to order, That the Master, or Person having the Charge or Command of any Ship or Veffel to whom fuch Licence shall be granted, shall, upon the Arrival of the faid Ship or Veffel at the Port, Harbour or Place in the Ifland of Newfoundland where he shall discharge such Bread, Flour, Indian Corn or Live Stock, deliver up the faid Licence to the Collector or other proper Officer of the Cuftoms there, having first indorfed on the Back of fuch Licence the Marks, Numbers and Contents of each Package of Bread, Flour, or Indian Corn, and the Number of Live Stock, under the Penalty of the Forfeiture in the faid A& mentioned. And the Collector or other proper Officer of the Cuftoms at Newfoundland is hereby enjoined and required to give a Certificate to the Malter, or Perfon having the Charge or Command of fuch Ship or Veffel, of his having received the faid Licence, fo indorfed as before directed, and to transmit the fame to the Commiflioners of His Majefty's Cuftoms in England or Scotland, or to the Commissioners of His Majefty's Revenue in Ireland, respectively, by whom fuch Licence was granted.

Now be it known that the faid [Perfon's Name] hath Licence to lade on board the faid Ship [Ship's Name], at and from any Port or Place belonging to the United States of America, Bread, Flour, Indian Corn, and Live Stock, the Produce of the faid United States, and no other Article whatfoever, and to carry the faid Bread, Flour, Indian Corn, and Live Stock to fome Port or Place in the Island of Newfoundland ; and on the Arrival of the faid Ship at any Port, Harbour, or Place of Discharge in Newfoundland, the Master, or Person having the Charge or Command of the faid Ship, is required and enjoined to deliver up the faid Licence to the Collector or other proper Officer of His Majefty's Cuftoms there, and to indorfe on the Back thereof the Marks, Numbers, and Contents of each Package of Bread, Flour, or Indian Corn, and the Number of Live Stock, and shall thereupon receive a Certificate thereof from the faid Collector or other proper Officer of the Cuftoms.

#### Whitehall, February 2.

As several Artificers and Manufacturers, Subjects of Great Britain, bave, from Time to Time, gone into Foreign Countries to exercise their several Callings, contrary to the Laws of these Kingdoms, the following Abstracts of Acts of Parliament of Their late. Majesties King George the First and Second and of His prefent Majefly, for preventing fuch Practices, are published, for the Information of all Persons whe may be ignorant of the Penalties they may incur by Difobedience to them : And it will be observed, that fuch Penalties likewife extend to those who are any ways concerned or instrumental in the Sending or Enticing Artificers or Manufasturers out of theje Kingdoms, or in the Exportation of the Tools and Instruments used by them, as well as to the Artificers or Manufacturers themfelves.

#### Statute 5 George I. Chap. 27.

I F any Perfon fhall contract with, entice, or folicit, any Artificer in Wool, Iron, Steel, Brafs, or other Metal, Clock-maker, Watch-maker, or any other Atificer of Great Britain, to go into Foreign Countries out of the King's Dominions, and fhall be convicted thereof, upon Indictment or Information in any of the Courts at Weftminfter, or at the Affizes or Quarter-Seffions, he fhall be fined any Sum not exceeding ONE HUNDRED POUNDS for the firlt Offence, and fhall be imprifoned Three Months, and till the Fine be paid. And if any Perfon having been once convicted fhall offend again he fhall be fined at the Difcretion of the Court, and imprifoned, paid.

If any of the King's Subjects, being fuch Artificers, shall go into any Country out of His Majefty's Dominions, to exercise or teach the faid Trades to Foreigners; and if any of the King's Subjects in any fuch Foreign Country, exercifing any of the faid Trades, fhall not return into this Realm within Six Months after Warning given by the Ambaffador, Minister or Conful of Great Britain, in the Country where fuch Artificers shall be, or by any Perlon authorifed by fuch Ambaffador, &c. or by one of the Secretaries of State, and from henceforth inhabit within this Realm ; fuch Perfons shall be incapable of taking any Legacy, or of being an Executor or Administrator, or of taking any Lands, &c. within this Kingdom, by Defcent, De-vife or Purchafe, and thall forfeit all Lands, Goods, &c. within this Kingdom, to His Majefty's Ufe, and shall be deemed Alien, and out of His Majefty's Protection.

Upon Complaint made, upon Oath, before any Juffice of Peace, that any Perfon is endeavour ing to feduce any fuch Artificer, or that any fuch Artificer hath contracted or is preparing to go out of His Majelty's Dominions, for the Purpofes aforefaid, fuch Juffice may fend his Warrant to bring the Perfon complained of before him, or before fome other Juftice; and if it shail appear by the Oath of one Witnefs, or by Confession, that he was guilty of any of the faid Offences, such Justice may bind him to appear at the next Affizes or Quarter Seffions : And, if fuch Perfon fhall refuse to give Secu-rity, the Juffice may commit him to Goal till the next Affizes or Quarter Seffions, and until he shall be delivered by due Courfe of Law. And if any fuch Artificer thall be convicted, upon Indictment, of any fuch Promife, Contract, or Preparation to go beyond the Seas, for the Purpole aforefaid, he shall give fuch Security to the King not to depart out of His Majefty's Dominions, as fuch Court shall think reasonable, and shall be imprisoned till Security given.

If any of the above Offences shall be committed in Scotland, the fame shall be profecuted in the Court of Jufficiary, or the Circuits there.

#### Statute 23 George II. Chap. 13.

IF any Perfon shall contract with, or endeavour to feduce any Artificer in Wool, Mohair, Cotton or Silk, or in Iron, Steel, Brafs, or other Metal, or any Clock-maker, Watch-maker, or any other Artificer in any other of the Manufactures of Great Britain or Ireland, to go out of this Kingdom or Ireland, into any Foreign Country not within the Dominions of the Crown of Great Britain, and thall be convicted, upon Indictment or Information, in the King's Bench at Weftminfter, or by Indictment at the Affizes or General Gaol Delivery for the County; &c. wherein fuch Offence shall be committed in England, or by Indictment in the Court of Jufficiary, or any of the Circuit Courts in Scotland, or by Indictment or Information in the King's Bench at Dublin, if fuch Offence be committed in Ireland; the Perion to convicted thall, for every Ar-tificer contracted with, or feduced, forfeit FIVE HUNDRED POUNDS, and fhall fuffer Imprifonment in the Common Goal of the County or Stewartry wherein fuch Offender shall be convicted,

imprifoned Twelve Months, and till the Fine be | for Twelve Calendar Months, and until Forfeiture be paid: And in Cafe of a fublequent Offence of the fame Kind, the Perfons fo again offending shall forfeit, for every Perfon contracted with or feduced, ONE THOUSAND POUNDS, and shall fuffer Imprisonment in the Common Gaol of the County or Stewartry wherein fuch Offender thall be convicted, for Two Years, and until fuch Forfeiture be paid.

If any Perfon in Great Britain or Ireland shall put on Board any Ship or Boat, not bound directly to fome Port in Great Britain or Ireland, or to fome other of the Dominions of the Crown of Great Brig tain, any fuch Tools or Utenfils as are commonly ufed in, or proper for the Preparing, Working up or Finishing of the Woollen or Silk Manufactures or any Part of such Tools, he shall, for every Offence, forfeit all fuch Tools, or Parts thereof, put on Board, and TWO HUNDRED POUNDS, to be recovered by Action of Debt, &c. in any Court of Record at Weftminfler, or in the Court of Seffion in Scotland, or at any of the Four Courts in Dublin respectively, wherein no Effoin, &c. shall be allowed.
