fo both We and Our People may humble Ourfelves before Almighty God, in order to obtain Pardon of Our Sins, and may, in the most devout and folemn Manner, fend up Our Prayers and Supplications to the Divine Majefty, for averting those heavy Judgments which Our manifold Sins and Provocations have most justly deferved, and imploring His Bleffing and Affiftance on Our Arms, and for reftoring and perpetuating Peace, Safety and Profperity to Us and Our Kingdoms: And We do ftriftly charge and command, that the faid Publick Fait be reverently and devoutly observed by all Our loving Subjects in Scotland, as they tender the Favour of Almighty God, and would avoid His Wrath and Indignation and upon Pain of fuch Punishment as We may juffly inflict on all fuch as contemn and neglect the Performance of fo religious and necessary a Duty : Our Will is therefore, and We charge, that this Our Proclamation feen, ye forthwith pais to the Market Crofs of Edinburgh, and all other Places needful, and there, in Our Name and Authority, make Publication hereof, that none pretend Ignorance : And Our Will and Pleafure is, That Our Solicitor do caufe printed Copies hereof to be fent to the Sheriffs of the feveral Shires, Stewarts of Stewartries and Bailiffs of Regalities, and their Clerks, whom We ordain to fee the fame published: And We appoint them to fend Copies hereof to the feveral Parish Churches within their Bounds, that upon the Lord's Day immediately preceding the Day above mentioned the fame may be published and read from the the Pulpits immediately after Divine Service.

A PROCLAMATION.

GEORGE R.

HEREAS on the Night of the First of this instant Month of February, fome Perfon unknown, in Company with a few other Perfons, to the Number of Twelve or thereabouts, in a Part of Covent Garden, opposite Southampton Street, in Our City of Westminster, threw a Stone, Brick, or other hard Substance, which struck with great Violence one of Our Servants, then standing behind Our Carriage, in which We, together with Our Royal Confort, were then returning from the Theatre in Drury Lane: And whereas afterwards on the fame Night, whild We were for returning, fome Perfon anknown threw with great Violence into Our faid Garriage a very sharp-edged and dangerous Flint

Stone, as Our faid Carriage was paffing along Pall Mall, in Our faid City of Weftminster, and opposite to John Street, which Stone broke one of the Glaffes of Our faid Carriage, and afterwards fell in Our faid Carriage; and the Acts aforefaid were done in Violation of the Public Peace, and to the actual Danger of the Royal Perfons of Us and Our Royal Confort, and are highly criminal and traiterous: We therefore, with the Advice of Our Privy Council, do hereby enjoin all Magistrates, and all other Our loving Subjects, to use their utmost Endeavours to difcover and caufe to be apprehended the Perfons concerned in fuch traiterous Outrages, in order that they may be dealt with according to Law. And We hereby promise, that any Person or Persons, concerned in the faid traiterous Outrages, other than fuch Perfon or Perfons as actually committed the faid Acts of Violence, or either of them, by which the Royal Perfons of Us and Our Royal Confort were immediately endangered, who fhall give Information, fo that any other or others of the Perfons concerned therein, or offending as aforefaid, may be apprehended and brought to Juffice, fhall receive a Reward of ONE THOUSAND POUNDS. to be paid on Conviction of every fuch Offender ; which faid Sum of ONE THOUSAND POUNDS the Lords Commiffioners of Our Treafury are hereby required and directed to pay accordingly : And We do further promife, that any Perfon or Perfons concerned in fuch traiterous Outrages as aforefaid, other than fuch as actually committed the faid Acts of Violence, or either of them, who fhall give Information, fo as that any other or others of the Perfons concerned therein, or offending as aforefaid, fhall be apprehended and brought to Juffice, shall, upon Conviction of fuch Offender or Offenders, receive Our most gracious Pardon.
