A'T the Court at St. James's, the 6th of May, 1796,

PRESENT,

The KING's Most Excellent Majesty in Council. THEREAS the Time limited by His Majefty's Order in Council of the 4th of November last, prohibiting the transporting into any Parts out of this Kingdom any Pot-Ath or Pearl-Afh, (except as in the faid Order is mentioned) will expire upon the 7th Day of this inftant May : And whereas it is judged expedient that the faid Prohibition fhould be continued for fome Time longer; His Majefly doth therefore, with the Advice of His Privy Council, hereby order, require, prohibit and command, that no Perfon or Perfons whofoever do, at any Time, during the Space of Six Months from the faid 7th Day of this inftant May, export, or attempt to export, transport, carry or convey, or lade or lay on Board of any Ship, Veffel or Boat, in order to be exported, transported, carried or conveyed out of this Kingdom, any Pot-Ash or Pearl-Ash, without Leave or Permiffion being first had and obtained from His Majefty or His Privy Council, upon Pain of incurring the Forfeitures inflicted by an Act paffed in the Thirty-fourth Year of His Majefty's Reign, intituled, " An Act for indemnifying " all Perfons who have been concerned in advifing " or carrying into Execution an Order of the Lords " Commissioners of His Majefty's Treasury respect-" ing the Exportation of Pot-Afhes or Pearl Afhes ; " for preventing Suits in confequence of the fame ;

" portation or carrying Coaftwife of Pot-Aft es or " Pearl-Afhes, and for making further Provisions " relative thereto." But it is neverthelefs His Majefty's Pleafure, that nothing herein contained shall extend, or be confirued to extend, to prevent the Exportation of the faid Articles to Ireland, or to His Majefty's Iflands of Guernfey, Jerfey, Alderney, Sark or Man, or to His Majefty's Colonies or Plantations in America or the Weft Indies, or to Newfoundland, or to His Majefty's Forts and Settlements on the Coast of Africa, or to the Island of St. Helena, or to the British Settlements or Factories in the East Indies; provided that, upon the Exportation of the faid Articles to Ireland, or to His Majefty's Islands of Guernfey, Jerfey, Alderney, Sark or Man, or to His Majefly's Colonies and Plantations in America or the West Indies, or to the Island of Newfoundland, or to His Majelty's Forts and Settlements on the Coaft of Africa, or to the Ifland of St. Helena, or the British Settlements or Factories in the East Indies, the Exporters of the faid Articles do first make Oath of the true Destination of the fame to the Places for which they fhall be entered Outwards, before the Entry of the fame shall be made, and do give full and fufficient Security, by Bond, to the Satisfaction of the Commit fioners of His Majelty's Cultoms, to carry the faid Articles to the Places for which they are fo entered Outwards, and none other ; and fuch Bond fhall not be cancelled or delivered up until Proof be made,

" for authorizing His Majefly to prohibit the Ex-

to the Satisfaction of the faid Commiffioners, by the Production, within a Time to be fixed by the faid Commiffioners, and fpecified in the Bond, of a Certificate or Certificates, in fuch Form and Manner as fhall be directed by the faid Commiffioners, fhewing that the faid Articles have been duly landed at the Places for which they were entered Outwards.—And the Right Honorable the Lords Commiffioners of His Majefty's Treafury, the Commiffioners for executing the Office of Lord High Admiral of Great Britain, and the Lord Warden of the Cinque Ports, are to give the neceffary Directions herein, as to them may refpectively appertain.

The KING's Most Excellent Majesty in Council. WHEREAS by an Act paffed in this prefent Seffion of Parliament, intitled, "An Act " for indemnifying all Perfons who have been con-" cerned in advifing or carrying into Execution an " Order of His Majefty in Council refpecting the " Exportation of Rock Salt; for preventing Suits " in confequence of the fame; for authorizing His " Majefty to prohibit the Exportation or carrying " Coaftwife of Rock Salt; and for making further " Provisions relative thereto;" it is enacted, That His Majefty may, by Proclamation or Order in Council, when he shall fee Cause, and for such Time as shall be therein expressed, prohibit the exporting or carrying Coaftwife, or the attempting to export or carry Coaffwife, any Sort of Rock Salt whatfoever : And His Majefty, judging it neceffary to prohibit the Exportation of Rock Salt, doth therefore, by and with the Advice of His Privy Council, under the Authority of the faid Act, hereby order, require, prohibit and command, that no Perfon or Perfons whatfoever do at any Time, during the Space of Six Months from the Date of this Order in Council, export or attempt to export, transport, carry or convey, or load or lay on board of any Ship, Veffel or Boat, in order to be exported. transported, carried or conveyed out of any Port or Place in Great Britain, any Sort of Rock Salt whatfoever, without Leave or Permifion first being had and obtained from His Majefty or His Privy Council, upon Pain of incurring the Forfeitures inflicted by aforementioned Act : His Majefty, neverthelefs, by the Advice aforefaid, hath thought fit to order, that nothing herein contained shall prevent Rock Salt being carried Coaftwife under the ufual Rules, Re-

gulations and Reffrictions, nor the Exportation of the fame to Ireland, or to any other of His Majefty's Dominions, under the ufual Conditions and Regulations, and upon Security being given, by the Exporter and Two other Perfons, (of whom the Mafter of the Veffel (hall be one) by Bond, in fuch Penalty as shall be directed by the Commissioners of His Majefty's Cuftoms, that the faid Rock Salt shall be exported to fome Port or Place in His Majefty's Dominions, and none other; and that a Certificate shall be produced within Six Months from the Date of the Bond, if fuch Rock Salt shall be entered out for any Part of His Majefty's Dominions in Europe, and within Twelve Months if for any Part of His Majafty's Dominions in America or the Weft Indies, and within Eighteen Months if for any of the British Settlements or Factories in Afia or Africa, under the Hand of the Principal Officer of the Cuftoms at the Port or Place where fuch Rock Salt shall be fo landed ; and if there shall be no Officer of the Customs, then under the Hand of the Chief Magistrate of the Place, tettifying that the faid Rock Salt has been duly landed at the Port or Place for which the fame was entered out. And the Right Honourable the Lords Commissioners of His Majesty's Treasury, the Lords Commissioners of the Admiralty, and the Lord Warden of the Cinque Ports are to give the necefiary Directions herein as to them may refpectvely appertain. I have the Pleasure to acquaint you, for the Information of my Lords Commissioners of the Admiralty, that a French National Cutter, (L'Abeille) of Fourteen Guns and Seventy Men, is just brought in here, captured by His Majesty's Ship Dryad, Captain Pulling, on Monday last, the Lizard bearing North Half East, Sixteen or Seventeen Leagues, Uthant S.S. W. Thirteen Leagues; the other Ships of the Squadron then in Chace of a Corvette, which there was every Probability of their coming up with.

The Dryad had before taken a large Smuggling Cutter, laden with Spirits, and fent her to Piymouth.

Mr. Fairweather, one of the Mates of the Dryad who has Command of the Cutter L'Abeille, informs me, that the had only been out Three Days from Breft, and had not taken any Thing. She is Three Years old, coppered, and appears well found; and thall be fent by the earlieft Opportunity to Plymouth
