T the Court at St. James's, the 6th of May,

PRESENT,

The KING's Most Excellent Majesty in Council. THEREAS the 'Time limited by His Majesty's Order in Council of the 4th of November last, prohibiting the transporting into any Parts out of this Kingdom any Pot-Ash or Pearl Ash, (except as in the faid Order is mentioned) will expire upon the 7th Day of this instant May: And whereas it is judged expedient that the faid Prohibi tion should be continued for some Time longer; His Majesty doth therefore, with the Advice of His Privy Council, hereby order, require, prohibit and command, that no Person or Persons whosoever do, at any Time, during the Space of Six Months from the faid 7th Day of this inflant May, export, or attempt to export, transport, carry or convey, or lade or lay on Board of any Ship, Vessel or Boat, in order to be exported, transported, carried or conveyed our of this Kingdom, any Pot-Ash or Pearl-Ash, without Leave or Permission being first had and obtained from His Majesty or His Privy Council, upon Pain of incurring the Forfeitures inflicted by an Act passed in the Thirty-fourth Year of His Majefly's Reign, intituled, " An Act for indemnifying " all Persons who have been concerned in advising or carrying into Execution an Order of the Lords

- " ing the Exportation of Pot-Ashes or Pearl-Ashes; for preventing Suits in consequence of the same;
- · Commissioners of His Majesty's Treasury respect-

" for authorizing His Majesty to prohibit the Ex-" portation or carrying Coastwise of Pot-Ashes or

" Pearl-Ashes, and for making further Provisions

" relative thereto." But it is nevertheless His Majesty's Pleasure, that nothing herein contained shall extend, or be construed to extend, to prevent the Exportation of the faid Articles to Ireland, or to His Majesty's Hlands of Guernsey, Jersey, Alderney, Sark or Man, or to His Majesty's Colonies or Plantations in America or the West Indies, or to Newfoundland, or to His Majesty's Forts and Settlements on the Coast of Africa, or to the Island of St. Helena, or to the British Settlements or Factories in the East Indies; provided that, upon the Exportation of the faid Articles to Ireland, or to His Majesty's Islands of Guernsey, Jersey, Alderney, Sark or Man, or to His Majesty's Colonies and Plana tations in America or the West Indies, or to the Island of Newfoundland, or to His Majesty's Forts and Settlements on the Coast of Africa, or to the Island of St. Helena, or the British Settlements or Factories in the East Indies, the Exporters of the faid Articles do first make Oath of the true Destination of the same to the Places for which they shall be entered Outwards, before the Entry of the fame shall be made, and do give full and sufficient Security, by Bond, to the Satisfaction of the Commit fioners of His Majelty's Cultoms, to carry the faid Articles to the Places for which they are so entered Outwards, and none other; and fuch Bond shall not be cancelled or delivered up until Proof be made,
